**NOTICE OF OPPOSITION**

Opposers, U.S. News & World Report, L.P. and U.S. News & World Report, Inc. (collectively, "Opposer"), believe that they are being damaged and will be damaged, by the registration of Henry Madison Research Inc.'s U.S. & WORLD EARLY WARNING REPORT mark shown in Application Serial No. 87746253 and hereby oppose the same. As grounds for its opposition, Opposer alleges the following, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:

**Opposer and Its U.S. NEWS & WORLD REPORT Mark and Trade Name**

1. Opposer U.S. News & World Report, L.P. is a Delaware limited partnership, having a principal place of business at 120 Fifth Avenue, 7th Floor, New York, NY 10011.
2. Opposer U.S. News & World Report, Inc. is a Delaware corporation, having a principal place of business at 120 Fifth Avenue, 7th Floor, New York, NY 10011.

3. Opposer has offered news and information products and services under its U.S. NEWS & WORLD REPORT trademark since 1948 and under its U.S. NEWS & WORLD REPORT trade name since as early as 1985.

4. Opposer has offered news and information products and services under its WORLD REPORT trademark since 1945.

5. Opposer is a multi-platform publisher of websites, magazines, and books, including its [www.usnews.com](http://www.usnews.com) website, online publications including magazines, and print and e-book versions of its authoritative rankings of colleges, mutual funds, hospitals, and more.

6. The U.S. NEWS & WORLD REPORT trademark has for decades been one of the most well-known brands in the publishing and news fields.



7. Opposer's usnews.com website, launched in 1995, is and has for many years been a popular news site among U.S. consumers, allowing them to obtain news and information on various topics, including finance, and providing advice, analysis, and rankings, such as on the best stocks, mutual funds, and credit cards. Opposer's usnews.com website is visited by millions of unique visitors each month who access tens of millions of page views.

8. Opposer has spent many millions of dollars advertising and promoting its goods and services in the U.S. under its U.S. NEWS & WORLD REPORT mark, all of which prominently displays its U.S. NEWS & WORLD REPORT mark. Opposer and its U.S. NEWS & WORLD REPORT mark have also received extensive publicity throughout the U.S. in various print and online media for many years.

9. Opposer extensively uses social media to promote the U.S. NEWS & WORLD REPORT trademark and products and services. Opposer maintains pages on Facebook (<https://www.facebook.com/usnewsandworldreport/>), Twitter (<https://twitter.com/usnews>) and Google+ (<https://plus.google.com/+usnewsworldreport>) and collectively has more than 1.5 million followers. Opposer's social media posts across these platforms are widely viewed and shared.

10. As a result of the activities noted above, Opposer's U.S. NEWS & WORLD REPORT mark is a famous mark and has been a famous mark in the U.S. for decades.

11. In addition to its common law rights, Opposer owns the following U.S. trademark registrations:

(collectively, “Opposer’s Registrations”) (TSDR Printouts from the U.S. Patent and Trademark Office (“PTO”) database are attached as Exhibit A). The goods and services covered by Opposer’s Registrations and the goods and services described in Paragraphs 3-8 above are collectively referred to as “Opposer’s Goods and Services.”

12. Opposer’s Registrations are valid and subsisting and constitute prima facie evidence of the validity of the covered marks and registrations, and of Opposer’s ownership of and exclusive right to use the covered marks in commerce in connection with the services recited in the registration.

13. Opposer’s Registrations No. 847644, 4348713, 4348721, and 1521791 are incontestable and constitute conclusive evidence of Opposer’s exclusive rights to use the covered marks in connection with the goods and services recited in the registrations.

**Applicant and Its U.S. & WORLD EARLY WARNING REPORT Mark**

14. Applicant Henry Madison Research Inc. (“Applicant”), is a Nevada corporation with an address of 10000 N. 31st Avenue, Suite C102, Phoenix, AZ 85051.

15. Applicant is the listed owner of Application Serial No. 87746253 (“the Application”), filed on January 7, 2018 under Section 1(a), 15 U.S.C. § 1051(a), for the mark U.S. & WORLD EARLY WARNING REPORT (“Applicant’s U.S. & WORLD EARLY WARNING REPORT mark”) for “Newsletters in the field of financial news” in Class 16 (“Applicant’s Goods”). Applicant claims a first use date of August 1, 2004 in the Application.



16. The Application was published for opposition in the *Trademark Official Gazette* (TMOG) on April 3, 2018, and Opposer filed a timely extension of time to oppose on May 3, 2018.

**Likelihood of Confusion, 15 U.S.C. § 1052(d)**

17. Opposer repeats and realleges each and every allegation set forth in the above paragraphs.

18. Opposer has priority based on Opposer's Registrations, and based on Opposer's prior use of Opposer's U.S. NEWS & WORLD REPORT trade name and trademark and WORLD REPORT trademark in commerce for Opposer's Goods and Services before the filing date of the Application and any date of first use that can be established by Applicant.

19. Opposer's U.S. NEWS & WORLD REPORT mark was famous in the publishing and news fields before the filing date of the Application and any date of first use that can be established by Applicant.

20. Applicant's Goods are identical and/or closely related to Opposer's Goods and Services offered under Opposer's U.S. NEWS & WORLD REPORT mark and trade name and WORLD REPORT mark.

21. Applicant's U.S. & WORLD EARLY WARNING REPORT mark so closely resembles Opposer's prior used and registered U.S. NEWS & WORLD REPORT mark and WORLD REPORT mark and prior used U.S. NEWS & WORLD REPORT trade name, as to be likely when used and registered in connection with Applicant's Goods, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. § 1052(d).

WHEREFORE, Opposer believes that it is being damaged and will be damaged by the registration of the mark shown in Application Serial No. 87746253, and respectfully requests that the opposition be sustained, and that registration to Applicant be refused.
