NOTICE OF OPPOSITION

Opposer, Wolf Appliance, Inc. (“Wolf”), a Wisconsin corporation, having a business address at 2866 Bud’s Drive, Fitchburg, Wisconsin, believes that it will be damaged by, and hereby opposes, registration of the mark WOLFLY (the “WOLFLY Mark”) that is the subject of Application Serial No. 87/746,313 (the “Application”) published in the *Official Gazette* on May 29, 2018, subject to Wolf’s timely request for an extension of time to oppose, which expires on September 26, 2018, and requests that registration of the Application with respect to the goods specified herein be refused.

As grounds in support of this opposition, Opposer asserts as follows:

1. By the Application Ser. No. 87/746,313 herein opposed, Applicant seeks to register the WOLFLY Mark in Class 21 for the following goods:

Baking mats; Bottle openers, electric and non-electric; Brushes for washing up; Cake molds; Canister sets; Cleaning brushes for household

use; Coffee grinders, hand-operated; Containers for household or kitchen use; Cookie molds; Cookie jars; Egg cups; Gloves for household purposes; Ice cube molds; Mouse traps; Oven mitts; Rat traps; Washing brushes; Cup cake molds; Garlic presses; Plastic household gloves; Rubber household gloves; Tea canisters

The Application was filed on January 7, 2018, and is based on use in commerce with an alleged first-use date of November 1, 2017.

2. Opposer herein specifically opposes the following goods in Class 21:

Baking mats; Bottle openers, electric and non-electric; Brushes for washing up; Cake molds; Canister sets; Cleaning brushes for household use; Coffee grinders, hand-operated; Containers for household or kitchen use; Cookie molds; Cookie jars; Egg cups; Gloves for household purposes; Ice cube molds; Oven mitts; Washing brushes; Cup cake molds; Garlic presses; Plastic household gloves; Rubber household gloves; Tea canisters.

(the “Opposed Goods”).

3. Opposer owns Registration No. 2698313 for the mark WOLF for “Domestic gas and electric cooking appliances, namely, ranges, cooktops, wall oven, microwave ovens, ventilation hoods for ranges, barbeque grills, and warming ovens” in Class 11. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.

4. Opposer owns Registration No. 2716174 for the mark WOLF for “Servicing of domestic gas and electric cooking appliances” in Class 37. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.

5. Opposer owns Registration No. 3578568 for the mark WOLF & Design (the “WOLF Logo”) for “Domestic gas and electric cooking appliances, namely, ranges, cooktops, wall ovens, microwave ovens, ventilation hoods for ranges, barbeque grills and warming ovens”

in Class 11 and “Servicing, repair and maintenance of domestic gas and electric cooking appliances” in Class 37. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.

6. Opposer owns Registration No. 3655912 for the mark WOLF GOURMET for “Knives, namely, chef, kitchen, paring, bread, knife sharpeners” in Class 8. This registration is valid, subsisting, unrevoked, uncancelled, and incontestable.

7. Opposer owns Registration No. 5054848 for the mark WOLF GOURMET for “Domestic electric kitchen machines, namely, blenders” in Class 7, “Domestic electric kitchen machines, namely, toasters and toaster ovens” in Class 11, and “Cookware, namely, pots, pans; knife blocks” in Class 21. This registration is valid, subsisting, unrevoked, and uncancelled.

8. Opposer owns US App. No. 87/193,242 for the mark WOLF GOURMET for “Domestic electric kitchen machines, namely, food processors and mixers” in Class 7, “Knives, namely, butcher, cheese, steak, boning, fillet, carving, utility and santoku knives; kitchen shears; hand-operated vegetable shredders; hand-operated slicers” in Class 8, “Timers; measuring spoons” in Class 9, “Domestic electric kitchen machines, namely, coffee makers, espresso machines, rice cookers, automatic bread makers, rotisseries, slow cookers, multicookers, griddles, tea kettles and countertop ovens; domestic barbecue grills with and without covers, domestic gas grills with and without covers; domestic broilers and broiling pans” in Class 11, and “Kitchen accessories, namely, chopping blocks; cooking utensils, namely, spatulas, slotted spoons, strainers, grills, grill covers, graters, funnels, serving tongs, wire baskets, cookie cutters, sieves, sifters, serving spoons, mixing spoons; barbecue utensils, namely, forks, tongs and turners; grilling utensils, namely, forks, tongs and turners; cookware, namely, bakestones, roasting pans, cookie sheets, cake pans, steamers, griddles, skewers, double boilers, Dutch ovens,

non-electric pressure cookers, woks, muffin tins; dinnerware, namely, earthenware for use as dinnerware” in Class 21.

9. Opposer, including via its authorized agents, began using the mark WOLF at least as early as January 2001 in connection with gas and electric cooking appliances, including ranges, cooktops, wall ovens, microwaves, warming ovens, barbeque grills, and ventilation hoods, and the servicing of these products.

10. Opposer, including via its authorized agents, began using the WOLF Logo at least as early as February 2001 in connection with gas and electrical cooking appliances, including ranges, cooktops, wall ovens, microwaves, warming ovens, grills, and ventilation hoods, and the servicing, repair, and maintenance of these products.

11. Opposer, including via its authorized agents, began using the mark WOLF GOURMET at least as early as May 2009 in connection with knives, knife sharpeners, and kitchen accessories.

12. Opposer, including via its authorized agents, began using the mark WOLF GOURMET at least as early as February 2015 in connection with domestic electric kitchen machines, namely, blenders, toasters, and toaster ovens, and cookware, namely, pots, pans, and knife blocks.

13. Opposer’s WOLF and WOLF GOURMET word marks and WOLF Logo (collectively referred to herein as the “WOLF Marks”) are of significant value to Opposer, including as an identification of source in connection with the sale and offering of Opposer’s products and services. The WOLF Marks registrations and pending application are attached hereto as **Exhibit A**.

14. Opposer, prior to any filing date or date of first use upon which Applicant can rely, applied for, adopted, and used its WOLF Marks in connection with Opposer's products and services.

15. Opposer's WOLF Marks for Opposer's products and services and the WOLFLY Mark sought to be registered by Applicant for the Opposed Goods all prominently feature the term WOLF and are highly similar in sound, spelling, connotation, appearance, and commercial impression.

16. The Opposed Goods are overlapping, complementary, similar or closely related to, or are within the natural zone of expansion of, Opposer's products and services provided under the WOLF Marks. Opposer, under its WOLF Marks, offers and sells domestic gas and electric cooking appliances, including "ranges," "cooktops," "wall ovens," "microwave ovens," "warming ovens," "blenders," "toasters," and "toaster ovens," and offers servicing, repair, and maintenance services in connection with the above products. In addition, Opposer, under its WOLF Marks, offers and sells other cookware and related kitchen and cooking accessories, including cooking "pots" and "pans," "knife blocks," and chef, pairing, and bread knives. Opposer also holds a prior-filed application for the mark WOLF GOURMET covering other related kitchen and cooking accessories, such as "cookie sheets," "cake pans," "muffin tins," "cookie cutters," "mixing spoons," etc. Applicant, under its WOLFLY Mark, allegedly offers and sells "baking mats," "bottle openers, electric and non-electric," "brushes for washing up," "cake molds," "canister sets," "cleaning brushes for household use," "coffee grinders, hand-operated," "containers for household or kitchen use," "cookie molds," "cookie jars," "egg cups," "gloves for household purposes," "ice cube molds," "oven mitts," "washing brushes, "cup cake molds," "garlic presses," "plastic household gloves," "rubber household gloves," and "tea

canisters.” The Opposed Goods allegedly offered and sold under Applicant’s WOLFLY Mark are all products used in a kitchen in relation to food preparation or storage. These types of products are typically sold through the same or similar channels of trade to the same or similar class of consumers as the goods sold, or intended to be sold, under the WOLF Marks.

17. Applicant’s WOLFLY Mark so resembles Opposer’s WOLF Marks that, when applied to the Opposed Goods, it is likely to, or will, cause confusion, mistake, or deception within the meaning of Section 2(d) of the Trademark Act, all to the damage of the Opposer.

18. Through Opposer’s use of its WOLF Marks for Opposer’s products and services, purchasers and prospective purchasers of such products and services, and/or similar, related, overlapping, or complementary goods and services, associate such marks with a single source, namely, the Opposer.

19. Purchasers and prospective purchasers are likely to be misled into believing, contrary to fact, that the Opposed Goods sold or provided under the mark opposed herein emanate from, are connected, associated, or affiliated with, or are in some way approved or sponsored by, Opposer, all to Opposer’s irreparable damage, including through impairment of its goodwill, as symbolized by Opposer’s WOLF Marks.

20. For at least the above reasons, registration of Application Serial No. 87/746,313 for the Opposed Goods is opposed on the ground that Applicant’s proposed WOLFLY Mark is likely to cause confusion, to cause mistake, or to deceive under Section 2(d) of the Trademark Act, and under state statutory and common law.

WHEREFORE, Opposer requests that this opposition be sustained and the subject Application Serial No. 87/746,313 to register the WOLFLY Mark for the Opposed Goods be refused registration.
