Pursuant to TBMP § 514.02, Argento SC By Sicura Inc. ("Applicant"), with the consent of Voyetra Turtle Beach, Inc. ("Opposer"), hereby amends the identification of goods recited in Ser. No. 87/800,806 in Class 9 to add the bold language as follows:

Class 9: Protective covers and cases for smartphones; Protective covers and cases for portable music players; Protective covers and cases for tablet computers; Ear buds; Wireless Ear buds; Ear phones; Headphones; Armbands, holders, clips and carrying cases specially adapted for personal electronic devices, namely, smartphones, portable music players and tablet computers; Audio speakers; Wireless indoor and outdoor speakers; Neon signs, all of the foregoing goods expressly excluding gaming products.

Because the amendment narrows the identification of goods, it should be accepted.

On the condition that the above amendment is entered, and pursuant to 37 C.F.R. § 2.114(c) and TBMP § 601.02, Opposer and Applicant consent and stipulate to the dismissal of the notice of opposition.


