Opposer, Suyen Corporation, a corporation organized under the laws of the Philippines, located and doing business at BENCH TOWER, 30th Street Corner Rizal Drive, Bonifacio Global City Taguig Philippines ("Opposer"), believes that it will be damaged by registration of the mark shown in United States Trademark Application Serial Number 87456023 ("the Opposed Application"), and hereby opposes same. The Opposed Application was filed on May 18, 2017, and was published for

opposition in the Official Gazette on April 3, 2018. On April 26, 2018, Opposer filed a “First 30 Day Request for Extension of Time to Oppose”, ESTTA Tracking number ESTTA892855, against the CKL BENCH Application in the Trademark Trial and Appeal Board (“TTAB”); on May 30, 2018, a “60 Day Request for Extension of Time to Oppose”, ESTTA Tracking number ESTTA899896, was granted by the TTAB; and, on July 27, 2018, an additional “60 Day Request for Extension of Time to Oppose”, ESTTA Tracking number ESTTA912209, was granted by the TTAB.

The Opposed Application is Application No. 87456023: BENCH for Class 016: “Paper; cardboard; printed publications and printed matter, namely, printed certificates, booklets, coupons, lectures, leaflets, paper signs, manuals, curricula, newsletters, informational cards and brochures in the fields of art, music and artistic performances, entertainment, fashion, sports, culture, general human interest, film production, languages, science and technology, law; Inking Ribbons for computer printers; bookbinding materials; books in the field of art, music and artistic performances, entertainment, fashion, sports, culture, general human interest, film production, languages, science and technology, law; adhesives for stationery or household purposes; artists' paint brushes; music sheets; printed music scores on sheets; periodical magazines in the field of art, music and artistic performances, entertainment, fashion, sports, culture, general human interest, film production, languages, science and technology, law; photographs; stationery and educational supplies, namely, blank note books and school supply kits containing various combinations of selected school supplies, namely, writing instruments, pens, pencils, mechanical pencils, erasers, markers, crayons, highlighter pens, folders, notebooks,

paper, protractors, paper clips, pencil sharpeners, writing grips, glue for stationery or household use and book marks; typewriters; printed instructional and teaching material, except apparatus, namely, in the field of art, music and artistic performances, entertainment, fashion, sports, culture, general human interest, film production, languages, science and technology, law; plastic materials, namely, bags, bubble packs and films for packaging; printing blocks”; for Class 026: “Lace; Embroidery; ribbons; braids; buttons; hooks and eyes; pins, namely, sewing pins, hat pins, curling pins, safety pins, bobby pins, marking pins, ornamental novelty pins; needles; artificial flowers”; and for Class 038: “Telecommunication services, namely, telecommunication access services, digital network telecommunications services, transmission of webcasts and podcasts, providing electronic message alerts via the internet, personal communication services and, providing multiple-user access to a global computer network, transmission of voice, data, graphics, images, audio and video by means of telecommunications networks, wireless communication networks, and the Internet; communication services for the electronic transmission of voices; electronic transmission of data; electronic transmission of images, photographs, graphic images and illustrations over a global computer network; electronic transmission of data, audio, video and multimedia files; simulcasting broadcast television over global communication networks, the Internet and wireless networks; provision of telecommunication access to video and audio content provided via an online video-on-demand service; satellite communication services; telecommunications gateway services”. The Applicant in the Opposed Application is identified as CKL Holdings N.V., Leeuwenstraat 4, Antwerpen BELGIUM 2000

("Applicant").

As grounds for its Opposition, it is alleged:

1. Opposer is the owner of a family of trademarks, that prominently include the word BENCH, including BENCH, BENCH BODY, BLU BENCH, HERBENCH HB and KINDERBENCH, which are used and registered in the United States, and in multiple countries throughout the world, for retail clothing services, clothing, bags, perfume and accessories, as set forth further below (the "family of BENCH marks").

2. Opposer is the owner of United States Trademark Registration 2134561 for the mark BENCH for perfume, cologne, hair shampoo, soap, hair conditioner, skin lotion and face and body powder, which was filed on April 7, 1997, and registered on the Principal Register on February 3, 1998, with a renewal under Section 8 & 9 of the United States Trademark Act filed on February 22, 2017. This registration is incontestable under Section 15 of the United States Trademark Act. Said registration was based upon an application filed in the United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

3. Opposer is the owner of United States Trademark Registration 4437795 for the mark BENCH for "Leather goods, namely, wallets, bags and attache cases", which was filed on January 10, 2005, and registered on the Principal Register on November 26, 2013. Said registration was based upon an application filed in the

United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

4. Opposer is the owner of United States Trademark Registration No. 4405020, for the mark BENCH for "Clothing, namely, jackets, coats, outerwear, namely, sweaters and cardigans, capes, pants, shirts, skirts, dresses, t-shirts, sweaters, vests, shorts, sport shirts, blouses, neckwear, belts, socks, underwear, lingerie, pajamas, robes, gloves, swimwear, sweatpants, sweatshirts and wristbands; Footwear, namely, shoes, boots and sandals; Headwear, namely, scarves, hats, caps and headbands; Men's and ladies' shoes, sandals, slippers, boots and underwear, namely, men's and ladies' briefs, boxer shorts, sandos (tank tops), undershirts, socks, stockings, pajamas, lingerie, bathing suits, swimming trunks, bathrobes, caps, vests, jumpers, jumpsuit, athletic suits, sweaters, cardigans, neckties, suspenders" and "Athletic Supporters", which was filed on January 10, 2005, and registered on the Principal Register on September 24, 2013. Said registration was based upon an application filed in the United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting, and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

5. Opposer is the owner of United States Trademark Registration No. 3906043, for the mark BENCH for "Retail store services featuring clothing, clothing

accessories, personal care products, leather goods, cosmetics, footwear, shoes, slippers, luggage, bags, souvenir items and gift sets; wholesale stores, ordering services and distributorship services in the fields of clothing, clothing accessories, personal care products, leather goods, cosmetics, footwear, shoes, slippers, luggage, bags, souvenir items and gift sets”, which was filed on January 10, 2005, and registered on the Principal Register on January 18, 2011, with a renewal under Section 8 & 15 of the United States Trademark Act filed on August 29, 2016. This registration is incontestable under Section 15 of the United States Trademark Act. Said registration was based upon an application filed in the United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting, and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

6. Opposer is the owner of United States Trademark Registration No. 3142731, for the mark BENCH BODY “Clothing, namely, jackets, coats, capes, pants, shirts, skirts, dresses, t-shirts, sweaters, vests, shorts, sport shirts, blouses, neckwear, belts, socks, underwear, lingerie, pajamas, robes, gloves, swimwear, sweatpants, sweatshirts and wristbands; Footwear, namely, shoes, boots and sandals; Headwear, namely, scarves, hats, caps and headbands”, which was filed on February 3, 2005, and registered on the Principal Register on September 12, 2006, with a renewal under Section 8 & 9 of the United States Trademark Act filed on September 19, 2016. This registration is incontestable under Section 15 of the United States Trademark Act. Said registration was based upon an application filed in the

United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting, and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

7. Opposer is the owner of United States Trademark Registration 3149074 for the mark BLU BENCH (and Design) for "Clothing articles, footwear and headgear, namely T-shirts, polo shirts, pants, shorts, underwear, jackets, sweaters, blazers, swimwear, socks, shoes, slippers, sandals, belts, stockings, pajamas, blouses, dresses, hats, and caps", which was filed on June 4, 2002, and registered on the Principal Register on September 26, 2006, with a renewal under Section 8 & 9 of the United States Trademark Act filed on September 20, 2016. This registration is incontestable under Section 15 of the United States Trademark Act. Said registration was based upon an application filed in the United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

8. Opposer is the owner of United States Trademark Registration 1978564, for the mark HERBENCH HB (and Design) for "Clothing, namely blouses, polo shirts, skirts, slacks and jeans, shorts, vests, T-shirts, undershirts, jackets, sweaters, pants, blazers, belts, hats and caps, sandals, shoes, socks, hosiery, scarfs, and underwear, including panties, brassieres and half-slips", which was filed on August 14, 1995, and registered on the Principal Register on June 4, 1996, with a

renewal under Section 8 & 9 of the United States Trademark Act filed on April 22, 2016. This registration is incontestable under Section 15 of the United States Trademark Act. Said registration was based upon an application filed in the United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

9. Opposer is the owner of United States Trademark Registration 3139660 for the mark KINDERBENCH (word only) for "Clothing, namely, jackets, coats, capes, pants, shirts, skirts, dresses, t-shirts, sweaters, vests, shorts, sport shirts, blouses, neckwear, belts, socks, underwear, pajamas, robes, gloves, swimwear, sweatpants, sweatshirts and wristbands; Footwear, namely, shoes, boots and sandals; Headwear, namely, scarves, hats, caps and headbands", which was filed on January 10, 2005, and registered on the Principal Register on September 5, 2006, with a renewal under Section 8 & 9 of the United States Trademark Act filed on September 19, 2016. This registration is incontestable under Section 15 of the United States Trademark Act. Said registration was based upon an application filed in the United States Patent and Trademark Office on a date prior to the date of filing of the Opposed Application. Said registered mark of Opposer is valid and subsisting and is prima facie evidence of Opposer's exclusive right to use said mark in commerce on the goods and/or services specified in said registration.

10. By virtue of its federal registrations identified above in paragraphs 2-9 and incorporated by reference herein (at times herein, collectively the "BENCH

Registrations”), Opposer has the prima facie exclusive right to use of its family of BENCH marks on the identified goods and services in the United States, and this exclusive right extends to marks which are so highly similar as to create a likelihood of confusion, mistake or deception.

11. Based upon information and belief, Applicant has no legitimate common law rights in its alleged mark BENCH (standard characters), Applicant having used and/or intended to use its alleged mark more recently than Opposer’s rights, regarding all of Opposer’s marks identified above in paragraphs 2-9 and incorporated by reference herein (at times herein, collectively “BENCH Marks”).

12. Based on information and belief, Applicant has no registration rights for the alleged mark BENCH (standard characters), with the United States Patent and Trademark Office. Applicant’s only application for said mark is the subject of the current opposition proceeding, the application, identified as Application No. 87456023, which was filed on May 18, 2017, as an intent to use trademark application, a date subsequent to all of Opposer’s federal registrations identified above in paragraphs 2-9 and incorporated by reference herein.

13. Based on information and belief, there is no issue as to priority, with first use by Opposer for all of its federal registrations identified above in paragraphs 2-9 and incorporated by reference herein, pre-dating Applicant’s intent to use Application filing date of May 18, 2017, with no alleged date of first use. Opposer first used and registered the marks in all of its federal registrations identified above in paragraphs 2-9 above, in commerce and interstate commerce on or before the filing date of Applicant’s intent to use application opposed herein.

14. Opposer has developed substantial goodwill and a large national and international business identified by its marks identified above in paragraphs 2-9 and incorporated by reference herein. Customers and others within the trade have come to recognize Opposer's marks identified above in paragraphs 2-9 and incorporated by reference herein as exclusively identifying Opposer, and Opposer has developed, and is continuing to develop, a valuable reputation for excellence in connection with the quality of its goods and services identified in and for the marks identified above in paragraphs 2-9 and incorporated by reference herein.

15. The alleged mark sought to be registered by Applicant, BENCH (standard characters), is identical to Opposer's "BENCH" marks identified above in paragraphs 2-9, incorporated by reference herein, and confusingly similar to Opposer's other marks identified above in paragraphs 6-9, incorporated by reference herein, and so resembles Opposer's BENCH Marks as to be likely, when used in connection with the goods identified in the Opposed Application, to cause confusion, to cause mistake, or to deceive the consuming public. The dominant portion of each of Opposer's BENCH Marks is BENCH and the Applicant's alleged mark is also "BENCH". In addition, Opposer's BENCH Marks are used on identical and closely related goods and/or services, which on information and belief, Opposer believes travel in the same channels of trade and are sold to the same class of customers as Applicant's goods and services are targeted to be advertised and sold.

16. Further, Opposer's BENCH Marks and Applicant's alleged BENCH mark, make highly similar commercial impressions as to the sight and sound, creating the likelihood that customers and others will be confused, misled, or deceived into the

mistaken belief that Applicant's goods and services bearing the alleged mark emanate from, or are somehow associated with Opposer. Once again, the dominant portion of each of Opposer's BENCH Marks is BENCH, and the Applicant's alleged mark is BENCH, and as a result, both Opposer's and Applicant's marks in all cases are either identical or nearly identical visually, with either an identical or near identical sound in pronunciation. The resulting confusion, mistake or deception will be to the detriment of Opposer and will cause substantial damage and injury.

17. Opposer has no control over the nature and quality of Applicant's goods and services, and thus, faces the substantial risk that the value, goodwill, and reputation associated with Opposer's BENCH Marks will be tarnished, which will cause significant damage and injury.

18. Approval of Applicant's Application for registration, and Applicant's use of the alleged mark would further constitute a false designation of origin and a false and misleading representation of fact likely to cause confusion, mistake, or deception as to the affiliation, connection, or association of the parties, or as to the origin, sponsorship, or approval of Applicant's goods by Opposer. See 15 U.S.C. § 1125(a).

19. True and correct print outs as of September 26, 2018, from the United States Trademark Office TARR system of Opposer's federal registrations set forth above in paragraphs 2-9 are attached hereto and incorporated by reference herein.


