NOTICE OF OPPOSITION

Constantine Kalaris, an individual and a citizen of the United States, with a business address of 7113 Alexander Drive, Highland, Maryland 20777 (“Kalaris” or “Opposer”), files this Notice of Opposition against the application for registration filed by First Pour, LLC dba Brew Worthy (“Respondent” or “Applicant”) for the mark BREW WORTHY in Class 43 for “Restaurant services; self-service restaurant services; café services; bar services; snack bar services; coffee bar services; carry out restaurant services; catering services; restaurants featuring home delivery; café restaurants; cocktail lounges; preparation of food and beverages; services for providing food and drink” (the “Application”).

Opposer believes he will be damaged by the registration of the mark identified above, and hereby opposes that Application on the basis of a likelihood of confusion under the

provisions of Sections 2(d) of the Trademark Act of July 5, 1946, as amended (15 U.S.C. § 1051 *et seq.*). The grounds for this opposition are as follows:

1. Opposer is the owner of Constantine Wines, founded in 1986 to import and distribute wine, and Axios Napa Valley Wines, founded in 1999 to make and distribute wine.

2. Since at least as early as 2004, Opposer has been making and selling wine under the brand name WORTHY (the “WORTHY Mark”). The use of the WORTHY Mark by Opposer has been continuous and Opposer has never ceased use or otherwise abandoned his rights in the WORTHY Mark. Opposer is the owner of U.S. Registration No. 2,852,040 for the WORTHY Mark, which is incontestable

3. Opposer is also the owner of U.S. Registration No. 5,514,032 for the WORTHY Mark for use in connection with beer, which has been on continuous use by Opposer’s licensee on beer since at least as early as 2011.

4. True and correct copies of the registration certificates, as well as current printouts of the online status page of the U.S. Patent and Trademark Office’s showing the current status and title of Opposer’s registrations, are attached as Exhibit A.

5. As a result of Opposer’s long-standing and widespread use of the WORTHY Mark in interstate commerce, Opposer has developed strong rights in the WORTHY Mark and the public has come to identify the WORTHY Mark uniquely with Opposer. As a consequence, the WORTHY Mark has become a valuable asset of Opposer and a principal symbol of its goodwill.

6. Since long before Applicant’s January 17, 2018 filing date, Opposer has used the WORTHY Mark in interstate commerce for wine and beer.

7. Opposer's WORTHY Mark is symbolic of the extensive goodwill and consumer recognition built up by Opposer through substantial amounts of time and effort in advertising and promotion.

8. If Applicant is granted the registration herein opposed, it would thereby obtain a *prima facie* exclusive right to the use of "BREW WORTHY" for restaurant services and related services, a further source of damage to Opposer.

9. During prosecution of the Application for BREW WORTHY, Applicant agreed to a disclaimer of the generic term "brew" and thus the dominant portion of Applicant's mark is the single term "worthy."

10. The trademark proposed for registration by Applicant is likely to cause confusion in the marketplace as to the source of Applicant's services and the source of Opposer's wine and beer. The mark BREW WORTHY has a dominant term that is identical to opposer's registered mark WORTHY - and the services are related. Therefore, the respective marks are so closely related as to be likely to cause confusion or mistake or to deceive purchasers when Applicant enters the marketplace with a confusingly similar mark in which Opposer has priority.

11. It is not uncommon for breweries and wineries to offer restaurant services, not is it uncommon for restaurants to brew their own beer or have custom-labeled wine. Moreover, these goods and services are likely to be sold to the same consumers. As a result, Opposer's goods and Applicant's services are highly related. Applicant's use of the proposed mark is, therefore, likely to cause confusion or mistake or to deceive purchasers resulting in damage and detriment to Opposer and his reputation.

12. The use and registration by Applicant of the mark BREW WORTHY for restaurant services and related services will enable Applicant to utilize and trade on the goodwill established by Opposer in his WORTHY mark.

For the foregoing reasons, Opposer will be damaged by the registration of Applicant's BREW WORTHY mark shown in Application No. 87/758,644.

GROUND FOR OPPOSITION
Likelihood of Confusion

13. Opposer incorporates by reference paragraphs 1 through 12, inclusive, as if fully set forth here.

14. The BREW WORTHY mark is confusingly similar to Opposer's WORTHY mark in appearance.

15. The BREW WORTHY mark is confusingly similar to Opposer's WORTHY mark in sound.

16. The BREW WORTHY mark is confusingly similar to Opposer's WORTHY mark in meaning.

17. The services for which Applicant seeks registration under the BREW WORTHY mark are restaurant services and related services, which are confusingly similar to the goods sold by Opposer under the WORTHY mark.

18. The services identified in the application for the BREW WORTHY mark and the goods offered by Opposer under the WORTHY mark are likely to appeal to the same class of consumers.

19. Opposer began using its WORTHY mark in commerce in the United States fourteen years prior to Applicant's filing date.

20. Registration of Applicant's BREW WORTHY mark will injure Opposer because the BREW WORTHY mark, when used on or in connection with restaurant services and related services, is likely to cause confusion, or to cause mistake or to deceive. Accordingly, pursuant to Section 2(d) of the United States Trademark Act, as amended, 15, U.S.C. 1052(a), Applicants' mark should be refused registration.

WHEREFORE, Opposer prays that Applicants' Application Serial No. 87/758,644 be refused, that no registration be issued thereon to Applicant, and that this opposition be sustained in favor of Opposer Constantine Kalaris.

Opposer Constantine Kalaris hereby appoints Richard A. Nebb, Barbara L. Friedman, Michael E. Dergosits, and Todd A. Noah, of the law firm of Dergosits & Noah LLP, and members of the bar of the State of California, to act as attorneys for Opposer herein, with full power to prosecute said opposition, to transact all relevant business with the Patent and Trademark Office and in the United States Courts and to receive all official communications in connection with this opposition.
