NOTICE OF OPPOSITION

Reebok International Limited (“Opposer” or “Reebok”), a United Kingdom limited company, located at 11/12 Pall Mall, London, United Kingdom SW1Y5LU, believes that it will be damaged by registration of the mark AIR PUMP and Design (“Applicant’s Mark”) as shown in Application Serial No. 87/831,783 (“Applicant’s Application”), filed by Winner Shoes Co., Ltd. (“Applicant”), and Opposer having been granted an extension of time to oppose up to and including November 28, 2018, hereby opposes the same.

As grounds for opposition, it is alleged that:

1. Reebok is currently, and for many years has been, one of the world’s leading manufacturers of athletic footwear, apparel and sporting goods.

2. Since 1958, Reebok itself, and/or through its subsidiaries, affiliates, licensees and their predecessors or successors, has been engaged in the manufacture, distribution and sale in interstate commerce of men’s, women’s and children’s footwear, apparel and headwear, bags for general purpose and sports use, sporting goods and

accessories.

3. Since as early as 1989, Reebok has used THE PUMP as a trademark for footwear in interstate commerce.

4. Throughout the past several decades, Reebok has used THE PUMP as a trademark to market, promote and sell various types of footwear, including, among others, basketball shoes, tennis shoes, running shoes, training shoes and casual footwear.

5. Reebok's footwear marketed and sold under THE PUMP mark are well known, popular and have been the subject of significant advertising, promotional activities and unsolicited publicity.

6. THE PUMP footwear has been advertised in various nationally circulated publications, including, *Newsweek*, *Footwear News*, *USA Today*, *The Los Angeles Times*, *The New York Times*, *The Boston Globe*, *The Miami Herald*, *The Chicago Sun-Times*, *The Wall Street Journal*, in nationally televised commercials, on Reebok's website at reebok.com and websites of national retailers, and store point-of-sale displays.

7. THE PUMP trademark and footwear have received significant unsolicited publicity, industry awards and accolades, including being named as one of the "*Ten Most Important Sneakers of All Time*" by GQ.com.

8. THE PUMP footwear has been recognized and described as "iconic" in articles published in trade and media publications, including footwear and fashion websites and blogs, such as sneakhype.com, finishline.com and footlocker.com.

9. THE PUMP footwear has been endorsed by numerous famous professional athletes, including former professional basketball players, Shaquille O'Neal

and Alan Iverson, and more recently, mixed martial arts fighter Connor McGregor and professional football player J.J. Watt.

10. Reebok owns the following United States registrations for the trademarks THE PUMP and INSTA PUMP (attached hereto as the exhibits indicated below are printouts from the TSDR database of Reebok's registrations and made of record in this proceeding pursuant to 37 C.F.R. §2.122(d)(1));

11. Opposer's above-listed registrations are valid, subsisting and in full force and effect.

12. U.S. Trademark Registration Nos. 1,943,292 and 3,459,279 are incontestable under the provisions of 15 U.S.C. § 1065.

13. U.S. Trademark Registration Nos. 1,943,292 and 3,459,279 are conclusive evidence of Reebok's exclusive right to use THE PUMP mark and the INSTA PUMP mark in commerce on or in connection with the goods specified in said registrations.

14. U.S. Trademark Registration No. 4,844,988 is at least *prima facie* evidence of the validity of such registration, the ownership thereof by Reebok and its exclusive right to use THE PUMP mark in commerce on or in connection with the goods set forth in the registration.

15. Long prior to the filing date of Applicant's Application and, upon

information and belief, the earliest date that Applicant may rely upon in this proceeding, Reebok and/or its authorized licensees have continuously used, advertised and promoted a family of PUMP trademarks, including the registered THE PUMP and INSTA PUMP marks and unregistered trademarks used at common law, including, among others, PUMP SUPREME and PUMP PLUS (collectively the "PUMP Marks"), in interstate commerce, on or in connection with footwear, and, in addition, for at least THE PUMP mark, clothing, including, athletic socks and caps, sport wrist watches, gym bags and back packs, among other goods (collectively "Opposer's Goods").

16. The PUMP Marks are inherently distinctive.

17. The PUMP Marks have been and continue to be used on and in connection with footwear.

18. The PUMP Marks have been prominently displayed on and in connection with Reebok footwear offered for sale and sold in the United States since prior to the filing date of the Applicant's Application and/or, on information and belief, prior to any use of Applicant's Mark.

19. Reebok footwear bearing the PUMP Marks are sold throughout the United States through various retail outlets, including Reebok retail stores, sporting goods stores, department stores, specialty footwear stores, outlet stores, via mail order and via the internet.

20. Reebok footwear bearing its PUMP Marks have been advertised in various media, including the Reebok website and retail customers' websites, via e-commerce marketing, in print media, including, national magazines and local newspapers, and on retail store displays.

21. By its continuous and extensive use and promotion of the PUMP Marks, expenditures for advertising and promotional activities, sales and promotion of goods under the PUMP Marks and the excellence of its products, Reebok has acquired valid and enforceable rights and valuable good will in and to the PUMP Marks as trademarks for Opposer's Goods.

22. The PUMP Marks are well known to the consuming public and trade as identifying and distinguishing Reebok exclusively and uniquely as the source of products for which the trademarks are used.

23. Reebok acquired common law trademark rights in the PUMP Marks for Opposer's Goods, upon information and belief, long prior to any date that Applicant may rely upon in this proceeding.

24. Despite the long-standing prior rights of Reebok in its PUMP Marks, on December 6, 2016, Applicant filed Applicant's Application, Serial No. 87/831,783, which was filed based on intent-to-use and seeks to register the below-illustrated trademark for the goods identified as "clothing, namely, t-shirts, underwear, suits, dresses, gowns, skirts, pants, coats, mufflers as neck scarves, head scarves, hats, gloves, socks; shoes" in International Class 25 ("Applicant's Goods"):



25. Applicant's Goods include goods that are identical and/or closely related, to the goods for which Reebok has used and registered the PUMP Marks. Moreover, to the extent that Applicant's Goods and Opposer's goods do not already overlap, they are

within each other's zone of natural expansion.

26. The identification of goods in Applicant's Application is unrestricted as to trade channels.

27. The Opposer's Goods and the Applicant's Goods are presumed to be offered and sold to the same classes of purchasers through the same channels of trade.

28. In view of the similarities between the PUMP Marks and Applicant's Mark and the fact that Applicant's Goods are identical and/or closely related to Opposer's Goods, there is a likelihood that Applicant's Goods will be perceived as being sponsored by or affiliated with Reebok.

29. Applicant's Mark so resembles the PUMP Marks, as to be likely to cause confusion, or to cause mistake, or to deceive as to the affiliation, connection or association of Applicant with Reebok, or as to the source, origin or sponsorship of Applicant's Goods within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

30. The registration of Applicant's Mark will damage Opposer in the advertising and sale of its goods by causing a likelihood of confusion.

31. Based, *inter alia*, on the strength of THE PUMP mark, the duration and extent of use of THE PUMP mark in connection with Opposer's goods, the duration and extent of advertising, promotion and unsolicited publicity of THE PUMP mark, the geographical extent of the trading area in which THE PUMP mark has been used, the channels of the trade for the goods with which THE PUMP mark is used, the degree of public recognition of said mark, THE PUMP is a "famous" mark as that term is used in Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c).

32. THE PUMP mark became famous long before the filing date of Applicant's Application and the earliest date that Applicant may rely upon in this proceeding.

33. Applicant's Mark so resembles THE PUMP mark as to be likely, when used in connection with Applicant's Goods, to cause dilution of the distinctive quality of Opposer's THE PUMP mark within the meaning of Section 43(c) of the Lanham Act, 15 U.S.C. §1125(c), and thereby lessen the capacity of THE PUMP to identify and distinguish the goods of Reebok and cause dilution of the distinctive quality of THE PUMP mark.

34. The use and registration of Applicant's Mark will erode the association of THE PUMP mark with Reebok, lessen the capacity of THE PUMP to identify Reebok as the source of goods to customers and potential customers who would expect THE PUMP to identify genuine and authorized products of Reebok, blur the distinctive quality of THE PUMP mark and otherwise cause dilution of THE PUMP mark.

35. If Applicant is granted the registration herein opposed, Applicant would thereby obtain at least a *prima facie* exclusive right to the use of Applicant's Mark on or in connection with Applicant's Goods.

36. For the foregoing reasons, Reebok will be damaged by the registration of Applicant's Mark on the Principal Register.

37. Applicant is not entitled to registration of Applicant's Mark.

WHEREFORE, Opposer Reebok International Limited, by its attorneys, respectfully requests that its opposition be sustained, and that registration of U.S. Trademark Application Serial No. 87/831,783 be denied.
