NOTICE OF OPPOSITION

The Aldo Group Inc./Le Groupe Aldo Inc., a Canadian corporation having a business address at 2300 Émile Bélanger Saint-Laurent, Québec, Canada H4R3J4, (“Opposer”) believes that it will be damaged by the registration of the mark shown in Application Serial Number 87943801 – J’AIME ALDO for “Shoes” in Class 25 (“Applicant’s Mark”).

Application Serial Number 87943801 – J’AIME ALDO was filed on May 31, 2018 by Jazame Inc, a Texas corporation, with an address at 1467 Prudential Drive, Dallas, Texas 75235 (“Applicant”). Opposer hereby opposes the same pursuant to Section 13 of the Trademark Act of 1946 (15 U.S.C. §1063).

As grounds for opposition, it is alleged that:

1. Opposer is the owner of the following registrations and earlier-filed application:
 - *Incontestable* Reg. No. 2445364 – ALDO SHOES for “retail services in connection with shoes, namely, sandals, slippers, hiking boots, moccasins, athletic shoes, loafers, walking shoes, walking boots, purses, gloves, belts, briefcases, and shoe care products” in Class 35, filed November 22, 1995 and registered April 24, 2001.

- *Incontestable* Reg. No. 2826814 - ALDO (Stylized) – **ALDO** for “footwear care products, namely, shoe polish, leather and fabric shoe cleaners and protectors, aerosol and non-aerosol, suede shoe cleaners and protectors [, leather garment aerosol protectors]” in class 3, “men's, women's and children's footwear, namely, shoes, boots, loafers, walking shoes, running shoes, athletic shoes, sandals and slippers; [men's and women's clothing, namely, coats, jackets, suits, pants, slacks, sweaters, shirts and vests,] suspenders, scarves; [men's and women's sportswear, namely, sweat shirts, sweat pants, sweat jackets and sweat suits;] men's and women's rainwear, namely, coats, jackets, hats and umbrellas; skiwear, namely, [jackets, sweaters, tops, pants,] mitts, gloves, scarves, hats; [windwear, namely, jackets and windjackets; sleepwear and swimwear, namely, t-shirts, shorts, robes, women's dresses, skirts and] lingerie, socks, hats, pantyhose; [men's underclothing; men's and women's leather and suede apparel, namely, coats, jackets, skirts, pants,] belts, gloves [, men's and women's leather, cloth and thermal insoles]” in Class 25, “operation of a retail store and a department within a store featuring men's, women's and children's footwear, footwear accessories, footwear care products, clothing, leather apparel, fashion accessories, [luggage,] handbags and wallets” in Class 35, and other goods in Classes 9, 14, 18 and 26, filed June 29, 2000 and registered March 30, 2004.
- *Incontestable* Reg. No. 2826815 – ALDO ACCESSORIES (Stylized) – **ALDO accessories** for “retail store services in the field of men's, women's and children's footwear, footwear accessories, footwear care products, clothing, leather apparel, fashion accessories, luggage, handbags, wallets” in Class 35, filed June 29, 2000 and registered March 30, 2004.
- App. Ser. No. 86778402 – ALDOLINI for “children's footwear” in Class 25, filed October 5, 2015.

True and correct copies of the U.S. Patent and Trademark Office’s TSDR reports for the foregoing registrations and application, as well as copies of the registration certificates when available, are attached hereto as **Exhibit A**.

2. Since at least as early as January 10, 1988, Opposer has used the mark ALDO in commerce for the goods and services claimed in Opposer’s registrations and earlier-filed application, listed above. By virtue of its bona fide use in interstate commerce, and commerce with the United States, which was and is in a regular and recurring manner, Opposer has acquired

common law rights in the word mark ALDO (collectively with the registrations and earlier-filed application listed above, “Opposer’s Marks”)

COUNT I: LIKELIHOOD OF CONFUSION

3. By virtue of Opposer’s extensive sales and promotion for more than 30 years, Opposer’s Marks have become well-known for Opposer’s goods and services, and have acquired a high degree of distinctiveness indicating source in the Opposer.

4. On information and belief, Applicant has not used Applicant’s Mark in connection with any goods or services offered in the ordinary course of trade in the United States prior to January 10, 1988.

5. Applicant cannot claim a priority date in connection with the goods covered by Application Serial Number 87943801 earlier than January 10, 1988.

6. Opposer’s Marks and Applicant’s Mark are similar in appearance, sound and commercial impression in that they contain the identical term “ALDO.”

7. The goods and services for which Opposer has registered and uses Opposer’s Marks and the goods for which Applicant has applied to register Applicant’s Mark are identical or closely related.

8. The goods and services for which Opposer has registered and uses Opposer’s Marks and the goods for which Applicant has applied to register Applicant’s Mark are likely to be sold or distributed through the same or otherwise overlapping channels of trade.

9. Applicant’s Mark incorporates the French wording “J’AIME,” and Opposer is based in Montreal, Canada, where French is widely spoken. Many of Opposer’s consumers in the United States speak French or otherwise associate Opposer with its French-Canadian origins,

and as such are particularly apt to associate the French wording “J’AIME,” when coupled with “ALDO” as here, with Opposer.

10. The French wording “J’AIME” may be translated to English as “I love.” Opposer previously conducted a global campaign incorporating love-related imagery displayed in connection with Opposer’s ALDO mark. Samples of promotional materials from this campaign are attached hereto as **Exhibit B**.

11. On information and belief, Applicant's use and registration of Applicant’s Mark is likely to cause confusion, mistake or deception by having the public erroneously assume or believe that the goods emanate from Opposer, or that they are endorsed, licensed or sponsored by, or in some other way associated or connected with Opposer, in view of Opposer’s prior use and registration of Opposer’s Marks, all to Opposer’s irreparable damage.

COUNT II: DILUTION BY BLURRING

12. Opposer repeats and realleges each and every allegation set forth in ¶¶ 1-11 of this Notice of Opposition as though fully set forth herein.

13. Opposer is one of the world’s leading fashion retailers, with more than 3,000 points of sale around the globe and nearly 200 million customers visiting Opposer’s stores each year. Specializing in footwear and accessories, Opposer’s ALDO mark is its flagship brand.

14. Opposer has expended substantial time, effort, and money over a period of more than 30 years to provide the highest quality goods and services under Opposer’s ALDO mark and has extensively advertised and promoted its goods and services under Opposer’s ALDO mark. Consequently, Opposer has developed considerable and valuable goodwill in Opposer’s ALDO mark to the point that Opposer’s ALDO mark has become famous among the general public in the United States within the meaning of 15 U.S.C. § 1125(c).

15. Any use by Applicant of Applicant's Mark for the goods set forth in Application Serial Number 87943801, as well as the date of filing of such Application, did not occur until after Opposer's ALDO mark became famous.

16. The use and registration of Applicant's Mark for the goods set forth in Application Serial Number 87943801 is likely to blur and cause dilution of the distinctive quality of Opposer's ALDO mark, all to the damage of Opposer.

WHEREFORE, for the reasons set forth in ¶¶ 1-16, Opposer believes and asserts that it will be damaged by the registration of the mark in Application Serial Number 87943801 – J'AIME ALDO. Accordingly, Opposer prays that this opposition be sustained and that Applicant be refused registration of J'AIME ALDO for the goods set forth in Application Serial Number 87943801.
