APPLICANT'S MOTION TO SUSPEND PROCEEDING

Pursuant to 37 C.F.R. § 2.117(a) and TMBP § 510.02(a), Applicant Alibaba Group Holding Limited ("Alibaba"), through its undersigned attorneys, hereby moves to suspend the above-captioned proceeding in view of the earlier filed opposition between the same parties and involving related marks. For the reasons presented below, the Trademark Trial and Appeal Board (the "Board") should grant this motion and suspend the proceeding.

I. Background

On April 4, 2017, Alibaba filed a Notice of Opposition (No. 91233862) against Amer Group Inc.'s ("Amer") U.S. Application Serial No. 86/821,204 for the mark APAY in connection with Class 36 and 45 services (the "APAY Application") on the ground that registration of the APAY Application will create a likelihood of confusion, mistake and/or deception among consumers, within the meaning of § 2(d) of the Trademark Act, with Alibaba's U.S. Registration No. 3,761,346 for the mark ALIPAY in connection with Class 9, 35, 36, 38, 39 and 42 goods and services, U.S. Registration No. 4,036,742 for the mark

in connection with Class 35, 36, 38 and 42 services, U.S. Registration No. 5,071,223 for the mark ALIPAY in connection with Class 41 services and/or common law rights in and to the marks ALIPAY and (the "Alibaba Opposition"). A true and correct copy of the Notice of Opposition filed in the Alibaba Opposition is attached hereto as **Exhibit**A and incorporated herein by reference. The Alibaba Opposition is still pending before the Board. A true and correct copy of the docket in the Alibaba Opposition as of the date below is attached hereto as **Exhibit B** and incorporated herein by reference.

On December 12, 2018, Amer filed a Notice of Opposition against Alibaba's U.S. Application Serial No. 87/628,472 for the mark ALIPAY in connection with Class 9, 35, 36, 38, 39 and 42 goods and services in the above-captioned proceeding on the grounds of priority and likelihood of confusion and no bona fide intent to use the mark in commerce for identified goods or services (the "Amer Opposition"). Amer's priority and likelihood of confusion contentions are based on its alleged prior rights in the APAY mark as reflected in the APAY Application.

II. Argument

Pursuant to 37 C.F.R. § 2.117(a), "[w]henever it shall come to the attention of the Trademark Trial and Appeal Board that a party or parties to a pending case are engaged in a civil action or another Board proceeding which may have a bearing on the case, proceedings before the Board may be suspended until termination of the civil action or the other Board proceeding." See TBMP § 510.02(a) ("[T]he Board may also, in its discretion, suspend a proceeding pending the final determination of another Board proceeding in which the parties are involved..."); see also Cf. The Tamarkin Co. v. Seaway Food Town Inc., 34 USPQ2d 1587, 1592 (TTAB 1995) (suspended pending outcome of ex parte prosecution of opposer's application). "Unless there are unusual circumstances, the Board will suspend proceedings in the case before

it if the final determination of the other proceeding may have a bearing on the issues before the

Board." TBMP § 510.02(a).

Here, the final determination of the Alibaba Opposition will more than likely have a

bearing on the issues before the Board in this proceeding. First, the parties are exactly the same

in both the Alibaba Opposition and the Amer Opposition. Second, the marks at issue, i.e., the

marks ALIPAY and APAY, and the goods and/or services associated therewith, are

substantially, if not exactly, the same in both proceedings. Third, the issue of likelihood of

confusion is the same in both the Alibaba Opposition and the Amer Opposition. Thus, a decision

concerning the likelihood of confusion between the ALIPAY and APAY marks in the Alibaba

Opposition is certain to have some bearing on the issue of likelihood of confusion between the

same marks and similar goods and/or services in the subject proceeding. As such, the Board

should suspend the Amer Opposition pending the disposition of the earlier filed Alibaba

Opposition.

III. Conclusion

In light of the foregoing, Applicant respectfully requests that the Board suspend this

proceeding pending the final determination of the Alibaba Opposition. In the event that the

Board does not grant a suspension, Alibaba respectfully requests that it be allowed additional

time (thirty (30) days) to file an Answer or otherwise respond to the Notice of Opposition in this

proceeding.



NOTICE OF OPPOSITION

ALIBABA GROUP HOLDING LIMITED, a corporation organized under the laws of the Cayman Islands, with its principal place of business at One Capital Place, P.O. Box 847, Fourth Floor, George Town, Grand Cayman, Cayman Islands (hereinafter "Opposer"), believing it will be damaged by registration of the above-captioned application, hereby opposes registration of the mark APAY shown in Application Serial No. 86/821,204, filed November 16, 2015, under the Trademark Act of 1946, in the name of Amer Group Inc., a Delaware corporation with an address of record of One Blackfield Dr., Ste. 416, Tiburon, California 94920 (hereinafter "Applicant"), published for opposition in the *Official Gazette* of December 16, 2016.

The grounds of Opposition are as follows:

- 1. Opposer is the owner of U.S. Registration No. 3,761,346 (the "'346 Registration"), for the mark ALIPAY, for use in connection with, *inter alia*:
 - Software for processing electronic payments to and from others; authentication software for authenticating the identity of a payer; recorded computer programs for

processing electronic payments and/or authenticating the identity of a payer; recorded computer software for processing electronic payments and/or authenticating the identity of a payer; [computers;] computer peripherals; downloadable electronic publications in the nature of magazines, articles, brochures, leaflets and datasheets containing information or instructions in the field of electronic payments, [pre-recorded audio tapes, CD-ROMs, discs and video tapes in the field of electronic payments;] computer software for use in the search and retrieval of computerized information on hobbies, collectibles, auctions and products accessed from global information networks and network systems, in Class 9;

- Business advisory services relating to facilitating the transaction of business via local and global computer networks; providing computerized online ordering services featuring general consumer merchandise and industrial products; advertising services, namely, promoting the goods and services of others via local and global computer networks; international import and export agency services; rental of advertising space on communication media; direct marketing advertising services for others; market research and consulting services for others; online trading services in which sellers post products to be sold and purchases are made via the Internet and providing online business evaluation relating thereto; computer services, namely, providing an online computer database in the field of shopping, in Class 35;
- Clearing and reconciling financial transactions via a global computer network; online banking services and financial services, namely, credit card or/and debit card processing services, and transmission and processing of bills and payments thereof, conducted via a global computer network; electronic funds transfer services, in Class 36;

2. Opposer is the owner of U.S. Registration No. 4,036,742, for the mark ALIPAY

 - Software for processing electronic payments to and from others; authentication software for authenticating the identity of a payer; recorded computer programs for processing electronic payments and/or authenticating the identity of a payer; recorded computer software for processing electronic payments and/or authenticating the identity of a payer; [computers;] computer peripherals; downloadable electronic publications in the nature of magazines, articles, brochures, leaflets and datasheets containing information or instructions in the field of electronic payments, [pre-recorded audio tapes, CD-ROMs, discs and video tapes in the field of electronic payments;] computer software for use in the search and retrieval of computerized information on hobbies, collectibles, auctions and products accessed from global information networks and network systems, in Class 41.
- 4. Opposer claims common law rights in the ALIPAY and ALIPAY & Design Marks, as described above, for use with a wide variety of goods and services, including those listed in Paragraphs 1 through 3 above.

- 5. The marks set forth in the '346, '742, and the '223 Registrations shall be referred to herein collectively as the "Alibaba ALIPAY Marks." Copies of the Registration Certificates and Trademark Status & Document Retrieval ("TSDR") system records for the foregoing registrations are attached hereto as Exhibit A.
- 6. Through its '346, '742, and the '223 Registrations, Opposer is entitled to a first use date in conjunction with the Alibaba ALIPAY Marks in commerce in connection with at least the goods and services set forth in the '346, '742, and the '223 Registrations well before any date of use that could be claimed by Applicant. Opposer has developed significant goodwill in the Alibaba ALIPAY Marks.
- (the "Opposed Application"), pursuant to Trademark Act § 1(b), for the mark APAY, for use in connection with the services, Financial services, namely, administration of transactions involving funds drawn from securities, stocks, funds, equities, bonds, cash, or other types of financial investments in retirement plans using a credit or debit card over a global data network; Payment processing services, namely, credit card and debit card transaction processing services; Providing electronic processing of credit card transactions and electronic payments via a global computer network; providing payment processing services and payment verification services for mobile payments, contactless credit and debit card transactions, gift card transactions, loyalty reward card transactions, and bill payment transactions with retailers, merchants, and vendors via mobile devices; providing financial information by electronic means, namely, providing credit and debit card information; financial services, namely, processing and administration of mobile payments and contactless debit and credit card transactions, loyalty reward card transactions, and bill payment transactions with retailers, merchants, and vendors

via mobile devices, in Class 36, and Providing user authentication of electronic funds transfer in the nature of mobile payments, contactless credit and debit card transactions, gift card transactions, loyalty reward card transactions, and bill payment transactions with retailers, merchants, and vendors via mobile devices, in Class 45 ("the Opposed Mark").

- 8. Opposer has established prior rights in the Alibaba ALIPAY Marks in connection with at least the goods and services set forth within its aforementioned Registrations prior to any date upon which Applicant can rely for use of the mark set forth in the Opposed Application, through its ownership of the '346, '742, and the '223 Registrations, each with application filing dates well before any date upon which Applicant can rely for use of the mark set forth in the Opposed Application.
- 9. Opposer has expended significant revenue and resources in creating and marketing its payment software and hardware, its financial and payment processing services, including credit card processing services, retail services, retail support services, business advisory services, and a wide range of other goods and services, and, through these efforts, has established valuable consumer recognition and goodwill therein.
- 10. Applicant's proposed use and registration of the mark set forth in the Opposed Application will create a likelihood of confusion, mistake and/or deception among consumers, within the meaning of Trademark Act § 2(d), all to the detriment of Opposer.

WHEREFORE, Opposer believes that it has been damaged and will continue to be damaged by virtue of Applicant's attempted registration of Applicant's Trademark Application No. 86/821,204 and requests that said application be rejected, that no registration be issued thereon to Applicant, and that this Opposition be sustained in favor of Opposer.

Opposer has appointed Jeffrey L. Costellia and Jeffrey S. Molinoff, of the law firm of Nixon Peabody LLP, members of the Bar of the District of Colombia, to prosecute this opposition proceeding and to transact all business in and before the United States Patent and Trademark Office in connection herewith. 
