NOTICE OF OPPOSITION

In the matter of the trademark application filed by the Applicant, CHURCH & DWIGHT CO., INC., for the registration of the mark ODOR BLASTERS AND DESIGN covering a variety of personal household products and cleaning preparations in International Class 3 that include potentially commonly and widely used and available consumer household products, such as household cleaning preparations for an array of potential wide-ranging consumer uses and applications, laundry detergent or laundry additives, and stain removers, Application Serial No. 87/777,536, filed on January 31, 2018, and published in the Official Gazette of July 10, 2018;

Opposer BLISTEX INC., an Illinois corporation with a principal place of business at 1800 Swift Drive, Oak Brook, Illinois 60523, believes it will be damaged by the registration

of the mark shown in the application and hereby opposes the referenced application.

The grounds for the opposition are:

- 1. Continuously since long prior to January 31, 2018, the Applicant's earliest shown priority date for its application, being the filing date of the application, the Opposer has marketed, advertised and sold throughout the United States under the mark ODOR-EATERS an extensive range of skin and foot care preparations, including deodorant powders and sprays for skin and foot care and for deodorizing footwear, socks, hosiery and clothing, as well as other deodorizing or other odor or wetness absorbing products or personal care or cleaning products, including diverse consumer products, such as inserts or insoles for footwear.
- 2. Opposer's products sold under the above trademark **ODOR- EATERS** have been extensively promoted throughout the United
 States to the relevant trade and to the consuming public.
- 3. By reason of Opposer's aforesaid extensive promotion and sale of its products, Opposer's trademark **ODOR-EATERS** has acquired great recognition and renown, and the relevant trade and public have come to recognize the trademark **ODOR-EATERS** as signifying Opposer exclusively.

4. Opposer has duly registered the mark **ODOR-EATERS** in the United States Patent and Trademark Office and owns the following registrations:

- 5. All of the registrations referenced in paragraph No. 4 that show or include the mark **ODOR-EATERS** are valid subsisting registrations in full force and effect. Furthermore, Registration Nos. 1,036,051; 1,149,920; 1,587,346; 1,749,207; 3,047,631; 3,106,982; 3,106,983 and 4,104,312 have each achieved "incontestable" registration status, thereby constituting conclusive prima facie evidence of Opposer's exclusive right to use said marks in commerce.
- 6. Applicant's claimed trademark **ODOR BLASTERS AND DESIGN**, as proposed for use in connection with items used for a variety

of consumer household products and cleaning preparations, referenced herein and as set forth in the opposed application, is so similar to Opposer's trademark ODOR-EATERS, used for a wide range of personal care, household and cleaning products, including deodorizers and moisture absorbing products, as to be likely to create confusion, mistake or deception, all to the damage of Opposer, and to the damage of Opposer's rights in its trademark, which mark has been in use long prior to the filing of the Applicant's trademark application or any priority date that Applicant could assert in its underlying mark.

- 7. Products identified in Opposer's referenced registrations would include, overlap, encompass or would be within the ambit of items identified or described in the Applicant's application, and products identified or described in the Applicant's application are also related personal household products or deodorizing or cleaning or moisture absorbing products to those sold by the Opposer.
- 8. The goods "household cleaning preparations" identified in the Applicant's application are very broadly described and could include numerous products and be used for a multiplicity of possible uses.
- 9. Based upon information and belief, the goods identified in the Applicant's application for the trademark **ODOR BLASTERS**AND DESIGN and those products sold under the Opposer's mark could be sold to the same potential consumers or end-users.

- 10. Based upon information and belief, the goods identified in the Applicant's application for the trademark **ODOR BLASTERS**AND DESIGN and those products sold under the Opposer's mark could move through the same channels of distribution, or be sold on the internet, or be sold in the same stores or in stores selling competing items or selling Opposer's related personal care, household or cleaning products.
- offered and sold by Opposer, so consumers observing a confusingly similar mark on such items would believe that such similar or related household products would emanate from the same source. Consumers come to expect consumer products of the nature of those of the Applicant under the mark at issue and those of the Opposer under the Opposer's trademark ODOR-EATERS could emanate from the same source. Products sold by the Opposer and the Applicant or the products involved could be expected to be produced or be made available by the same entity, a factor which could heighten opportunities for confusion to occur when confusingly similar marks are used.
- 12. The Applicant filed the underlying application, on information and belief, with actual knowledge of the Opposer's mark ODOR-EATERS AND DESIGN.
- 13. The first word of both the Opposer's mark and the Applicant's mark is the same word "ODOR". Both opposer's mark and Applicant's mark are comprised of only two words with the

first word being the same in both marks and with the second word of Applicant's mark ending with the letters "TERS" which are the same in appearance, sound and meaning to the last four letters of the second word in Opposer's mark, which is the word "EATERS".

- 14. Applicant's mark is similar to Opposer's mark in sound.
- 15. Applicant's mark is similar to Opposer's mark in appearance.
- 16. Applicant's mark is similar to Opposer's mark in meaning.
- 17. Applicant's mark is similar to Opposer's mark in overall commercial impression.
- 18. Use by the Applicant of the trademark **ODOR BLASTERS AND DESIGN,** for which registration is sought in the application opposed herein, is without Opposer's consent or permission.
- 19. Applicant's registration of the trademark **ODOR BLASTERS AND DESIGN** will result in damage and in the diminishment in sales and the loss of the value of the Opposer's mark **ODOR-EATERS**.
- 20. Applicant's registration of the trademark **ODOR BLASTERS AND DESIGN** will result in damage, dilution, and in the diminishment in sales and the loss of the value of the Opposer's famous mark **ODOR-EATERS**.

WHEREFORE, Opposer believes it will be damaged by the registration of the claimed trademark in Application Serial

No. 87/777,536 and prays that this Opposition be sustained and that the Applicant's registration be denied for all of the goods covered by the application.
