NOTICE OF OPPOSITION

The Opposer, The Mentholatum Company (“TMC”), believing it will be damaged by Laura Giardullo’s (“Giardullo”) registration of the mark TRIOXY pursuant to Application No. 88/174,886 hereby opposes the registration of said mark in International Class 3. Hereinafter, TMC may be referred to as the “Opposer,” and Giardullo may be referred to as “Applicant.”

Background

1. The TRIOXY Mark that is the subject of Application No. 88/174,886 was published for opposition on April 9, 2019. Accordingly, the deadline for Opposer to file its Notice of Opposition is May 9, 2019. This Notice of Opposition is timely filed by that date.

The Parties

2. The Mentholatum Company is a Delaware corporation having a place of

business at 707 Sterling Drive, Orchard Park, New York, 14127 USA.

3. Laura Giardullo, on information and belief, is an individual having an address of 200 Marble Ave., Pleasantville, New York, 10570.

TMC's OXY Registrations

4. TMC is the owner, by assignment, of U.S. Trademark Registration No. 1,869,207 (the '207 registration) for OXY for acne medication in International Class 5. This mark was registered on December 27, 1994 and is valid, subsisting and incontestable. A printout from the Office's Trademark Status & Document Retrieval ("TSDR") database showing the current status and ownership of the '207 registration is attached as **Exhibit A** and is incorporated herein by reference.

5. TMC is the owner of U.S. Trademark Registration No. 3,514,158 (the '158 registration) for OXY for medicated or non-medicated soaps, facial scrubs and skin washes and pre-moistened or non-pre-moistened cosmetic wipes, facial creams, and skin moisturizers in International Class 3. This mark was registered on October 7, 2008 and is valid, subsisting and incontestable. A printout from the Office's TSDR database showing the current status and ownership of the '158 registration is attached as **Exhibit B** and is incorporated herein by reference.

6. TMC is the owner of U.S. Trademark Registration No. 3,532,521 (the '521 registration) for OXY for medicated scrubs, pre-moistened or non-pre-moistened medicated wipes, and medicated skin washes for the treatment or prevention of acne or problem skin conditions in International Class 5. This mark registered on November 11, 2008 and is valid, subsisting and incontestable. A printout from the Office's TSDR

database showing the current status and ownership of the '521 registration is attached as **Exhibit C** and is incorporated herein by reference.

7. TMC's aforementioned federally-registered marks (hereafter collectively the "OXY Marks") enjoy substantial public recognition and goodwill, and are recognized as designating TMC as a single source for the skin care preparations and related goods sold under those marks.

Giardullo's Application to Register

8. Giardullo filed U.S. Trademark Application No. 88/174,886 (the '886 application) on October 30, 2018 seeking to register the mark TRIOXY for "Non-medicated skin care preparations," in International Class 3. Applicant claims a first use date of February 1, 2018.

9. The '886 application also seeks to register the TRIOXY mark for the services "Providing non-surgical cosmetic facial treatments," in International Class 44. TMC is not opposing the mark in this class.

Grounds for Opposition

10. The goods listed in each of the aforementioned federal registrations for TMC's OXY Marks are similar or related to those listed in Giardullo's application to register the TRIOXY Mark in International Class 3. For example, TMC's goods and Giardullo's goods both include non-medicated skin care preparations.

11. The goods associated with each of the respective marks move or will move in similar or the same channels of trade and are expected to be sold to similar or the same consumers.

12. The TRIOXY Mark is similar in appearance, sound, and commercial

impression to the OXY Marks owned by TMC. In particular, the second syllable “OXY” of Applicant’s mark is phonetically and visually identical to TMC’s OXY Marks, which creates a confusingly similar impression.

13. TMC believes that it will be, or that it is likely to be, damaged should the TRIOXY Mark register, that mark being sufficiently similar to TMC’s registered OXY Marks in sound, appearance and commercial impression as to be likely to cause confusion or mistake, or to deceive, as to the source, origin and/or sponsorship of goods sold or distributed under the TRIOXY Mark.

14. Consumers and the public are likely to confuse at least the skin care preparations sold under Giardullo’s TRIOXY Mark with the medicated and non-medicated skin care and related products sold by TMC under its OXY Marks, and to erroneously believe that the former goods also come from, are affiliated with or endorsed by TMC. As a result, any perceived defects or poor quality of Applicant’s goods sold under the TRIOXY Mark are likely to be erroneously attributed to TMC, to the substantial detriment of TMC and of the goodwill that it has developed and enjoys in its OXY Marks.

Conclusion

15. For the foregoing reasons, the present opposition should be sustained, and the Applicant should be refused registration of the TRIOXY mark on all goods identified in Class 3 in the ‘886 application.
