OPPOSER'S MOTION FOR EXTENSION OF TRIAL CALENDAR

Opposer's motion is made for good cause. Opposer timely served its pretrial disclosures on February 28, 2020. Since that time, Opposer has begun to prepare the documents and testimony it intends to submit to the TTAB during Opposer's 30-day trial period. Those efforts, however, have been significantly hampered by the impact of the coronavirus. The offices of Opposer, its counsel in Denmark, and its counsel in the U.S. have all closed. While many are working from home, Opposer and its counsel no longer have full access to the information,

documents, and people needed to submit its case in chief by the current deadline of April 19, 2020.

Prior to filing, Opposer sought Applicant's consent to this motion. Applicant refused that request.
