Opposer, LT Overseas North America, Inc., a California corporation, located and doing business at 11130 Warland Drive, Cypress, California 90630 (“Opposer”) believes that it will be damaged by the registration of the ROYAL GUYANA mark shown in U.S. Trademark Application Serial No. 88/050900 (the “Application”), filed on July 24, 2018 by Steven Yassin, an individual with an address of 8519 Palo Alto St., Holliswood, New York 11423 (“Applicant”) and therefore opposes the same. A description of Applicant’s Application is as follows:

As grounds for opposition, it is alleged:

1. Since at least as early as 1989, long before Applicant filed his Application, Opposer has been and still is, using its ROYAL® mark in connection with flour, rice, grains, and other food items.

2. Opposer owns and relies upon United States Trademark Registration No. 4,203,136 (“136 Registration”) for the mark ROYAL® for “rice, flour; preparations made from cereals, namely, corn flour, whole grain oat, corn bran, rice;” in International Class 30, which registration issued on September 4, 2012 and is based on an application filed with the United States Patent and Trademark Office (“PTO”) on April 11, 2011. Opposer first used this mark, filed its application and obtained its registration well before Applicant filed the Application. True and correct copies of printouts obtained from the electronic database records (TSDR) of the PTO showing the current status and title of the ’136 Registration are attached hereto as Exhibit 1 and made of record.


3. Opposer owns and relies upon incontestable United States Trademark Registration No. 3,990,952 (“952 Registration”) for the mark ® for “rice” in International Class 30, which registration issued on July 5, 2011 and is based on an application filed with the PTO on March 30, 2010. Opposer first used this mark, filed its application and obtained its registration well before Applicant filed the Application. True and correct copies of printouts from the electronic database records (TSDR) of the PTO showing the current status and title of the ’952 Registration are attached hereto as Exhibit 2 and made of record.

4. Opposer owns and relies upon United States Trademark Registration No. 5,428,599 (“599 Registration”) for the mark ROYAL® for “regular and organic dried lentils and beans” in Class 29, which registration issued on March 20, 2018 and is based on an application filed with the PTO on September 27, 2012. Opposer first used this mark and filed its application well before Applicant filed the Application. True and correct copies of printouts from the

electronic database records (TSDR) of the PTO showing the current status and title of the '599 Registration are attached hereto as Exhibit 3 and made of record.


5. Opposer owns and relies upon incontestable United States Trademark



Registration No. 1,683,914 ("914 Registration") for the mark  ® for "rice" in International Class 30, which registration issued on April 21, 1992 and is based on an application filed with the PTO on May 2, 1991. Opposer and its predecessors-in-interest first used this mark, filed the application and obtained the registration long before Applicant filed the Application. True and correct copies of printouts from the electronic database records (TSDR) of the PTO showing the current status and title of the '914 Registration are attached hereto as Exhibit 4 and made of record.


6. Opposer owns and relies upon incontestable United States Trademark



Registration No. 1,982,351 ("351 Registration") for the mark  ® for "rice" in International Class 30, which registration issued on June 25, 1996 and is based on an application filed with the PTO on May 11, 1995. Opposer and its predecessors-in-interest first used this mark, filed the application and obtained the registration long before Applicant filed the Application. True and correct copies of printouts from the electronic database records (TSDR) of the PTO showing the current status and title of the '351 Registration are attached hereto as Exhibit 5 and made of record.

7. Opposer owns and relies upon incontestable United States Trademark



Registration No. 2,066,393 (“’393 Registration”) for the mark  ® for “rice” in International Class 30, which registration issued on June 3, 1997 and is based on an application filed with the PTO on October 25, 1995. Opposer and its predecessors-in-interest first used this mark, filed the application and obtained the registration long before Applicant filed the Application. True and correct copies of printouts from the electronic database records (TSDR) of the PTO showing the current status and title of the ’393 Registration are attached hereto as Exhibit 6 and made of record.

8. Opposer’s registrations identified in Paragraphs 3 and 5-7 are incontestable. As such, they constitute conclusive evidence of the validity of the registered marks and of the registrations of the marks, of Opposer’s ownership of the marks, and of Opposer’s exclusive right to use the registered marks in commerce as provided in Section 33 of the Lanham Act, 15 U.S.C. § 1115.

9. Opposer’s registrations identified in Paragraphs 2-7 are valid, subsisting, unrevoked, uncanceled, and not abandoned. As such, they constitute prima facie evidence of the validity of the registered marks and of the registrations thereof, and Opposer’s ownership of the marks shown therein. Said registrations also constitute notice to Applicant of Opposer’s claim of ownership of the marks shown therein, all as provided in Sections 7(b), 22 and 33(a) of the Trademark Act of 1946, as amended.

10. Since long before Applicant filed the Application, Opposer has been using its ROYAL marks in connection with rice, flour, and other food items. The use of the ROYAL marks set forth in Paragraphs 2-7 above (“Opposer’s ROYAL Marks”) has been valid and continuous and has not been abandoned.

11. Opposer's dates of first use of Opposer's ROYAL Marks and filing dates for the above registrations precede the filing date of the Application.

12. Opposer, through continuous and substantial use and promotion, has acquired significant goodwill and consumer recognition in Opposer's ROYAL Marks. Opposer also relies on its extensive common law rights in Opposer's ROYAL Marks throughout the United States as a basis for this Opposition proceeding.

13. Applicant seeks an unrestricted federal registration for the ROYAL GUYANA mark covering "Flour; Noodles; Sauces; Sugar" in International Class 30 as set forth in Applicant's Application. As such, if Applicant's Application matures to registration, such registration will constitute prima facie evidence of Applicant's exclusive right to use the registered mark in commerce or in connection with the identified goods throughout the United States with no limitation thereon.

14. Applicant's ROYAL GUYANA mark so resembles Opposer's ROYAL Marks as to be likely to cause confusion or to cause mistake or to deceive under Section 2(d) of the Trademark Act. In view of Opposer's prior statutory and common law trademark rights, Applicant is not entitled to registration of the Application pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

15. By reason of the foregoing, Opposer will be damaged by registration of U.S. Trademark Application Serial No. 88/050900 for the mark ROYAL GUYANA.

WHEREFORE, Opposer requests that U.S. Trademark Application Serial No. 88/050900 for the mark ROYAL GUYANA be rejected and stricken, that no registration be issued thereon to Applicant, and that this opposition be sustained in favor of Opposer.
