NOTICE OF OPPOSITION

Opposer Energy North Incorporated ("Opposer") believes that it will be damaged by registration of the mark shown in Application Serial No. 79/216868, and hereby opposes the same. As grounds for opposition, Opposer alleges as follows:

- Opposer, is a Massachusetts company with offices in Lawrence,
 Massachusetts, and the owner of U.S. Trademark Reg. No. 4859458 for the mark
 HAFFNER'S.
- 2. Upon information and belief, applicant, Haffner Energy Societe Par Actions Simplifiee ("Applicant") is a French company with offices in Vitry Le François, France.
- 3. On May 26, 2017, Applicant filed Application Serial No. 79/216868 (the "Opposed Application") to register the mark "HAFFNER ENERGY" on the Principal Register. The Opposed Application has been amended through prosecution to recite goods/services in classes:

IC 004. US 001 006 015. G & S: Biofuels; fuels; electrical energy; fuel gas; oil-gas, namely, compressed petroleum gas; solidified fuel gas

IC 007. US 013 019 021 023 031 034 035. G & S: Machines, namely, feeding apparatus for biomass boilers; machines, namely, scale collectors for biomass boilers; mechanical smoke condensing installations; high energy chargers being parts of gas production machines; steam condensers as parts of machines; steam/oil separators; heat exchangers being parts of machines; filters being parts of machines, motors and engines for filtering gases; electricity generators; mechanical smoke condensing installations; dust exhausting installations for cleaning purposes; suction machines for industrial use; pressure regulators being parts of machines; separators, namely, dust separators; blowing machines for the compression, exhaustion and transport of gases; superheaters in the nature of steam engine boilers; high energy chargers being parts of gas production machines

- 4. During prosecution of the Opposed Application, Applicant disclaimed the exclusive right to use "ENERGY" apart from the mark as shown.
- 5. Since 1925, long prior to Applicant's adoption of the term HAFFNER ENERGY, Opposer was engaged in commerce in the United States using its mark HAFFNER'S in the business of "automobile service station services; car washing; vehicle fueling services; vehicle service stations." Opposer has used its mark extensively, since at least as early as 1925, in association with "fuel delivery services" and aspects of commerce associated with fuel delivery and servicing of fuel burning and heating equipment. Opposer has used and advertised and promoted its services extensively.
- 6. Opposer's services using the HAFFNER'S Mark include uses in interstate commerce in association with and/or in relation to, among other things, fuels; fuel gas; oil-gas; and compressed petroleum gas; heating boilers and oil and gas burner services; burner maintenance and repair; maintenance and repair of combustion heating apparatus; maintenance and repair of heating equipment; heating equipment installation and repair; furnace installation and repair; cleaning and repair of boilers; energy auditing; consulting services and advice to reduce energy consumption; and technological consulting services in the field of energy production and consumption.
- 7. By reason of longstanding and extensive marketing, advertising and promotion of the services in connection with the HAFFNER'S Mark, and the high quality of those services, the HAFFNER'S Mark has developed extremely valuable goodwill, and has a reputation associated and identified with Opposer long before the Applicant can assert any claim in the Applicant's HAFFNER ENERGY mark.

- 8. Applicant's adoption and use of the Applicant's HAFFNER ENERGY mark has been without the consent or permission of the Opposer.
- 9. The services specified in the Applicant's application for the Applicant's HAFFNER ENERGY mark are similar to the services provided by Opposer under the HAFFNER'S Mark in current use.
- 10. On information and belief, the Applicant's use of the HAFFNER ENERGY mark in connection with the specified services are or will be promoted in the same channels of trade, to the same potential purchasers, and use the same advertising media and channels as those in connection with Opposer's HAFFNER'S Mark.

CLAIM FOR RELIEF Likelihood of Confusion

- 11. The mark shown in the Opposed Application so resembles Opposer's registered HAFFNER'S Mark as to be likely, when used on or in connection with the goods and services identified in the Opposed Application, to cause confusion, to cause mistake, or to deceive, and Applicant's HAFFNER ENERGY mark is thus unregistrable under § 2(d) of the United States Trademark Act, 15 U.S.C. § 1052(d).
- 12. Opposer will be damaged by registration of the mark shown in the Opposed Application because registration will give Applicant prima facie evidence of ownership of, and exclusive right to use in commerce, a mark that is confusingly similar to Opposer's registered HAFFNER'S Mark.
- 13. If the Applicant is granted registration of its HAFFNER ENERGY mark as shown in Application No. 79/216868, the Applicant will thereby obtain the right to use the HAFFNER

Appl. No. 79216868

ENERGY mark, and such registration of the HAFFNER ENERGY mark will damage Opposer's

goodwill and rights in its registered HAFFNER'S Mark causing further injury to Opposer.

14. Applicant's HAFFNER ENERGY mark is likely to cause confusion, mistake, or

deception that Applicant's services are those of Opposer or are otherwise endorsed, sponsored,

or approved by Opposer, resulting in damage to the Opposer.

PRAYER FOR RELIEF

WHEREFORE, Opposer prays that this Opposition be sustained and that registration of

the Opposed Application for the HAFFNER ENERGY mark as shown therein be refused.
