Opposer fails to state a claim upon which relief can be granted.

Second Affirmative Defense

There is no likelihood of confusion, mistake, or deception between opposer's marks and LSU's DaVinci Degree mark.

Third Affirmative Defense

Any and all acts alleged to have been committed by LSU were performed with lack of knowledge and lack of willful intent.

PRAYER FOR RELIEF

WHEREFORE, LSU respectfully requests this Court to enter judgment in its favor and against Intuitive Surgical, Inc. by granting the following relief:

1. Declaration that the DaVinci Degree mark does not create a likelihood of confusion.
2. Declaration that the DaVinci Degree mark does not create dilution.
3. Declaration that the DaVinci Degree mark does not create a false suggestion of a connection.
4. Declaration that the DaVinci Degree mark does not present a misrepresentation of source.
5. Attorney's Fees.
6. Any other relief the court deems appropriate.


