### NOTICE OF OPPOSITION

Opposer Retail Royalty Company, a Nevada corporation with an address at 101 Convention Center Drive, Las Vegas, Nevada 89109 ("Opposer"), believes that it will be damaged by the registration of the mark AERIOUS that is the subject of Application Serial No. 88309108, filed by AromaKnowledge, LLC ("Applicant").

As grounds for its Opposition, Opposer alleges the following, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:

#### **Opposer and Opposer's AERIOUS Mark**

1. Opposer, together with its affiliated companies, owns the well-known and highly respected lifestyle brand AERIE. Opposer is a leading retailer that operates retail stores and designs, markets, and sells a variety of products, including fragrances, essential oils, and other personal care products under various trademarks and services marks, including its AERIE trademark (the "AERIE Mark").

2. Since at least as early as 2007, Opposer has used the AERIE Mark extensively as a trademark to identify its personal care products, fragrances, and related retail store services, including

in Opposer's more than 140 standalone brick-and-mortar AERIE stores and on its website www.aerie.com.

3. Opposer has spent substantial sums of money promoting its goods and services offered in connection with the AERIE Mark and AERIE-formative marks (collectively, the "AERIE Marks"). Through extensive advertising, promotion, and use, Opposer's AERIE Marks have come to embody substantial goodwill associated with Opposer, and consumers immediately identify the AERIE Marks with Opposer.

4. In addition to the common law rights which Opposer has developed through extensive use of the AERIE Marks, Opposer owns the following valid and subsisting registrations for its AERIE Marks for goods and services closely related to the goods identified in Application Serial No. 88309108 (the "AERIE Registrations"):

Extracts of the current status and title of Opposer's above-listed registrations from the USPTO TESS and TSDR databases are attached as Exhibit A.

5. The AERIE Registrations are valid and in full force and effect, and thereby constitute prima facie evidence of Opposer's exclusive right to use the AERIE Marks in commerce in connection with the specified goods and services.

### Applicant and Applicant's Mark

6. Applicant, AromaKnowledge, LLC, is a New Jersey limited liability company with an address at 251 Franklin Turnpike, Allendale, New Jersey 07401.

7. On February 20, 2019, Applicant filed an application under § 1(b) of the Lanham Act based on Applicant's alleged intent to use the AERIOUS mark in U.S. commerce for "Candles, wax melts" in Class 4, which was assigned Serial No. 88309108 (the "Application").

#### Count One Likelihood of Confusion, 15 U.S.C. §1052(d)

8. Opposer repeats and realleges each and every allegation set forth in each of the preceding paragraphs.

9. Opposer has used in commerce, registered, and/or applied to register its AERIE Marks well before Applicant's February 20, 2019, filing date, and any date of first use that may be alleged by Applicant.

10. The parties' marks are visually, aurally, and conceptually similar.

11. The goods described in the Application are so closely related to the goods offered by Opposer under Opposer's AERIE Marks and identified in Opposer's AERIE Registrations. Upon information and believe, Applicant's goods may or will be offered to the same general class of customers to whom Opposer offers its goods and services under its AERIE Marks.

12. Applicant's AERIOUS mark is so similar to Opposer's prior used and/or registered AERIE Marks, and the goods covered by Opposer's AERIE Marks and AERIE Registrations and the Application are similar or related in such a way, that it is likely that a potential consumer would be confused or mistaken or deceived as to the source of the parties' respective goods. Such confusion would damage Opposer.

13. If Applicant is granted the registration herein opposed, it would thereby obtain a *prima facie* right to exclusive use of the AERIOUS mark, which would be a further source of damage to Opposer.

WHEREFORE, Opposer believes that it will be damaged by the registration of the mark shown in Application Serial No. 88309108, and respectfully requests that the opposition be sustained and that registration to Applicant be refused.
