#### **CONSOLIDATED NOTICE OF OPPOSITION**

Opposer Omegle.com, LLC ("Opposer" or "Omegle"), an Oregon limited liability company with an address of 4557 11th Avenue NE #131, Seattle, Washington 98105 and the senior user and owner of a U.S. registration for the OMEGLE mark, believes it will be damaged by registration of the OMETV mark shown in Application Serial No. 88/264,546 and Application Serial No. 88/264,565 in connection with services in, respectively, IC 038 and IC 045, filed by Applicant Bad Kitty's Dad, LDA ("Applicant"), and hereby opposes those applications.

As grounds for opposition, Opposer alleges as follows:

- 1. Opposer offers a free online chat website under its OMEGLE mark that randomly pairs users in one-on-one chat sessions via video or text.
- 2. Launched in March 2009, Opposer's OMEGLE chat service has become one of the most popular chatting websites for meeting, socializing and networking with random users online. From approximately 1.7 million unique visitors in April 2009 after it first launched its OMEGLE chat service, Opposer had more than 28 million unique visitors in May 2019.
- 3. Opposer began using its OMEGLE mark in commerce in March 2009 and, as a result of Opposer's considerable success and investment in its OMEGLE chat service, the OMEGLE mark has become uniquely associated with Omegle and its chat service among its users and others within the industry.
  - 4. Opposer owns a U.S. registration for its OMEGLE mark.
- 5. Opposer's Registration No. 3,997,588 for the OMEGLE mark was issued on July 19, 2011, for the following services in IC 038 based on a first use date of March 25, 2009: "Providing internet chatrooms". True and correct copies of printouts from the TSDR electronic

database records of the PTO showing the current status of the registration and the Certificate of Registration for Registration No. 3,997,588 are attached hereto as **Exhibit A**.

- 6. The registration for the OMEGLE mark, Registration No. 3,997,588, was initially issued to Leif C. K-Brooks on July 19, 2011. (*See Exhibit A.*) On August 27, 2015, Mr. K-Brooks assigned the OMEGLE mark and corresponding registration, along with all goodwill appurtenant thereto, to Opposer. Attached hereto as *Exhibit B* is a true and correct copy of the assignment agreement recorded with the PTO (reel/frame 5610/0951).
- 7. Opposer's Registration No. 3,997,588 for its OMEGLE mark is valid, subsisting, unrevoked, and uncancelled, and constitutes *prima facie* evidence of the validity of the registered mark and of the registration of the mark, of Omegle's ownership of the mark, and of Omegle's exclusive right to use the registered mark in commerce on or in connection with the goods or services specified in the registration, as provided in Section 33(a) of the Lanham Act, 15 U.S.C. § 1115(a). Opposer's Registration No. 3,997,588 further constitutes constructive use of the OMEGLE mark, conferring a right of priority nationwide in effect in connection with the services specified in the registration as of the filing date of the application, as provided in Section 7(c) of the Lanham Act, 15 U.S.C. § 1057(c).
- 8. Both of Applicant's applications for the OMETV mark were filed on January 16, 2019.
- 9. A true and correct copy of a printout from the TSDR electronic database records of the PTO of the application for Serial No. 88/264,546 is attached hereto as **Exhibit C**.
- 10. A true and correct copy of a printout from the TSDR electronic database records of the PTO of the application for Serial No. 88/264,565 is attached hereto as **Exhibit D**.

- 11. Applicant did not file its applications to register the OMETV mark until January 16, 2019, well after Opposer filed its application for its OMEGLE mark on December 23, 2010 and the registration of its OMEGLE mark on July 19, 2011. Additionally, although Applicant claims a first use date of September 9, 2015 in both applications, Opposer's use of its OMEGLE mark began some six years earlier in March 2009. Accordingly, Opposer's OMEGLE mark is first in time and there is no issue as to priority or seniority as between Opposer and Applicant.
- 12. At the time Applicant filed its applications to register the OMETV mark, Applicant also had prior knowledge, both actual and constructive, of Opposer and its OMEGLE mark. Not only is Opposer and its OMEGLE online chat service well known in the industry but Applicant specifically markets its competitive service as an "Omegle chat alternative" and otherwise references Opposer and its OMEGLE chat service in Applicant's marketing and promotional materials. (*See, e.g.*, **Exhibits C-D**.)
- 13. Additionally, Opposer's registration for its OMEGLE mark constitutes constructive notice of Opposer's claim of ownership of the mark under Section 22 of the Lanham Act, 15 U.S.C. § 1072.
- 14. Applicant's OMETV mark is highly similar to Opposer's OMEGLE mark and creates a similar overall commercial impression. Given the generic nature of the "TV" portion of Applicant's OMETV mark, the dominant feature of Applicant's mark is "OME", which suggests a connection to or an affiliation with Opposer and its well-known OMEGLE chat service. That connection or affiliation is further supported by Applicant's repeated reference to Opposer's OMEGLE chat service in its marketing of Applicant's OMETV chat service.

- 15. The services covered under Applicant's applications for the OMETV mark are closely related, if not identical, to the services covered under Opposer's registration for its OMEGLE mark, in that both parties provide online chat services.
- 16. The confusing similarity of the parties' marks and the proximity of the parties' services offered under their respective marks is further compounded by the parties' use of related, if not identical, channels of trade, including specifically the Internet, to market to the same consumers.
- 17. Consumers familiar with Opposer's OMEGLE mark will incorrectly assume that Opposer is the origin of, or otherwise associated with, Applicant's chat service offered under the OMETV mark, or that Opposer has approved, endorsed, sponsored or otherwise authorized Applicant's chat service or its use of a mark confusingly similar to Opposer's OMEGLE mark.
- 18. Opposer, through its long-standing use of its OMEGLE mark and its marketing and promotion of its OMEGLE online chat service, has developed valuable goodwill in its OMEGLE mark.
- 19. As a result, Opposer will be damaged by the registration of Applicant's applications for the OMETV mark in that the OMETV mark so resembles Opposer's OMEGLE mark as registered as to be likely, when used in connection with the services identified in Applicant's applications, to cause confusion, or to cause mistake, or to deceive in contravention of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).
- 20. Given Opposer's prior rights in the OMEGLE mark, Applicant is not entitled to registration of the OMETV mark pursuant to Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

21. By reason of the foregoing, Opposer will be damaged by the registration of the

OMETV mark shown in Applicant's applications.

22. Both of Applicant's applications for the OMETV mark were published for

opposition in the Trademark Official Gazette on May 14, 2019. On June 11, 2019, Opposer filed

requests for a thirty-day extension of the time to file a notice of opposition to Applicant's two

applications for the OMETV mark. Those requests were granted the same day, giving Opposer

until July 13, 2019, to file a notice of opposition to Applicant's applications. Because this

Consolidated Notice of Opposition is being filed prior to July 13, 2019, it is timely.

WHEREFORE, for the foregoing reasons, Opposer respectfully requests that the Board

grant its Opposition and deny registration of both of Applicant's applications for the OMETV

mark.

This Consolidated Notice of Opposition is being filed electronically and the required fee

will be paid simultaneously with filing.
