**JOINT STATUS REPORT REGARDING STATUS OF SETTLEMENT AND MOTION

Pursuant to TBMP § 509, the parties, including Classic Media LLC, by and through its counsel, hereby respectfully request that all subsequent deadlines in the above proceeding be extended by an additional 60 days to allow the parties to continue their settlement efforts.

Per its Order entered on September 20, 2021, the Board requested that the parties file a status report detailing the progress they have made toward resolving the matter for all further Motions to Suspend or Extend for Settlement filed in this proceeding as well as a recitation of issues that have been resolved, the issues that remain to be resolved, and a firm timetable for resolution.
