NOTICE OF OPPOSITION

Opposer, Intuitive Surgical Operations, Inc. ("Opposer" or "Intuitive") believes that it will be damaged by the registration of the designation DA VINCI that is the subject of U.S. Application Serial No. 88/236,419 ("the Application"), and hereby opposes its registration under Lanham Act Section 13, 15 U.S.C. § 1063, and Trademark Rule 2.101, 37 C.F.R. § 2.101 on the following grounds:

FACTUAL BACKGROUND REGARDING OPPOSER AND ITS MARKS

1. Opposer Intuitive is a Delaware corporation, having its principal place of business at 1020 Kifer Road, Sunnyvale, California 94086-5304.

Opposer owns the Marks DA VINCI, DA VINCI S HD SURGICAL SYSTEM,
 DA VINCI S (design mark), DA VINCI SI HD SURGICAL SYSTEM, DA VINCI SONICPRO,
 DA VINCI S HD SURGICAL SYSTEM (standard character mark), DA VINCI CONNECT, DA

VINCI XI, DA VINCI SI, DA VINCI SP, DA VINCI X and related Marks for use in connection with surgical systems and associated surgical equipment and surgical instruments (collectively, the "DA VINCI Family of Marks").

3. The surgical systems and associated surgical equipment and surgical instruments bearing the Marks are used to perform state-of-the-art, minimally invasive surgical procedures across a broad range of surgeries.

4. Opposer has continuously used the DA VINCI Family of Marks since at least as early as July 7, 2000, long before the filing date of the Application.

5. Opposer is the owner of record of the incontestable registered trademark DA VINCI, U.S. Registration No. 2,628,871, U.S. Application Serial No. 75/982,190, filed on March 19, 1999 for "computerized surgical manipulation system comprised of surgeon's console, master control, immersive video display, camera image processing equipment, surgical manipulation system software and instructional manuals provided as a unit, patient-side cart with set-up arms and manipulator slave arms, sterile adaptors to connect arms to instruments, and a full line of resposable, in other words, limited re-use tools, namely, laparoscopes, endoscopes, trocars, cannulas, cutters, clamps, elevators, gouges, knives, scope preheaters, light sources, cables and component parts, electrosurgical instruments, electrocautery instruments, laser instruments, ultrasound instruments, lens cleaning, scrub and biopsy brushes, clip appliers and clips, tack appliers and tacks, applicators, ligature carriers, needle holders, clamps, hemostats, graspers, curettes, instrument guides, ligature passing and knotting instruments, needle, retractors, snares, stylets, forceps, dissectors, calipers, scissors, suction and irrigation probes, sterile drapes, hemostats, amputation hooks, ostetomes, saws, retainers, suturing apparatus, measuring tapes, chisels and contractors, files, skin graft expanders, lancets, mallets, pliers, hammers, rasps, spatulas, and strippers; a full line of FDA classes I and II exempt surgical

Opposer has invested many millions of dollars in the advertising and promotion of the DA VINCI Family of Marks for its surgical systems and associated surgical equipment and surgical instruments, and as a result of Opposer's extensive investment and effort in promoting Opposer's DA VINCI Family of Marks, they have become famous and well-known, and recognized as Opposer's Marks among consumers in the relevant industry.

FACTUAL BACKGROUND REGARDING THE APPLICATION

18. Upon information and belief, on December 20, 2018, Applicant Health Level Seven International, Inc., DBA Hooper Hathaway P.C., a New Jersey non-profit corporation having a principal place of business at 3300 Washtenaw Avenue, Suite 227, Ann Arbor Michigan 48104 ("Applicant"), filed U.S. Application Serial No. 88/236,419 in the United States Patent & Trademark Office ("USPTO") seeking registration of "DA VINCI" for use with

"Downloadable electronic publications in the nature of standards specification and implementation guides and manuals to enable the exchange of healthcare documents, payments, and information" in International Class 09 on an intent-to-use basis pursuant to Lanham Act Section 1(b). Applicant is the current owner of record of the Application.

19. Upon information and belief, the Application was published for opposition in the *Official Gazette* on May 28, 2019.

FIRST GROUND FOR OPPOSITION

(Likelihood of Confusion)

20. Opposer incorporates the allegations contained in Paragraphs 1 through 19 herein.

21. Based on Opposer's longstanding, extensive, and continuous use of Opposer's DA VINCI Family of Marks, the advertising and publicity they have received, Opposer's federal registrations for its DA VINCI Family of Marks, and the high degree of consumer recognition for Opposer's Marks, Opposer's DA VINCI Family of Marks are entitled to a broad scope of protection.

22. Applicant's use of the DA VINCI designation is confusingly similar to Opposer's DA VINCI Family of Marks, which are previously used and registered and, when used in connection with the purported services identified in the Application, is likely to cause confusion or mistake or deception as to source, affiliation and/or sponsorship.

23. The identified services offered by Applicant under the DA VINCI designation are highly related to the goods offered under Opposer's DA VINCI Marks, and on information and belief, both Opposer's and Applicant's respective goods and services are or will be marketed, offered for sale, and/or sold to the same consumers and in the same or similar channels of trade. A true and correct copy of Opposer's website, "Da Vinci Surgery," demonstrates that Opposer's SMRH:4813-7543-6962.1 -12DA VINCI surgical systems are utilized across a broad range of surgeries which are closely related to the healthcare document and data exchange services which Applicant intends to offer under its DA VINCI designation, is attached hereto as **Exhibit L**.¹

SECOND GROUND FOR OPPOSITION

(Dilution)

24. Opposer incorporates the allegations contained in Paragraphs 1 through 23 herein.

25. Opposer's DA VINCI Family of Marks are famous and distinctive within the meaning of the Federal Trademark Dilution Act, as amended. Opposer's DA VINCI Family of Marks became famous before Applicant's filing date of the Application, and Applicant seeks to commercially use the designation DA VINCI in the United States.

26. The registration of the designation that is the subject of the Application is likely to dilute Opposer's DA VINCI Family of Marks, either through dilution by blurring or dilution by tarnishment, or both.

THIRD GROUND FOR OPPOSITION

(False Suggestion of a Connection)

27. Opposer incorporates the allegations contained in Paragraphs 1 through 26 herein.

28. The trademark DA VINCI is strongly, if not exclusively, associated with Opposer Intuitive Surgical in the relevant medical/surgical space. The trademark DA VINCI is recognized as such, in that it uniquely and unmistakably points to Opposer Intuitive Surgical.

29. The designation that is the subject of the Application is not only a close approximation of but is identical to Opposer's previously used and longstanding trademark, DA

VINCI, and creates a false suggestion of a connection or association with Opposer Intuitive Surgical.

30. Opposer's Family of DA VINCI Marks were used long before Applicant's use and/or the filing date of its Application for DA VINCI.

31. Opposer is not connected in any way with Applicant or the proposed use by Applicant of the DA VINCI designation for "downloadable electronic publications in the nature of standards specification and implementation guides and manuals to enable the exchange of healthcare documents, payments, and information" as identified in the Application. The fame and reputation of Opposer Intuitive Surgical is of such a nature that a connection with Opposer will be presumed when Applicant's DA VINCI designation is used on or with or to promote Applicant's surgical services as identified in the Application.

32. Applicant's proposed designation DA VINCI is likely to create a false suggestion of a connection, association, or affiliation with Opposer or as to the origin, sponsorship or approval of Applicant's goods and/or commercial activities by Opposer.

33. Upon information and belief, Applicant's use and/or proposed use of DA VINCI will disparage Opposer, falsely suggest a connection with Opposer, and/or bring Opposer into disrepute.

FOURTH GROUND FOR OPPOSITION

(Misrepresentation of Source)

34. Opposer incorporates the allegations contained in Paragraphs 1 through 33 herein.

35. Upon information and belief, Applicant's intention in the use or intended use of DA VINCI is to misrepresent the source of the goods on or in connection with which Applicant uses or intends to use the designation.

36. Upon information and belief, Applicant has taken steps to deliberately pass off its services as related to the goods and state of the art technologies of Opposer, and has engaged in or intends to engage in blatant misuse of DA VINCI in a manner calculated to trade on the goodwill and reputation of Opposer.

DAMAGE TO OPPOSER

37. As a result of all of the foregoing, registration of Applicant's applied-for mark would cause a likelihood of confusion, mistake, or deception with Opposer and Opposer's DA VINCI Family of Marks, a likelihood of false connection, association, or affiliation with Opposer or as to the origin, sponsorship or approval of Applicant's services and/or commercial activities by Opposer, and/or a likelihood of dilution of Opposer's DA VINCI Family of Marks.

38. The registration of Applicant's DA VINCI designation on the Principal Register is inconsistent with Opposer's rights under the aforementioned registrations and common law, and would be damaging to Opposer, in that registration gives Applicant a *prima facie* exclusive right to the use of DA VINCI, despite the likelihood of confusion, mistake, or deception with Opposer and Opposer's DA VINCI Family of Marks and the likelihood of false connection, association, or affiliation with Opposer or as to the origin, sponsorship or approval of Applicant's services and/or commercial activities by Opposer, and/or likelihood of dilution as described above.
