1. Applicant filed a trademark infringement case naming, among other defendants, Opposer Tailorstory, Inc., on July 6, 2019, Case No. 19-cv-04565 pending before the United States District Court for the Northern District of Illinois (the “Lawsuit”).
2. Opposers Tailorstory, Inc. filed its counterclaim against Applicant in the Lawsuit on September 16, 2019. [Dkt. 105].
3. Opposers filed their Notice of Opposition on September 23, 2019.
4. On September 24, 2019, the USPTO TTAB set this Opposition’s “Conference, Discovery, Disclosure, and Trial Schedule” wherein Applicant’s deadline to answer the opposition remains November 3, 2019.
5. Opposers and Applicant have reached a settlement in principle with respect to the dispute in the Lawsuit, and thus also in this Opposition proceeding.
6. Opposers and Applicant request an extension of time (30 days) for Applicant to file its Answer.

WHEREFORE, for the reasons set forth above, Opposer and Applicant request that Applicant be

allowed until December 4, 2019 to file its Answer.
