1. Pursuant to TBMP § 605.03(a), the parties hereby notify the Board that effective October 28, 2021, Opposer Horizon and Applicant Verdesian have entered into a settlement agreement to resolve the issues set forth in Opposition Proceeding No. 91251302 (this “Proceeding”).
2.
