NOTICE OF OPPOSITION

Opposer, Rainforest Cafe, Inc. (hereinafter “Opposer”), a Minnesota corporation with an address of 1510 West Loop South, Houston, Texas 77027, believes that it would be damaged by registration of the mark shown in Serial No. 88292330, filed February 7, 2019, by Rainforest Inn, LLC (hereinafter “Applicant”), a Puerto Rico limited liability company with an address of P.O. Box 2087, Rio Grande, Puerto Rico 00745, and hereby opposes registration of the mark.

The grounds for opposition are as follows:

1. By the application herein opposed, Applicant is seeking to obtain under the provisions of the Trademark Act of 1946 as amended, a registration on the Principal Register of the mark RAINFOREST INN in connection with “bed and breakfast inn services,” in International Class 43.

2. Applicant’s mark was published for opposition on June 11, 2019 and Opposer extended the time to oppose the same until October 9, 2019. This Notice of Opposition is timely filed.




3. Opposer develops, owns and operates the internationally well-known RAINFOREST CAFE combination restaurant and retail facilities throughout the United States and internationally, including at international tourist destinations in the U.S., Canada, Europe,

Japan and the Middle East, including at Disney World in Florida (2 locations), Mall of America, Las Vegas, Nevada, Downtown Chicago, Niagara Falls, Disney Paris in Paris, France, Piccadilly Circus in London, England, Ikspiari Shopping Mall at Tokyo Disney Resort in Tokyo, Japan, and the Dubai Mall in UAE.

4. Since at least as early as October 3, 1994, Opposer has been using the mark RAINFOREST CAFE to identify and promote its restaurant and retail store services, as well as a range of souvenir consumer products.

5. Opposer is the owner of the mark RAINFOREST CAFE and the RAINFOREST CAFE stylized and design marks shown in the table below for restaurant services, retail store services, and various souvenir consumer goods.

6. Opposer owns numerous registrations for its well-known RAINFOREST CAFE marks, including the following (collectively, along with the common law usage referred to herein, “Opposer’s Marks”):

Current printouts of information from the electronic database records of the USPTO showing the current status and title of the registrations are attached hereto as Exhibit A.

7. The registrations listed in the above table have not been cancelled, are valid, are now in full force and effect, and have become incontestable under Section 15 of the Lanham Act,

15 U.S.C. § 1065. Consequently, these registrations are conclusive evidence of the validity of the registered marks and of the registration of the marks, of Opposer's ownership of the marks, and of Opposer's exclusive right to use the marks in commerce under Section 33 of the Lanham Act, 15 U.S.C. § 1115.

8. Opposer has advertised and promoted Opposer's Marks continuously and extensively, and made substantial sales of services and products under said marks. Opposer's company name is Rainforest Cafe, Inc., and Opposer owns the website and the domain name RAINFORESTCAFE.COM. As a result of such continuous use and promotion, Opposer's Marks have developed and represent valuable goodwill inuring to the benefit of Opposer.

9. There is no issue of priority concerning Application Serial No. 88292330 since Opposer used and registered Opposer's Marks prior to Applicant's February 7, 2019, filing date and Applicant's claimed date of first use of June 25, 1997. Opposer adopted and commenced use of Opposer's Marks as trademarks long before Applicant adopted or used the claimed RAINFOREST INN mark. Opposer's usage of the mark RAINFOREST CAFE as a trademark commenced at least as early as October 3, 1994, which is prior to the filing date or claimed date of first use of Applicant's application for its claimed RAINFOREST INN mark. Opposer therefore has priority over Applicant with respect to the marks at issue.

10. Upon information and belief, Applicant had knowledge of the fact that Opposer used Opposer's Marks as trademarks and/or had constructive knowledge of Opposer's Marks and registrations before it adopted the claimed RAINFOREST INN mark and before it filed its application for the claimed RAINFOREST INN mark.

11. Applicant's claimed RAINFOREST INN mark is confusingly and deceptively similar to Opposer's previously used and duly registered Opposer's Marks.

12. Applicant's claimed RAINFOREST INN mark is nearly identical in sight, sound and commercial impression to Opposer's Marks.

13. Applicant's services are closely related to Opposer's services and goods marketed and sold by Opposer in connection with Opposer's Marks.

14. In particular, Opposer offers restaurant services and Applicant has applied for services that include the provision of food service, which are highly related to each other.

15. Upon information and belief, Opposer's goods/services and Applicant's services are promoted and sold through the same channels of trade to the same consumers or class of consumers.

16. Due to the similarity between Applicant's claimed mark, RAINFOREST INN and Opposer's previously used and registered Opposer's Marks, the closely related nature of the goods/services of the respective parties, customers and potential customers are likely to believe that Applicant's services originate from Opposer, resulting in a likelihood of confusion in the marketplace, and damage to Opposer.

17. The use and registration by Applicant of the claimed mark RAINFOREST INN for Applicant's services is likely to cause confusion or to cause mistake or deception in the trade, and among purchasers and potential purchasers, with Opposer's previously used and registered Opposer's Marks, again resulting in damage to Opposer

18. Because of the closely related nature of the services of the parties, and the similarity of the marks, use and registration of the claimed mark RAINFOREST INN by Applicant is likely to cause confusion, mistake, or deception that Applicant's services are those of Opposer, or are otherwise endorsed, sponsored, or approved by Opposer causing further damage to Opposer.

19. Registration of the claimed RAINFOREST INN mark shown in Application Serial No. 88292330 will result in damage to Opposer under the provisions of Section 2 of the U.S. Trademark Act, 15 U.S.C. § 1052, pursuant to the allegations stated above.

WHEREFORE, Opposer requests that its opposition to this application be sustained and that registration of the mark shown in Application Serial No. 88292330 for the services set forth therein be refused.
