NOTICE OF OPPOSITION

Kudos, Inc. (“*Kudos*” or “*Opposer*”) believes that it will be damaged by the issuance of a registration for the mark KUDOS as applied for in application Serial No. 87/430346 and therefore opposes the same pursuant to Section 13(a) of the Lanham Act, 15 U.S.C. § 1063(a). As grounds for this opposition, Opposer, by its undersigned counsel, states as follows:

FACTS COMMON TO ALL CAUSES OF ACTION

1. Opposer is a corporation organized and existing under the laws of the Province of Alberta, Canada, with a business address of 101 - 1240 20th Ave SE, Calgary, Alberta, Canada T2G 1M8.

2. For nearly a decade Opposer has continuously used the mark KUDOS, and numerous related KUDOS-inclusive marks (collectively the “*KUDOS Marks*”) around the world including the United States in connection with on-line social networking software and software applications featuring technology used to enable and manage online communication, interaction, and collaboration among users (the “*Kudos Platform*”). The Kudos Platform has expanded to

encompass a wide variety of services, including services intended to increase individual performance, personal wellness, and well-being. Opposer has extensively used and promoted the KUDOS Marks in the United States.

3. Through this extensive promotion and use, and the success of Opposer’s offerings under the KUDOS Marks, Opposer has developed strong trademark rights and enormous goodwill in the KUDOS Marks.

4. Long before any date upon which Applicant can rely, the KUDOS Marks became uniquely identified with Opposer and came to identify the products and services of Opposer.

5. In addition to its substantial common law trademark rights, Opposer owns the following U.S. trademark registrations, some of which have achieved “incontestable” status:

6. Copies of the TSDR status printouts for the foregoing registrations are attached hereto as **Exhibit A**.

7. According to the online records of the United States Patent and Trademark Office (“*USPTO*”), applicant Everfit, Inc. d/b/a Kudos (“*Applicant*”) is a Delaware corporation with a business address of 2405 Larkin Street, San Francisco, California, 94109.

8. According to the online records of the USPTO, applicant filed with the USPTO trademark application Serial No. 87/4303 (the “*Application*”) to register the mark KUDOS in in Class 41 for “Fitness technology, namely, providing a website and an online computer database featuring information regarding exercise techniques and an assigned human coach that, when combined, provide personalized exercise recommendations, videos, how-to guides, and step-by-

step directions on how to complete exercise movements that support a customer's fitness goals,” based on an intent to use the mark under Section 1(b) of the Lanham Act, 15 U.S.C. § 1051(b).

9. Upon information and belief, the May 31, 2018 filing date of the Application is the earliest date upon which Applicant can rely for any claim of rights in the KUDOS mark. This date is long after Opposer developed substantial trademark rights in the KUDOS Marks, and thus Opposer’s rights in the KUDOS Marks are prior and superior to any rights Applicant may claim in the KUDOS mark.

10. Applicant’s KUDOS mark is identical or nearly identical to Opposer’s KUDOS Marks in appearance, sound, and commercial impressions.

11. Applicant seeks to register the KUDOS mark for services that are identical or closely related to those that have been provided and/or registered by Opposer, or are within Opposer’s zone of reasonable expansion, under the KUDOS Marks.

12. Upon information and belief, the trade channels Applicant intends to use to deliver the services recited in the Application overlap with and/or are similar to the trade channels used by Opposer in connection with the KUDOS Marks.

13. The recitation of services in the Application contains no limitations or exclusions regarding channels of trade or target consumer groups. Thus, the services are presumably offered to all classes of consumers via all available trade channels.

14. Applicant’s use and registration of the KUDOS mark in connection with the goods identified in the Application is likely to cause confusion, cause mistake, or to deceive consumers to falsely believe that Applicant’s goods emanate from or otherwise are authorized, sponsored by, or affiliated with Opposer, in violation of Section 2(d) of the Lanham Act, 15 U.S.C. 1052(d).

15. By reason of the foregoing, Opposer is likely to be harmed by the registration of the Application for the KUDOS mark.

WHEREFORE, Opposer respectfully requests that this opposition be sustained and that the registration sought by the Application be denied.
