APPLICANT STIPULATED/ CONSENT MOTION TO EXTEND

This motion is based on the facts and argument below, as well as the record and file of this proceeding and any other oral or documentary evidence that may be relevant. On October 16, 2020, Gabriel Vincent Dupree exchanged communications with Guess via email. The contents of that discussion was Gabriel Vincent Dupree, the Applicant accepting a prior offer as for grounds to settlement that was proposed by Attorney, Michael J. MacDermott. The settlement included Guess being responsible for all Trademark Applicant fees prior to submission in exchange for the removal of the current application and resubmission of the mark into a more appropriate class and category specifically being film, media, and music. After said communication the Opposer, on October 16, 2020 said he would reconvene with his client, Guess and respond within the next week.

After hearing of no communication from Opposer, I Gabriel Vincent Dupree, Applicant called the office of the Attorney, Michael J. MacDermott, on October 23, 2020. I was unsuccessful at reaching the Attorney, Michael J. MacDermott himself, however I was able to speak with his Legal Secretary, Raymond Oo. At that time, Legal Secretary, Raymond Oo informed me that the Attorney was not available however, he had spoken to Attorney, Michael J. MacDermott about the matter. Legal Secretary, Raymond Oo then gave me legal advice to submit a motion to extend, assuring Attorney, Michael J. MacDermott would consent to a 30 day extension as we wait for a response from their client, Guess on the

settlement proposed by the Attorney. Today is October 23, 2020 marking the current Applicant's Amended Answer and Initial Disclosure due date. It also marks the last communication I've had with the Client, Guess and their representing attorney. With these facts I hope the trial will be adjusted accordingly and I therefore urge that this motion to extend for 30 days be granted.
