**STIPULATED MOTION FOR SUSPENSION OF OPPOSITION  
AND TO RESET TRIAL DATES**

Applicant, NVIDIA Corporation, by and through its attorneys, hereby requests that the Trademark Trial and Appeal Board (“Board”) suspend proceedings in the above-entitled opposition for a further 90 days to allow the parties to continue their settlement efforts. Counsel for Opposer consented to this request via email with the undersigned counsel on June 9, 2021.

The current suspension period for this proceeding ends on June 17, 2021. The suspension for a further 90 days would end on September 15, 2021. The parties have exchanged several settlement proposals and are engaged in ongoing settlement negotiations.
