NOTICE OF PARTIAL OPPOSITION

Coulter Ventures, LLC, an Ohio limited liability company whose address is 545 E. 5th Avenue, Columbus, Ohio 43201 (“Opposer”), will be damaged by registration of the above-identified mark in International Class 28 (hereinafter “Applicant’s Mark”), applied for on the Principal Register by Monster Energy Company, a corporation of Delaware whose address of record is 1 Monster Way, Corona, California 92879 (“Applicant”), and hereby opposes registration in International Class 28 of same.

The grounds for the partial opposition are as follows:

1. Opposer is a leading supplier of strength and conditioning equipment, lifestyle goods, and services associated with physical fitness and training.

2. Opposer is the owner of at least the following U.S. Trademark Applications and common law rights for the following marks containing “MONSTER” (hereinafter, the “MONSTER Marks”):

Copies of the USPTO TSDR records showing current status and title of the applications are attached as Exhibit A.

3. Opposer also has common law rights in the MONSTER Marks for use in connection with, *inter alia*, weight lifting equipment, namely, weight lifting rigs, weight lifting racks, weight lifting benches, monkey bars, pull up bars, storage racks and posts for weights, dumbbells, kettlebells, and exercise bands that predate Applicant's March 13, 2018 date of first use asserted in its application for the International Class 28 goods.

4. Opposer has made substantial sales of goods under the MONSTER Marks.

5. As a result of Opposer's use and applications for the MONSTER Marks, Opposer has developed substantial goodwill in the MONSTER Marks, and the public has come to associate the MONSTER Marks with the goods and services of Opposer.

6. On March 21, 2017, Applicant filed the following Oppositions against Applications owned by Opposer:

7. On September 28, 2017, the Board issued an order to consolidate Opposition Nos. 91233515, 91233516 and 91233517, with Opposition No. 91233515 being the parent Opposition.

8. On July 3, 2018, Applicant filed Opposition No. 91242202 against Opposer's Application Serial No. 87/777738 for the mark "MONSTER MASS STORAGE."

9. On January 17, 2019, the Board issued an order further consolidated Opposition No. 91242202 with and into Opposition No. 91233515.

10. Applicant filed its Application No. 88/264717 for Applicant's Mark MUSCLE MONSTER on January 16, 2019, pursuant to Section 1(a) of the Trademark Act in connection with "Resistance bands for exercise" in International Class 28 and alleging a date of first use in commerce of at least as early as March 13, 2018, as well as filing for other goods in International Classes 9, 14, 16, 18, 21 and 24.

11. If Applicant is permitted to register its mark for "Resistance bands for exercise" in International Class 28, the registration will give Applicant a *prima facie* exclusive right to the use of Applicant's Mark for those goods. Such registration would damage and injure Opposer.

COUNT I

LIKELIHOOD OF CONFUSION

12. Opposer repeats and realleges paragraphs 1-11 as paragraph 12 of this Count I.

13. Opposer's filing dates and use of its MONSTER Marks are long prior to the filing date and date of first use of the International Class 28 goods covered by the opposed Application.

14. On information and belief, Applicant was aware of Opposer's MONSTER Marks at the time it filed its application.

15. Applicant's Mark is confusingly similar to Opposer's MONSTER Marks.

16. Applicant's Mark is confusing similar to Opposer's MONSTER Marks with respect to at least "Resistance bands for exercise" in International Class 28 such that the use and registration of Applicant's Mark in connection with such goods in International Class 28 is likely to cause confusion, mistake, or deception of the public and lead the public and prospective purchasers to believe that Applicant's goods in International Class 28 are those of Opposer or are endorsed, sponsored, or otherwise affiliated or connected with Opposer, or that Opposer's goods and services are associated with Applicant, all to the damage and injury of the purchasing public and to the damage and injury of Opposer.

17. Applicant's use and registration of its mark in International Class 28 will inevitably lead to confusion, to mistake, or to deception of the public within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d), all to Opposer's grave and irreparable damage.

18. Registration of Applicant's Mark in International Class 28 should be denied based on a likelihood of confusion with Opposer's prior MONSTER Marks, in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d).

CLAIM FOR RELIEF/DAMAGE

19. By reason of the foregoing, Applicant's registration of the mark in International Class 28 herein opposed will cause injury and damage to Opposer's rights to its MONSTER Marks and to its use thereof described above.

20. WHEREFORE, Opposer respectfully prays that the present opposition be sustained and that the registration sought by the Applicant in International Class 28 be refused.
