OPPOSER’S MOTION FOR DEFAULT JUDGEMENT

Springfield, Inc. (“Opposer”) brings the present Motion for Default Judgment pursuant to TBMP §312.01.

On October 4, 2021 the TTAB entered an order (37 TTABVUE) granting as conceded Opposer’s motion (filed July 2, 2021, 32-33 TTABVUE) for leave to file an amended notice of opposition and its motion (filed July 19, 2021, 35 TTABVUE) challenging the confidentiality designation of Exhibit A to the motion. The October 4th Order provided Applicant twenty days, until October 24, 2021, to file an answer to the amended notice of opposition.

Applicant has not filed an answer to the amended notice of opposition. In view of Applicant’s failure to respond to Opposer’s prior two motions and Applicant’s current failure to file an answer, it does not appear that Applicant intends to further respond or otherwise participate in this opposition proceeding. Therefore, Opposer hereby requests, pursuant to 37 C.F.R. §2.106(a), that the TTAB enter a default judgment against Applicant on all counts in the Notice of Opposition. Action in accordance with this request is respectfully requested.

Pursant to TBMP §312.01, Opposer requests that this motion for default substitute for the Board's issuance of a notice of default.
