**NOTICE OF OPPOSITION**

International Brotherhood of Teamsters, a District of Columbia unincorporated association, whose address is 25 Louisiana Avenue, N.W., Washington D.C. 20001 (“Opposer”), believes it will be damaged by issuance of a registration of the mark NJ TEAMSTERS FC & Design to Applicant and hereby opposes the same.

The grounds for opposition are as follows:

**OPPOSER’S MARKS**

1. Opposer is a labor union that was founded in 1903 and has been in existence for more than 115 years. Since its founding, Opposer has used the mark INTERNATIONAL BROTHERHOOD OF TEAMSTERS in connection with its labor union services. Throughout the past century, Opposer has used numerous marks that include the terms TEAMSTER or TEAMSTERS for various goods and services. Opposer has 1.4 million members making it one of the largest unions in the country, and provides a myriad of goods and services to its members including, without limitation, office supplies; publications; tote bags; novelty items, jewelry; clothing; labor union and association services, educational services; credit card services;



insurance services; loan services, legal aid services, mortgage services, internet and phone access services; health discount services; and everyday savings services on various third party goods and services.

2. There have been thousands of movies, documentaries, books, or articles written about Opposer or its leaders during the last century. Some have become feature films starring actors such as Jack Nicholson, Danny DeVito, Al Pacino, Robert De Niro and Joe Pesci.

3. Long prior to the March 12, 2019 filing date of Applicant’s opposed application and the March 11, 2019 claimed date of first use in commerce of the mark set forth in Applicant’s opposed application, Opposer adopted and used, and is still using in commerce, numerous marks that include the term TEAMSTERS and cover office supplies; publications; paper goods; tote bags; jewelry; clothing; novelty items; mugs and cups; labor union and association services; educational services; credit card services; insurance services; loan services; legal aid services; mortgage services; internet and phone access services; health discount services; everyday savings services on various third party goods and services; social club services; organizing, arranging, and conducting social entertainment events for children and combat service-injured personnel; employment services; and disaster relief services (“Opposer’s Goods and Services”).

4. Opposer is the owner of the mark INTERNATIONAL BROTHERHOOD OF




TEAMSTERS & Design having continuously used said mark for labor union services for more than 75 years, since at least as early as 1940 (the “INTERNATIONAL BROTHERHOOD OF TEAMSTERS & Design Mark”).

5. Opposer is the owner of the mark INTERNATIONAL BROTHERHOOD OF TEAMSTERS having continuously exercised legitimate control over the use in commerce of

said mark for indicating membership in a labor union of transportation, maintenance, handling, and healthcare workers, and public employees, for nearly 30 years, since at least as early as 1991 (the “INTERNATIONAL BROTHERHOOD OF TEAMSTERS Mark”).





6. Opposer is the owner of numerous other marks that include the term TEAMSTERS or TEAMSTER, having continuously used these marks for Opposer’s Goods and/or Services since at least as early as 1993 (collectively, the “Other TEAMSTERS / TEAMSTER Marks”).



7. Opposer is the owner of Registration No. 1,994,996 for the mark  for the services set forth in that registration. Said registration is incontestable under 15 U.S.C. § 1065, and is conclusive evidence of the validity of the registered mark, of Opposer’s ownership of the mark, and of Opposer’s exclusive right to use the registered mark in commerce under 15 U.S.C. § 1115. A copy of the registration taken from the USPTO database showing current status and title of the registration is attached hereto as Exhibit A.

8. Opposer is the owner of Registration No. 2,607,484 for the mark INTERNATIONAL BROTHERHOOD OF TEAMSTERS for the services set forth in that registration. Said registration is incontestable under 15 U.S.C. § 1065, and is conclusive evidence of the validity of the registered mark, of Opposer’s ownership of the mark, and of Opposer’s exclusive right to use the registered mark in commerce under 15 U.S.C. § 1115. A copy of the registration taken from the USPTO database showing current status and title of the registration is attached hereto as Exhibit B.

9. Opposer is the owner of the following additional registrations, each of which contains the term TEAMSTERS or TEAMSTER, and is valid and subsisting:

Each of these registrations is incontestable under 15 U.S.C. § 1065, and is conclusive evidence of the validity of the registered mark, of Opposer’s ownership of the mark, and of Opposer’s exclusive right to use the registered mark in commerce under 15 U.S.C. § 1115. A copy of each of these registrations taken from the USPTO database showing current status and title of the registration is attached hereto as Exhibits C - J.

10. The registrations attached as Exhibits A - J, are collectively referred to as “Opposer’s TEAMSTERS Registrations” and the marks set forth in Opposer’s Registrations are collectively referred to as “Opposer’s Registered TEAMSTERS Marks” and the goods and services set forth in Opposer’s Registrations are collectively referred to as “Opposer’s Registered Goods and Services.”

11. Opposer also owns common law rights in marks consisting of or containing the term TEAMSTERS, including but not limited to, for example, THUNDER TEAMSTERS for social club services, namely, arranging, organizing, and hosting social events, get-togethers, and parties for club members; organizing, arranging, and conducting social entertainment events for children and combat-injured service personnel; TEAMSTER JOB BANK for employment services; TEAMSTERS for disaster relief, and others, hereafter collectively referenced as “Opposer’s Common Law TEAMSTERS Marks”, each of which has been in use for years prior to the March 12, 2019 filing date of Applicant’s opposed application and the March 11, 2019 claimed date of first use in commerce of the mark set forth in Applicant’s opposed application.

12. Opposer’s use, for more than a century, of many marks that include the term TEAMSTERS or TEAMSTER for a broad variety of goods and services, is one reason that


marks containing the term TEAMSTER or TEAMSTERS are associated with Opposer. The INTERNATIONAL BROTHERHOOD OF TEAMSTERS & Design Mark, the INTERNATIONAL BROTHERHOOD OF TEAMSTERS Mark, the Other TEAMSTERS / TEAMSTER Marks, Opposer's Registered TEAMSTERS Marks, and Opposer's Common Law TEAMSTERS Marks, are collectively referred to as Opposer's "Family of TEAMSTERS Marks".

13. By virtue of Opposer's prior and continuous use of Opposer's Family of TEAMSTERS Marks, the public has come to recognize Opposer's Family of TEAMSTERS Marks as an indication of origin in Opposer and, as a consequence of which, Opposer has established valuable goodwill and exclusive rights in the marks.

#### **APPLICANT'S MARK**

14. Upon information and belief, New Jersey Teamsters Football Club AKA NJ Teamsters FC is a limited liability company of New Jersey, with an address of 63 W. 30<sup>th</sup> Street, #102, Bayonne, New Jersey 07002 ("Applicant").



15. Applicant's Application Serial No. 88/337182 of the mark  was filed with the U.S. Patent and Trademark Office ("PTO") on March 12, 2019, based on use in commerce of the mark since March 11, 2019, and covers: organization of soccer games; organizing and conducting athletic competitions and games in the field of soccer; organizing, conducting, and operating soccer tournaments ("Applicant's Services").



16. Following the publication of the application, Opposer sought and obtained extensions of time from the PTO to and including January 8, 2020, in which to file a Notice of Opposition.

**COUNT I: LIKELIHOOD OF CONFUSION**

17. Opposer repeats and re-alleges each and every allegation set forth in the preceding paragraphs.

18. On information and belief, the earliest date on which Applicant can claim rights in



the mark for Applicant's Services is March 11, 2019, the claimed date of first use in commerce of the mark in connection with Applicant's Services.

19. Opposer's use of its Family of TEAMSTERS Marks for Opposer's Goods and



Services long predate the claimed first use in commerce date of the mark for Applicant's Services, as well as the filing date of Application Serial No. 88/337182 of the



mark for Applicant's Services.




20. Opposer's Mark and Applicant's Mark each contain the term

TEAMSTERS and each include a design that incorporates the head of a horse. The common elements in each mark create a connection between the marks.


21. The use of Opposer's Registered TEAMSTERS Marks for the sale of Opposer's




Registered Goods and Services, and the use of  for the sale of Applicant's Services, are likely to cause customers, prospective customers and others to be confused, mistaken or deceived into believing, contrary to fact, that Applicant's Services emanate from or are in some way sponsored, licensed or approved by Opposer, thereby damaging Opposer.

22. The use of Opposer's Common Law TEAMSTERS Marks for the sale of Opposer's




Goods and Services, and the use of  for the sale of Applicant's Services, are likely to cause customers, prospective customers and others to be confused, mistaken or deceived into believing, contrary to fact, that Applicant's Services, if offered in connection with the



 mark, emanate from or are in some way sponsored, licensed or approved by Opposer, thereby damaging Opposer.

23. Applicant is not lawfully entitled to the registration that it seeks because the




 mark, when used for Applicant's Services, so resembles Opposer's Family of TEAMSTERS Marks as to be likely to cause confusion, to cause mistake or to deceive within the meaning of 15 U.S.C. § 1052(d), thereby damaging Opposer.


## **COUNT II: DILUTION**

24. Opposer repeats and re-alleges each and every allegation set forth in the preceding paragraphs.

25. Opposer's Family of TEAMSTERS Marks has become distinctive and famous as indicators of source and origin as a result of Opposer's longstanding and widespread use, substantial publicity, news coverage, and extensive national promotion of its Family of TEAMSTERS Marks, through various forms of media including print, television, radio, Internet, and social media.

26. Opposer's Family of TEAMSTERS Marks became distinctive and famous within

the meaning of 15 U.S.C. § 1125(c) long before Applicant filed the  application and

before Applicant's claimed date of first use in commerce of  for Applicant's Services.

27. A registration of the  mark for Applicant's Services is likely to dilute the distinctive quality of Opposer's Family of TEAMSTERS Marks within the meaning of 15 U.S.C. § 1125(c), thereby damaging Opposer.

28. A registration of the  mark for Applicant's Services is likely to lessen the capacity of Opposer's famous Family of TEAMSTERS Marks to identify and distinguish Opposer's Goods and Services from the goods and services of others.

WHEREFORE, Opposer respectfully requests that this Notice of Opposition be sustained and

that registration of the  mark by Applicant be refused.
