10. The mark in the Application is substantially similar to Opposer's Registered Marks, covering the same Classes of goods/services.

Based on the substantially similar nature of the marks covering the same Classes of goods/services, the purchasing public is likely to falsely associate Applicant's goods with Opposer, or may erroneously believe the goods offered under the mark shown in the Application are sponsored, licensed, or otherwise endorsed and/or authorized by or affiliated with Opposer.

WHEREFORE, Opposer prays that Application No. 88/353418 be denied registration and that this Notice of Opposition be granted in favor of Opposer.
