**JOINT MOTION FOR AMENDMENT AND CONDITIONAL WITHDRAWAL OF
OPPOSITION**

Pursuant to TBMP §§ 212.07, 514 and 601, Applicant Aclaris Therapeutics, Inc. (“Aclaris”) and Opposer Neurocrine Biosciences, Inc. (“Neurocrine”) jointly move to amend the description of services in U.S. App. No. 88/372,841 (the “841 Application”), and conditionally withdraw the present Opposition proceeding.

Pursuant to an agreement between the parties, Neurocrine consents to amendment of the description of services in the subject application as follows:

“Research and development of pharmaceutical preparations, products and technology in the fields of dermatology; providing medical and scientific research information in the fields of dermatology and pharmaceuticals, pharmaceuticals and clinical trials; drug discovery services; a drug discovery platform.”
