NOTICE OF OPPOSITION TO APPLICATION NO. 88/196359

1. Applicant seeks to register the mark HUSHINSOLES for the following goods: “Orthopaedic soles; Orthopaedic inner soles incorporating arch supports; Orthopedic soles.”

2. The Application was filed on November 16, 2018, based on actual use on that same date.

3. For over 60 years, Opposer and its predecessors have sold and marketed footwear under the HUSH PUPPIES brand. Over the years, Opposer and its predecessors have expanded the line of products sold under the HUSH PUPPIES mark to include a variety of products beyond footwear as well. The HUSH PUPPIES trademark is widely known and associated with Opposer. Opposer uses the HUSH PUPPIES trademark on its marketing materials, website, in stores and on products.

4. Since prior to the filing date of the Application and Applicant’s stated date of first use, Opposer has used and established rights to the HUSH PUPPIES trademark (“Opposer’s Mark”). Opposer is currently the owner of record of United States Trademark Reg. Nos. 663849, 767344, 913297, 1118874, 1358761, 1381201, 1733837, 2040768, 2166409, 4094628, 5340967, 5408576 as well as other registrations in the past and pending United States Trademark Application No. 88/662163. Registration No. 1381201, issued February 4, 1986, in particular is for “foot care products, namely insoles” in Class 10. Copies of the TSDR status of the registrations and application are attached to this Notice.

5. There is no issue as to priority. The date of the Application and Applicant’s stated first use are subsequent by many years to Opposer’s first use of Opposer’s Mark and subsequent to most of Opposer’s registrations listed in this Notice.

6. Goods and services bearing Opposer’s Mark have been continuously offered to the public for many decades. Opposer has also widely advertised its products and services under Opposer’s Mark throughout the United States. Opposer’s sales and advertising of products and services bearing Opposer’s Mark have been substantial. Based upon this long term use and advertising, Opposer’s Mark has become well-known and famous.

7. Through Opposer’s advertising, provision of services, and sale of products bearing Opposer’s Mark, the public has come to recognize that mark as signifying Opposer and its products and services. Opposer has gained extensive and valuable goodwill in connection with the products and services provided under Opposer’s Mark.

8. Applicant’s mark HUSHINSOLES is confusingly similar to Opposer’s Mark, and Applicant seeks to register this mark for goods covered by and related to Opposer’s Mark, which is likely to cause a likelihood of confusion.

9. The mark HUSHINSOLES applied for by Applicant is a reproduction, copy and colorful imitation of Opposer’s Mark. The use by Applicant of its mark in association with footwear and clothing items, is likely to cause confusion, deception, and mistake as to the

affiliation of Applicant's goods and to confuse, mislead, and deceive members of the public into believing that Applicant's goods originate from or are provided, sponsored, approved, or licensed by Opposer, or are in some way connected to Opposer. Any such confusion would have a direct impact on Opposer's reputation and ability to market its products and services. Furthermore, any defect, objection or fault found with Applicant or Applicant's goods marketed under its mark would negatively impact and seriously injure the reputation that Opposer has established for its goods under Opposer's Mark.

10. Opposer's Mark is distinctive and famous and Applicant's HUSHINSOLES mark will cause dilution of the distinctive quality of Opposer's Mark.

11. If Applicant is granted the registration opposed in this Notice, it would obtain at least a *prima facie* exclusive right to use the HUSHINSOLES mark. This registration would damage and injure Opposer.

12. Opposer respectfully requests that its opposition be sustained and that registration to Applicant be refused.
