NOTICE OF OPPOSITION

Opposer, Tod’s S.p.A., an Italian joint stock company located at Sant’Elpidio a Mare, Via Filippo Della Valle, 1, Ascoli Piceno, Italy 63019, by and through undersigned counsel and pursuant to 37 C.F.R. § 2.101(b) hereby opposes Applicant Yiwu Yunpu Trade Co., Ltd.’s U.S. Trademark Application Serial No. 88557391 to register the mark STACY FAY because Opposer believes it will be damaged by registration of the application. The grounds for the opposition are as follows:

BACKGROUND

1. On information and belief, Applicant Yiwu Yunpu Trade Co., Ltd., (“Yiwu” or “Applicant”) is a Chinese limited liability company.
2. On August 1, 2019 (the “Filing Date”), Applicant filed U.S. Trademark Application Serial No. 88557391 (the “Application”) for the mark STACY FAY (“Applicant’s Mark”) covering “briefs; dress pants; dress shields; dress shirts; dress suits; dresses; pajamas; pyjamas; shorts; socks; t-shirts; ankle socks; board shorts; boat socks; boxer briefs; men’s socks; non-slip socks; slipper socks; thermal socks; toe socks; trouser socks; walking shorts; water socks; woollen socks; yoga socks” (collectively, the “Opposed Goods”) in International Class 25.

3. The Application was filed based on alleged use of Applicant's Mark in commerce under Trademark Act § 1(a), 15 U.S.C. § 1051(a).

4. The Application alleges July 15, 2019 as the date of first use in commerce for Applicant's Mark.

**OPPOSER'S USE AND REGISTRATION OF
ITS FAY TRADEMARK**

5. Opposer offers high-quality men's, women's and children's clothing, apparel, and related accessories in the United States under various FAY trademarks (the "FAY Marks").

6. Since at least as early as 2005, Opposer has used its FAY Marks continuously in United States commerce in connection with bags and wallets.

7. Since at least as early as December 2, 2013, Opposer has used its FAY Marks continuously in United States commerce in connection with clothing, apparel, and footwear.

8. Opposer has not abandoned its FAY Marks.

9. As a result of Opposer's promotion and use of its FAY Marks, the FAY Marks have come to identify goods originating exclusively from, or otherwise associated with Opposer, and are distinctive of Opposer's high-quality goods.

10. Opposer owns various U.S. trademark registrations for its FAY Marks including the following (collectively the "FAY Registrations"):

- a. U.S. Registration No. 3348680 for the mark FAY & Design, covering various goods in Classes 18 and 25;
- b. U.S. Registration No. 3769306 for the mark FAY & Design covering various goods in Classes 18 and 28;
- c. U.S. Registration No. 4516823 for the mark FAY & Design, covering various goods and services in Classes 14 and 35; and

- d. U.S. Registration No. 4603610 for the mark FAY & Design, covering various goods in Class 25.

True and correct copies of the TSDR records for the FAY Registrations are attached as Exhibit A.

11. The FAY Registrations are valid and subsisting on the Principal Register.
12. Applicant is not associated with or affiliated with Opposer.
13. Opposer has not consented to Applicant's use or registration of Applicant's Mark.

**COUNT I
LIKELIHOOD OF CONFUSION BASED ON PRIORITY OF USE**

14. Paragraphs 1-13 are incorporated herein by reference as if fully set forth.
15. On information and belief, Opposer first used its FAY Marks in commerce prior to Applicant's use of Applicant's Mark.
16. When applied to the Opposed Goods, Applicant's Mark so resembles Opposer's FAY Marks as previously used in the United States, that it will be likely to cause confusion.
17. Opposer will be damaged by registration of Applicant's Mark because consumers are likely to be confused as to the source of the goods offered by Opposer under its FAY Marks and the goods offered by Applicant under Applicant's Mark.
18. Accordingly, Applicant's Application should be refused pursuant to Trademark Act § 2(d), 15 U.S.C. § 1052(d), because Opposer has priority of use.

**COUNT II
LIKELIHOOD OF CONFUSION BASED ON PRIORITY OF REGISTRATION**

19. Paragraphs 1-13 are incorporated herein by reference as if fully set forth.
20. Opposer's FAY Registrations issued prior to Applicant's Application Filing Date.
21. When applied to the Opposed Goods, Applicant's Mark so resembles the marks in Opposer's previously registered FAY Registrations in the United States that it will be likely to cause confusion.

22. Opposer will be damaged by registration of Applicant's Mark because consumers are likely to be confused as to the source of the goods offered by Opposer under its FAY Marks and the goods offered by Applicant under Applicant's Mark.

23. Accordingly, Applicant's Application should be refused pursuant to Trademark Act § 2(d), 15 U.S.C. § 1052(d), because Opposer has priority of registration.

WHEREFORE, Opposer hereby respectfully requests: (a) that Application Serial No. 88557391 be rejected in its entirety based upon a likelihood of confusion; (b) that no registration be issued thereon to Applicant; and (c) that this opposition be sustained in favor of Opposer.
