Opposers Guess? IP Holder L.P., a Delaware limited partnership, and Guess?, Inc., a Delaware corporation, whose address is 1444 South Alameda Street, Los Angeles, California 90021, believe that they will be damaged by registration of the mark GUESS shown in application Serial No. 88/657,335 in International Classes 5 and 32 and hereby oppose its registration.

As grounds for opposition, Opposers allege that:

1. Opposers, through their predecessors and related companies (hereinafter collectively "Opposers"), have been and are now engaged in the marketing, manufacture, distribution and sale of a wide variety of consumer products, including beverages. Opposers

have engaged in traditional and e-commerce marketing and Opposers are highly active in marketing via social media.

- 2. Since prior to Applicant's priority date, Opposers have continuously and extensively used in commerce the trade name and mark GUESS, alone and in combination with other terms and designs (hereinafter the "GUESS Trade Name and Marks"), in connection with the marketing, manufacture, distribution and sale of a variety of consumer products and services including apparel, jewelry, watches, leather goods, eyewear, fragrances, stationery, bags, beverages, retail store services and e-commerce. Attached hereto as Exhibit A is a photo of an exemplary bottle of GUESS brand water. Since prior to Applicant's priority date, Opposers have provided food and beverages at promotional events for the GUESS brand. Attached as Exhibit B is promotional material disseminated for such an event at Opposers' headquarters. Since prior to Applicant's priority date, Opposers have continuously used the GUESS Trade Name and Marks in connection with marketing in print and electronic media including social media, for the promotion and sale of a broad range of consumer products and services.
- 3. Opposer Guess? IP Holder L.P. is the owner of U.S. Registration No. 2308468, issued January 18, 2000 on the Principal Register of the mark GUESS? for goods and services in Classes 9, 14, 16, 18, 25, 26 and Class 35. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 1, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.
- 4. Opposer Guess? IP Holder L.P. is the owner of U.S. Registration No. 2370424, issued July 25, 2000 on the Principal Register of the mark GUESS for services in Class 35. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 2, and made of record herein, is a current

printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

- 5. Opposer Guess? IP Holder L.P. is the owner of U.S. Registration No. 2333738, issued March 21, 2000 on the Principal Register of the mark GUESS? and Design for services in Class 42. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 3, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.
- 6. Opposer Guess? IP Holder L.P. is the owner of U.S. Registration No. 1433022, issued March 17, 1987 on the Principal Register of the mark GUESS for goods in Class 25. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 4, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.
- 7. Opposer Guess? IP Holder L.P. is the owner of U.S. Registration No. 2077475, issued July 8, 1997 on the Principal Register of the mark GUESS for goods in Class 14. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 5, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.
- 8. Opposer Guess? IP Holder L.P. is the owner of U.S. Registration No. 1704002, issued July 28, 1992 on the Principal Register of the mark GUESS for goods in Classes 3 and 9. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 6, and made of record herein, is a

current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.

- 9. Opposer Guess? IP Holder L.P. is the owner of U.S. Registration No. 4210798, issued September 18, 2012 on the Principal Register of the mark GUESS for goods in Class 9, including decorative and protective covers and cases for portable electronic devices such as cell phones, mobile phones, and computers. Said registration is valid and subsisting and has become incontestable under the provisions of Section 15 of the Trademark Act. Attached hereto as Exhibit 7, and made of record herein, is a current printout of information from the electronic database records of the United States Patent and Trademark Office showing the current status and title of the registration.
- 10. Through the widespread use and advertising of their GUESS Trade Name and Marks over a long period of time and by virtue of the quality of goods distributed and sold and services rendered in connection with the GUESS Trade Name and Marks, Opposers have built up a valuable goodwill and reputation in connection with the GUESS Trade Name and Marks, which would be jeopardized by Applicant's use and registration of the mark GUESS.
- 11. Applicant's goods for which it seeks to register the mark GUESS are related to the goods and services distributed, sold and rendered by Opposers under the GUESS Trade Name and Marks.
- 12. Applicant's mark GUESS so resembles Opposers' GUESS Trade Name and Marks, previously used in commerce and/or registered by Opposers and not abandoned, as to be likely, when applied to the goods of Applicant, to cause confusion or to cause mistake or to deceive.

- 13. Opposers re-allege and incorporate by reference paragraphs 1 through 12, inclusive.
- 14. Opposers have extensively used and marketed the GUESS Trade Name and Marks, and as a result, the GUESS Trade Name and Marks have achieved extensive recognition and are famous in the United States.
- 15. Applicant has averred an intent to use the mark GUESS in connection with certain goods in the United States. Applicant's use of the mark GUESS for such goods would create a likelihood of dilution by blurring and dilution by tarnishment thereby impairing the distinctiveness of Opposers' famous GUESS Trade Name and Marks, and causing irreparable injury and damage to Opposers.
- 16. If Applicant's application is allowed to proceed to registration, dilution, damage, and/or other injury to Opposers will occur.

WHEREFORE, Opposers pray that this opposition be sustained and that registration of Application Serial No. 88/657,335 be refused.


