**NOTICE OF OPPOSITION**

Opposer, TOCA Football, Inc., a Delaware corporation having a place of business at 2777 Bristol Street, Suite D, Costa Mesa, California 92626 (hereinafter “Opposer”) believes that it will be damaged by registration of the ADMETAR & Design mark shown in U.S. Application Serial No. 88/501,220 (the “Application”), filed by Meta M. Wong, an individual with a business address of 1347 McKinley Ct, San Jose, California 95126 (“Applicant”) and hereby partially opposes the same. As grounds for the Opposition, it is alleged that:

1. Opposer is in the business of providing sports training apparatus and sports training services, and has been providing those goods and services for many years—since at least as early as January 31, 2013—using the following design mark (the “TOCA Design Mark”):



2. For many years and since at least as early as January 31, 2013, Opposer adopted and has used the TOCA Design Mark on and in connection with its goods and services, and Opposer has drawn upon the goodwill and public recognition of its TOCA Design Mark by adopting and using this mark to signify its high quality goods and services.

3. Opposer's TOCA Design Mark has been conspicuously applied to and used in conjunction with Opposer's goods and services, and said goods and services so marked and services so designated have been extensively distributed, advertised, promoted and sold in interstate commerce in the United States.

4. Opposer has widely and extensively advertised and promoted its goods and services under the TOCA Design Mark, such that the public and trade recognize that these products and services emanate from one source, *i.e.*, TOCA Football, Inc.

5. By virtue of Opposer's extensive advertising, promotion, and sales of its goods and services under its TOCA Design Mark, the public and trade have come to rely upon Opposer's TOCA Design Mark to identify Opposer's superior products and services and to distinguish them from the products and services of others. The TOCA Design Mark has come to represent an extremely valuable goodwill belonging exclusively to Opposer.

#### **Opposer's Trademark Registrations and Applications**

6. Opposer is the owner of two federal registrations—Reg. Nos. 4,695,150 and 4,805,199 (the "TOCA Design Registrations")—for the TOCA Design Mark. Opposer's Registration No. 4,695,150 is for "Sports training apparatus, namely, soccer ball delivery machines; soccer balls" in International Class 28, and Opposer's Registration No. 4,805,199 is for "Sports training services" in International Class 41.

7. Opposer is also the owner of an application—Serial No. 87/330,928—for "Sports training apparatus, namely, devices for measuring player performance in the nature of wearable and non-wearable multifunctional electronic devices and sensors for monitoring, capturing, displaying, correlating, manipulating, measuring, transmitting and uploading information, including player performance, agility, speed, movement, accuracy, direction, time, biometric data, and distance and for monitoring related patterns and statistics, to electronic devices and the Internet" in International Class 9.

8. Opposer is also the owner of another application—Serial No. 88/051,099—for "Entertainment services, namely, provision of indoor facilities in which consumers can

participate in real and/or simulated environments for recreational, leisure, or entertainment or educational purposes; Provision of entertainment services in the nature of interactive, immersive and virtual reality events, exhibits and experiences; Conducting workshops and seminars in the field of soccer; Entertainment in the nature of soccer tournaments; Providing soccer facilities; Rental of soccer equipment, except vehicles; Entertainment services, namely, arranging and conducting of soccer competitions; Arranging, organizing, conducting, and hosting social entertainment events” in International Class 41.

9. The registrations for Opposer’s TOCA Design Mark are valid and subsisting, and are owned by Opposer together with the business and goodwill connected therewith. A copy of the TSDR records for the TOCA Design Registrations showing the current status and title is attached hereto as Exhibit A.

#### **Applicant’s Trademark Application**

10. Applicant seeks registration of the following design mark (“Applicant’s Mark”) on the basis of an application filed on July 4, 2019 (“Applicant’s Filing Date”), pursuant to Section 1(b) of the Lanham Act:



11. As published on November 12, 2019, the Application covers in part: “Sports training apparatus in the nature of an attachable tethered ball for use in soccer training” in International Class 28. Notably, these goods and services encompass goods and services that are identical to Opposer’s goods and services in Class 28, and potentially related or identical to Opposer’s goods and services in Class 9 and Class 41.

12. Opposer has been using its TOCA Design Mark in connection with its goods and services since before Applicant’s Filing Date.

13. Opposer’s TOCA Design Mark is visually similar to Applicant’s Mark.

14. Applicant’s Mark is confusingly similar in commercial impression to Opposer’s TOCA Design Mark.

15. The identifications of goods and services in the TOCA Design Registrations in Exhibit A place no restrictions on the type of consumer to whom the goods and services are sold or provided, or intended to be sold or provided.

16. The identification of goods in the Application places no restrictions on the type of consumers to whom the goods are intended to be sold.

17. The identifications of goods and services in the TOCA Design Registrations in Exhibit A place no restrictions on the channels of trade through which the goods and services are sold or provided, or intended to be sold or provided.

18. The Application places no restrictions on the channels of trade through which the identified goods are sold.

19. Upon information and belief, Applicant markets Applicant's goods to the same consumers of Opposer's goods and services.

20. Upon information and belief, Applicant's goods travel in the same channels of trade as Opposer's goods and services.

21. Applicant's goods are highly related, if not identical, to the goods and services Opposer offers under its TOCA Design Mark.

**CLAIM FOR RELIEF**  
**Likelihood of Confusion**  
**Section 2(d) of The Lanham Act; 15 U.S.C. §1052(d)**

22. Opposer hereby incorporates the foregoing paragraphs as if fully set forth herein.

23. Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d), prohibits registration on the principal register of a mark that consists of or comprises a mark which so resembles a mark previously used in the United States by another and not abandoned, as to be likely, when used on or in connection with the goods and services of the applicant, to cause confusion, or to cause mistake, or to deceive.

24. The goods identified above in the Application are closely related and/or complementary to the goods and services offered under Opposer's TOCA Design Mark.



25. Applicant's Mark so resembles Opposer's TOCA Design Mark, as to be likely, when used in connection with Applicant's goods, to cause confusion, to cause mistake, or to deceive.

26. With many years of prior use of Opposer's TOCA Design Mark, Opposer is entitled to the exclusive use of its marks in connection with those goods and services.

27. The Trademark Trial and Appeal Board has authority under 15 U.S.C. § 1068 to refuse to register the Application.

WHEREFORE, Opposer believes and avers that it will be damaged by registration of the Application and prays that the Application be rejected in part, that no registration be issued to Applicant for services in International Class 28, and that this Opposition be sustained in favor of Opposer.
