PHE, Inc., a corporation of the State of North Carolina, with a principal place of business in Hillsborough, North Carolina, and business address at 302 Meadowlands Drive, Hillsborough, North Carolina, believes that it will be damaged by registration of the mark shown in the above-identified application (hereinafter referred to as "Applicant's Application"), and hereby opposes same.

Opposer brings its claims pursuant to Trademark Act Section 2(d), 15 U.S.C. § 1052(d) and Trademark Act Section 2(a), 15 U.S.C. § 1052(a). The grounds for opposition are more particularly set out as follows. Headings are interposed for convenience; all allegations are deemed incorporated into each ground for opposition, as though realleged for each.

GENERAL ALLEGATIONS

- Opposer is a world-renowned leader in the field of human sexuality and sexual health, both within the United States and internationally, and is known to the general public by its famous mark ADAM & EVE. As a part of its overall trademark strategy and family of marks, Opposer has rights in numerous ADAM & EVE and ADAM marks. Opposer not only uses its marks itself, but also operates a very active licensing and franchise program throughout the United States and elsewhere.
- 2. Opposer, directly and through its licensees and franchisees, uses not only its marks ADAM & EVE and ADAM, but also formatives and variants thereof that evoke recollection of its ADAM & EVE and

ADAM brands, and of their owner, including the mark ADAM'S and other variants that alter the ADAM & EVE ampersand to an "and" or eliminate it, translate one of these brands, or add or omit design elements and words.

- 3. Opposer is, as a result, the owner of many marks consisting of the term ADAM & EVE and/or consisting in whole or substantial part of one or more of the terms ADAM and EVE in English or their foreign equivalents. The marks ADAM & EVE, ADAM, and ADAM'S, together with those additional marks, all of which are more specifically identified below, are collectively referred to hereafter as "Opposer's Marks."
- 4. Since its founding as the first mail-order contraceptive business in the United States almost three decades ago, Opposer has become the nation's largest provider of adult entertainment products and, operating under Opposer's Marks, has served well over ten million customers. Opposer also provides, under Opposer's Marks, one of the largest sexual education centers online, with articles and videos about sex toys, dating and relationships, sexual health, and more. And, under Opposer's Marks, Opposer funds nonprofit organizations, including those working to provide family planning and sexual health services worldwide.
- 5. Opposer's Marks include each mark set out in the table below, which lists some of the United States Trademark Registrations and applications owned by Opposer covering marks that include the term ADAM & EVE or ADAM, or a variant or formative thereof that reminds viewers and customers of Opposer and its marks ADAM & EVE or ADAM, and reinforces the link between Opposer's Marks and Opposer. Each of the registrations listed below was lawfully issued, is valid and subsisting, and establishes Opposer's exclusive right to use the registered mark in commerce in accordance with the registration. Copies of the electronic records provided by the United States Trademark Office for each

registration are attached hereto as Exhibits 1 through 18 and are incorporated herein by reference and for purpose of reliance.

- 6. Opposer's Marks also include the common law marks listed on Exhibit 18 attached hereto and, to the extent not already fully set out in the foregoing table and in the referenced exhibit of common law marks, the registrations and common law marks listed in the ESTTA Cover Sheet for the filing of the Notice of Opposition, all of which have priority over the applied-for mark and are incorporated herein by reference.
- 7. Opposer's Marks are used in a wide variety of fonts and colors, and are not in general limited by appearance, although appearance is an additional feature of certain marks.
- 8. Use of ADAM & EVE by Opposer commenced at least as early as 1971 and has continued both in interstate and foreign commerce continuously since that time. Use of Opposer's Marks in general commenced with adoption of ADAM & EVE, and has continued and increased in both the number of marks and the ways in which they have been used since that time. Use of ADAMMALE, for example, commenced at least as early as 1997 and has continued since that time. All of Opposer's Marks have been used in interstate and foreign commerce, both directly and through licensed affiliates and franchisees of Opposer, continuously since their adoption.
- 9. Opposer has priority over Applicant with respect to each of Opposer's Marks asserted in this Opposition, for all of the uses identified therewith. Opposer's priority significantly precedes the filing date of Applicant's Application and any other priority date to which Applicant might be entitled, whether based on use or otherwise. Opposer's priority extends to and includes priority as to the goods referenced in Paragraph 9 below.

- 10. Opposer's Marks are used in connection with, among other things, supplements and products for sexual improvements and performance enhancement.
- 11. Opposer's Marks and the goods and services provided by Opposer under Opposer's Marks are viewed by literally millions of adult Americans every year.
- 12. Applicant seeks to register a mark whose prominent term is identical to Opposer's Marks and that connotes a connection to ADAM & EVE, and Applicant's mark overall is likely to confused with Opposer's Marks.
- 13. Applicant has not asserted any earlier priority than the filing date of its application, July 26, 2019, with respect to any of the goods identified in its application.
- 14. Applicant has not incorporated in its application any restrictions as to the appearance of the mark sought to be registered, nor restrictions as to the manner in which goods marketed under the mark would be advertised and offered for sale, or the channels through which the goods would be sold.

PRIORITY AND LIKELIHOOD OF CONFUSION TRADEMARK ACT SECTION 2(d), 15 U.S.C. § 1052(d)

- 15. Applicant seeks registration of the mark ADAM'S POWER, without further limitations, pursuant to Section 1(b) of the Trademark Act (15 U.S.C. §1051(b)) for use in connection with "herbal supplements for sexual improvements" in International Class 005.
- 16. The prominent term in Applicant's mark, ADAM'S, is identical to Opposer's mark ADAM'S, and Applicant's mark overall is substantially similar to Opposer's Marks.
- 17. Applicant's use of the word "POWER" in the applied-for mark does not add distinctiveness sufficient to distinguish the mark from Opposer's ADAM & EVE mark and Opposer's marks in general. The term "POWER" as applied to Applicant's goods is descriptive and is frequently used to describe male sexual

enhancement products of the type identified in Applicant's Application, as well as those offered for sale through Opposer's retail outlets operated under and in connection with Opposer's Marks.

- 18. Opposer, directly and through licensees, has used Opposer's Marks in commerce on or in connection with goods that are identical and/or similar to those identified by Applicant, including but not limited to supplements for sexual improvement.
- 19. Use of Opposer's Marks in commerce for such substantially similar and closely associated goods, including those set out in the exhibits hereto, together with closely associated goods and services, precedes any priority date that Applicant can claim, and is continuing.
- 20. By reason of its longstanding use of Opposer's Marks, which commenced well prior to the date of Applicant's Application and any date of use on which Applicant is entitled to rely, and by reason of its pleaded registrations, Opposer has priority with respect to use of Opposer's Marks over Applicant and over Applicant's use and intended use of the applied-for mark as set out in the Application.
- 21. If registered as currently proposed, Applicant would be entitled to use and advertise the mark sought to be registered in ways that would emphasize the similarities and connections to Opposer and Opposer's Marks and that would de-emphasize any distinctions.
- 22. Moreover, Applicant's goods presumptively could be identified as "licensed" or "franchised" (without specification as to the licensor or franchisor) and presented in commerce to the hundreds of thousands of persons who directly interact every year with Opposer and its channels of trade, including Opposer's franchisees. The mark sought to be registered, used in connection with goods identical to goods provided under Opposer's Marks, presumptively would be targeted at, and marketed through channels of commerce directed to, Opposer's customers. It must be presumed that the market and the channels of trade through which Applicant will offer its goods in connection with the mark sought to be

registered are identical and closely related to those that are currently used by Opposer and that have been used by Opposer since long prior to any priority date to which Applicant might be entitled.

23. Applicant's mark, used as identified in Applicant's Application, is likely to cause confusion and mistake with respect to Opposer's Marks and their use by Opposer.

FALSE SUGGESTION OF A CONNECTION TRADEMARK ACT SECTION 2(a), 15 U.S.C. § 1052(a)

- 24. As hereinabove set out, Applicant's mark is substantially similar to Opposer's acclaimed mark ADAM & EVE, merely appending thereto the term "POWER" and Applicant's mark is a close approximation of Opposer's Marks, in general, containing the term ADAM.
- 25. Opposer's mark ADAM & EVE functions not only as a trademark and service mark, but also as a house mark of Opposer, is recognized as such by consumers, and has been so recognized since long prior to the earliest priority date on which Applicant can rely.
- 26. Opposer's Mark ADAM & EVE serves to identify and as an identity of Opposer, such identification beginning long prior to the filing date of Applicant's Application, prior to any first date of use of Applicant's mark that Applicant is entitled to assert, and prior to any other relevant priority date to which Applicant might be entitled with respect to the mark for which registration is sought, and continuing to the present time.
- 27. Opposer's provision and promotion of its services and products to the public under Opposer's Marks for 49 years has caused the public to associate those marks (including Opposer's mark ADAM & EVE) and the goods and services provided thereunder with Opposer, such association beginning long prior to the filing date of Applicant's Application, prior to any first date of use of Applicant's mark that Applicant is entitled to assert, and prior to any other relevant priority date to which Applicant might be entitled with respect to the mark for which registration is sought, and continuing to the present time.

Through those efforts, Opposer now has built substantial goodwill in Opposer's Marks, including its ADAM & EVE mark, which inures to the benefit of Opposer.

- 28. Opposer uses Opposer's Marks, including its ADAM & EVE mark, as aforestated and as set out in the exhibits, and in particular for goods that are identical to or substantially similar to those for which Applicant seeks registration, as well as for closely associated goods. Use of Opposer's Marks, including its ADAM & EVE mark, in commerce for such substantially similar and closely associated goods long precedes any priority date that Applicant can claim, and is continuing.
- 29. Opposer's renowned and excellent reputation and the close and long-time association of Opposer's Marks, including its ADAM & EVE mark, with Opposer are such that a connection with Opposer and Opposer's goods and services is likely to be presumed when the mark Applicant seeks to register is used in connection with the goods identified in the application.
- 30. The presumption of a connection is particularly likely and is enhanced because Applicant seeks to register and use its mark in a substantially unrestricted manner, presumptively in the same channels of trade, presumptively targeted to the same markets, and presumptively colored and otherwise configured and advertised to create a mistaken belief as to the affiliation of Applicant's mark with Opposer and Opposer's goods and services offered under Opposer's Marks, including its famous mark ADAM & EVE.
- 31. Consumers seeking to obtain goods identified with Opposer are familiar with Opposer's Marks, including its ADAM & EVE mark, know that the ADAM portion of the mark is used in connection with Opposer's goods and services for males, associate those marks with Opposer, know that third parties are licensed to use Opposer's Marks, assume that products bearing Opposer's Marks are duly authorized for sale by Opposer or otherwise connected with Opposer, and rely on their presumption

that a connection exists between Opposer and its licensees and other sources of goods and services branded with Opposer's Marks, to inform their purchasing decisions.

- 32. Applicant's mark, as sought to be registered, would lead consumers to draw false conclusions as to a connection of Applicant's mark with Opposer and with Opposer's goods and services, under circumstances where such a conclusion will be material to the consumer's deliberations regarding the purchase of the goods.
- 33. As alleged above, despite Applicant's claim of right to use the "ADAM'S POWER" mark it seeks to register, in connection with goods identical to goods offered by Opposer, Applicant is not affiliated with, licensed by, or otherwise associated with Opposer. Opposer is not connected with the goods that Applicant provides, offers, or intends to offer under the mark sought to be registered.
- 34. Nonetheless, Opposer's name, house mark, trademark, and service mark ADAM & EVE, and Opposer's Marks, are of sufficient fame or reputation that when Applicant's mark is used on or in connection with the goods identified in Applicant's Application, a connection with Opposer would be presumed and Applicant's mark would be recognized as connected with Opposer, uniquely and unmistakably pointing to Opposer.
- 35. Consumers are likely to be deceived as to the connection, which does not in fact exist, and to make purchasing decisions based on the false suggestion of a connection created by Applicant and its mark.
- 36. Registration and/or use of Applicant's mark as sought in Applicant's Application is likely to interfere with Opposer's use and exploitation of Opposer's Marks, including its ADAM & EVE mark, and to falsely suggest a connection with Opposer.

CONCLUSION

37. In view of the foregoing and the similarity of Opposer's prior-used and not abandoned Opposer's Marks to Applicant's applied-for mark, the similarities between the use made by Opposer and its

licensees of Opposer's Marks and the potential use of Applicant's mark by Applicant as identified in Applicant's Application and shown through Applicant's potential channels of commerce, it is alleged that Applicant's mark as currently applied for, identified and described, so resembles Opposer's marks as to be likely to cause confusion and to cause mistake. Moreover, registration and/or use of Applicant's mark as sought in Applicant's Application is likely to interfere with Opposer's use and exploitation of Opposer's Marks, to deceptively and falsely suggest a connection with Opposer.

WHEREFORE, Opposer requests that Applicant's Application be denied.




