**NOTICE OF OPPOSITION**

Pursuant to 15 U.S.C. § 1063(a) and 37 C.F.R. § 2.101, Eveden Inc., a corporation organized and existing under the laws of Massachusetts located and doing business at 65 Sprague Street, Boston, Massachusetts 02136 (“**Opposer**”), by its undersigned counsel, respectfully submits the following Notice of Opposition. Opposer believes that it is being, and will continue to be, damaged by the registration of the mark shown in U.S. Application No. 88/574,103 in International Class 25, filed on August 10, 2019 by Alanna Zabel, an individual, having an address of 1528 16<sup>th</sup> St. Suite A, Santa Monica, California 90404 (“**Applicant**”) and published for opposition on December 31, 2019. Upon information and belief, the Applicant’s email

address is believed to be alanna@aziam.com. Opposer hereby opposes the same and requests that registration to Applicant be refused.

On January 29, 2020, Opposer filed a 30-Day Request for an Extension of Time to Oppose. This 30-Day Request for an Extension of Time to Oppose was granted on January 29, 2020, with an opposition deadline of February 29, 2020. On February 28, 2020, Opposer then filed a 60-Day Request for an Extension of Time to Oppose for Good Cause. This 60-Day Request for an Extension of Time to Oppose for Good Cause was granted on February 28, 2020 with an opposition deadline of April 29, 2020. Therefore, the present Notice of Opposition is timely filed.

Opposer now files its Notice of Opposition on the following grounds:

1. Upon information and belief, Applicant is an individual, having an address of 1528 16<sup>th</sup> St. Suite A, Santa Monica, California 90404.
2. Upon information and belief, Applicant is the owner of U.S. Trademark Application No. 88/574,103, filed on August 10, 2019, in International Class 25, in connection with “Headbands; Jackets; Leggings; Pants; Shirts; Sweat shirts; Lounge pants; Sweat pants; Tank tops”.
3. Upon information and belief, Applicant is seeking to register the mark MODERN GODDESS (“**Applicant’s Mark**”), in International Class 25, for the goods “Headbands; Jackets; Leggings; Pants; Shirts; Sweat shirts; Lounge pants; Sweat pants; Tank tops”.
4. Upon information and belief, Applicant’s Application Number is 88/574,103 (the “**103 Application**”).

5. Upon information and belief, the ‘103 Application was filed on August 10, 2019, based upon an alleged *bona fide* use in U.S. commerce under Trademark Act Section 1(a); 15 U.S.C. Section 1051(a).

6. Upon information and belief, the Applicant alleges its date of first use anywhere of its alleged mark is October 2, 1999.

7. Upon information and belief, the Applicant alleges its date of first use in U.S. commerce of its alleged mark is July 20, 2001.

8. Upon information and belief, Applicant’s ‘103 Application was published for opposition on December 31, 2019.

9. Opposer is a corporation organized and existing under the laws of Massachusetts located and doing business at 65 Sprague Street, Boston, Massachusetts 02136.

10. Opposer is the owner of valid and subsisting U.S. trademark Registration No. 0,816,641 (“the ‘**641 Registration**”), registered on October 11, 1966 on the Principal Register for the mark GODDESS (“**Opposer’s Mark**”) in International Class 25 as used in association with the following goods: “brassieres, corsets, corselets, girdles, and bra slips.”

11. Opposer is the owner of valid and subsisting U.S. trademark Registration No. 5,179,490 (“the ‘**490 Registration**”), registered on April 11, 2017 on the Principal Register for the mark GODDESS (“**Opposer’s Mark**”) in International Class 25 as used in association with the following goods: “Clothing, namely, ladies underwear, lingerie, corsets, brassieres, bras, sports bras, maternity bras, knickers.”

12. Both of Opposer’s ‘641 Registration and ‘490 Registration are conclusive evidence of the validity of the registrations, of Opposer’s ownership thereof, and of Opposer’s exclusive right to use the registered mark in commerce in connection with the goods specified in

the respective registrations. Pursuant to Rule 2.122(d), Opposer attaches hereto, as **Exhibit A** and **Exhibit B**, printouts from the Trademark Status and Document Retrieval (TSDR) electronic database showing the current status and title of each of the said registrations.

13. Opposer's '641 Registration was granted incontestable status under Section 15 of the Trademark Act. Said trademark and registration therefor are valid and subsisting, and Opposer owns the GODDESS trademark, the registrations, and the goodwill of the business associated with such mark.

14. Opposer, through its parent company, predecessors-in-interest and affiliates, is now and has been involved in the business of, *inter alia*, designing, manufacturing and providing high quality clothing products, including, but not limited to, ladies' underwear, brassieres, corsets, corselets, girdles, bra slips, lingerie, bras, sports bras, maternity bras, and knickers.

15. Opposer has become widely known nationally and worldwide as a provider of its clothing products, including, but not limited to, ladies' underwear, brassieres, corsets, corselets, girdles, bra slips, lingerie, bras, sports bras, maternity bras, and knickers.

16. Opposer and/or its parent company, predecessors-in-interest and/or affiliates have extensively promoted and sold Opposer's goods in connection with its GODDESS mark in the United States.

17. By reason of such advertising, promotion and sale of Opposer's goods under the GODDESS mark, Opposer has developed substantial goodwill in connection with the GODDESS mark.

18. Opposer has acquired a favorable reputation throughout large segments of the relevant industry for its goods sold and provided under, and in association with its trademarks, including, but not limited to, GODDESS, and any other goods and/or services related thereto.

19. From a date long prior to Applicant's filing date of its '103 application, specifically since at least as early as December 1, 1945, Opposer has used its mark GODDESS in connection with clothing goods, including but not necessarily limited to, ladies' underwear, brassieres, corsets, corselets, girdles, bra slips, lingerie, bras, sports bras, maternity bras, and knickers.

20. From a date long prior to Applicant's alleged date of first use anywhere, namely, October 2, 1999, specifically since at least as early as December 1, 1945, Opposer has used its mark GODDESS in connection with clothing goods, including but not necessarily limited to, ladies' underwear, brassieres, corsets, corselets, girdles, bra slips, lingerie, bras, sports bras, maternity bras, and knickers.

21. From a date long prior to Applicant's alleged date of first use in commerce, namely, July 20, 2001, specifically since at least as early as December 1, 1945, Opposer has used its mark GODDESS in connection with clothing goods, including but not necessarily limited to, ladies' underwear, brassieres, corsets, corselets, girdles, bra slips, lingerie, bras, sports bras, maternity bras, and knickers.

22. The goods set forth in Applicant's '103 Application are identical to and/or closely related to the goods in connection with which Opposer has used and is using its mark GODDESS. In addition, upon information and belief, Applicant's goods are offered to the same class of customers who purchase Opposer's goods offered under its mark GODDESS.

23. The applied-for mark in Applicant's '103 Application is substantially similar to Opposer's Mark GODDESS, and is likely to cause confusion, mistake and deception as to the source of Applicant's goods, all to Opposer's damage and in violation of 15 U.S.C. Section 1052(d). Consumers are likely to believe that Applicant's goods offered in connection with the

mark that is the subject of Applicant's '103 Application emanate from, or are licensed by, approved by, or otherwise associated with Opposer, when they are not. Any dissatisfaction with Applicant's goods will adversely reflect upon and irreparably damage Opposer's reputation and goodwill as embodied in its mark GODDESS.

24. Applicant's Mark is confusingly similar in appearance, sound, connotation and commercial impression to Opposer's registered trademarks.

25. Applicant's filing of the '103 Application was without license, authorization or permission of Opposer.

26. By reason of the foregoing, Applicant's registration of the mark herein opposed would cause significant damage and injury to Opposer, to Opposer's rights in its marks, and to the use thereof as described herein

27. Accordingly, registration of Applicant's Mark would damage Opposer, and registration. Therefore, Applicant's Mark should be refused pursuant to Section 2(d) of the Trademark Act.

### **CONCLUSION**

28. If Applicant is granted the registration herein opposed, Applicant would thereby obtain a *prima facie* exclusive right to use the applied-for mark, which would be a further source of damage to Opposer.

29. By reason of the foregoing, Opposer will be damaged by the registration of the mark MODERN GODDESS to the Applicant.

**WHEREFORE**, Opposer believes that it will be damaged by registration of the mark which is the subject of the U.S. Trademark Application No. 88/574,103, and therefore, respectfully requests that such registration be refused.
