Amendment of the identification is proper under 37 CFR § 2.133(a) as Opposer, through her attorneys, consented to the requested amendment. In addition, the requested amendment only limits the services covered under the mark and does not expand the identification. See TMEP §1609.03.

Contingent upon the acceptance of the above amendment and with the consent of Applicant, Opposer withdraws Opposition No. 91255424, without prejudice.
