NOTICE OF OPPOSITION

Opposer Stone Brewing Co., LLC (“Opposer” or “Stone”), a California limited liability company with a business address of 1999 Citracado Parkway, Escondido, California, believes it will be damaged by registration of the mark shown in Application Serial No. 88715937 (the “Application”) and hereby opposes the Application.

As grounds for the opposition, Opposer alleges that:

1. Stone is a pioneering craft brewery with a business address of 1999 Citracado Parkway, Escondido, California. Stone is a duly registered limited liability company organized under California law. Before 2016, Stone was organized as a California corporation named Koochenvagner’s Brewing Co., d/b/a Stone Brewing Co. Stone is the registered owner of the incontestable trademark registrations for STONE (U.S. Reg. No. 2168093) and STONE BREWING CO. NORTH COUNTY SAN DIEGO (U.S. Reg. No. 2393034), as well as the U.S.

registrations identified in Exhibit A (collectively, the “**STONE Marks**”) (see also Exhibits B through I attached).

2. Since 1996, the STONE mark has represented a promise to beer lovers that each STONE-branded beer reflects the company’s devotion to craft and quality. Consumers associate the STONE Marks with Stone’s pioneering craft brews, brewery experiences, and restaurants. Today, the STONE Marks are one of the most recognizable and popular craft beer brands in the U.S. and the global standard bearer for independent craft beer, with sales in all fifty U.S. States and across five continents. The STONE Marks are one of the most valuable brands in beer, reflecting Stone’s substantial investment in crafting high quality brews under the STONE name. Stone brings this Opposition to prevent Applicant from unfairly capitalizing on the distinctiveness and fame of the STONE Marks and brand.

FACTUAL BACKGROUND

A. Foundations of STONE®

3. Before it grew into an internationally recognized craft beer brand, Stone had its origins in the creative fermentation of California in the 1980s and ‘90s. Founders Steve Wagner and Greg Koch first crossed paths in the effervescent Los Angeles rock-and-roll music scene of the 1980s. Years later, they raised a glass at brewing mecca U.C. Davis in Northern California, where both had enrolled to channel their creative energies into brewing. In a series of conversations, the future founders of Stone discovered that they shared a love of bold, interesting beers and a fiery obsession with being a part of the craft beer revolution.

4. After a few years commiserating on the bleak state of the American beer market, the pair decided to take matters into their own hands. Greg and Steve made plans to open a brewery

that would be defined by an unwavering commitment to quality and sustainability, holding true to the art of brewing bold, flavorful beers. Stone and the STONE Marks were born.

5. Over the course of the next four years, Stone signed a lease on a small warehouse that it turned into a brewery, went from kegging its beers to having two bottling lines, and released its most popular beer, STONE IPA. From Stone's earliest bottles to its first website and delivery trucks, the STONE Marks have signified Stone's rebel culture of creativity, quality, and independence.

6. From the start, Stone assiduously developed and maintained its trademark and brand. Every Stone beer proudly bears the STONE trademark, which has been registered with the U.S. Patent and Trademark Office since June 23, 1998 under U.S. Reg. No. 2168093.

7. In 2005, Stone opened up a new brewery in Escondido, California. Soon after the brewery opening, Stone launched the very first *Stone Brewing World Bistro & Garden*, which challenged "brewpub" conventions by serving, alongside STONE-branded beers, gourmet cuisine inspired by the Slow Food movement, with local, organic ingredients and a seasonal menu, and offerings of other beverages including a selection of wines.

8. Sprinting into the 2000s, Stone grew in size and reach, overflowing its first facility. Stone entered a new phase when it planned a custom-built brewhouse tailored to fit Stone's commitment to quality, sustainability, and craft.

9. The stage was set for a craft brewing revolution. Throughout the 2000s, Stone continued to win converts with its bold, unorthodox beers and artisan philosophy. Other brewers joined the fray, transforming the tastes of millions of beer drinkers who had not known what they

were missing. In droves, Americans began turning away from incumbent beer brands in favor of craft beers with more compelling brands and flavors.

10. The strength of Stone's brand kept pace with its commercial success. On or about June 28, 2008, the USPTO accepted Stone Brewing's Combined Declaration of Use and Incontestability for STONE, rendering the mark incontestable as a matter of law.

11. From 2012 to 2013, Stone opened three company stores throughout Southern California—including locations in Oceanside and Pasadena.

12. In 2013, Stone opened a new *Stone Brewing World Bistro & Garden* at Liberty Station, in the heart of downtown San Diego.

13. That same year, Stone opened a 2,900 square-foot restaurant in the San Diego International Airport. This beer haven offers thirsty travelers a sampling of the STONE brews and farm-to-table fare.

14. In 2014, Stone opened Stone Tap Room just outside Petco Park, the home of the San Diego Padres.

15. In July 2016, Stone opened a brewery in Richmond, Virginia. Stone has plans to open an accompanying *Stone Brewing World Bistro & Garden* in the next year or so.

16. Every Stone Restaurant, Brewery and Taproom similarly bears the STONE Marks, offers a variety of STONE-branded beers, and serves wine for those less inclined to hops.

B. STONE® Today

17. Today, Stone is the ninth-largest independent craft brewer in the United States. Presiding over a rapid expansion of the craft brewing industry from 800 breweries in 1996 to more

than 5,000 today, Stone has maintained its commitment to true independent craft and sustainability.

18. STONE-branded beers are sold in thousands of stores, bars, and restaurants throughout the country, including at major grocery stores and retailers. Instantly recognized by the STONE name, the STONE Marks enjoy exceptional customer loyalty and engagement, with a devoted fan base unrivalled by other brewers. A sampling of popular STONE beers appears thus:

19. Stone and its products have been widely lauded by national and international press, as well as connoisseurs and critics. In 2010, Stone Brewing was named the “All-Time Top Brewery on Planet Earth” by Beer Advocate magazine. Numerous national and international publications have recognized STONE as an industry leader, including The New York Times, The Wall Street Journal, The Economist, USA Today, and Time magazine, to name a few.

20. Even as Stone has expanded its range of offerings with bold new flavors and numerous seasonal beers, the STONE Marks have remained constant, an unchanging identifier of STONE’s reputation for quality and commitment to its craft.

21. By virtue of these efforts, STONE is uniquely beloved among American and international beers, with a passionate and loyal following among consumers and critics alike. STONE enjoys exceptional consumer engagement ratings on social media, with scores nearly double the nearest craft brewer. Loyal customers have even been known to commission tattoos of STONE in homage—and then travel to the Escondido brewery to proudly show off their ink.

22. STONE's brand and commitment to producing innovative artisan beer have helped it defy the status quo and disrupt the American beer industry. In 2016, Stone produced more than 10.6 million gallons of beer for sale to customers in all fifty U.S. States. In 2017, STONE's U.S. sales exceeded \$70 million, placing it among the ten best-selling craft brewers in the country.

23. Stone also has taken its beer brewing passion abroad. STONE is now the first American craft brewer to independently build, own and operate a brewery in Europe—in the heartland of Germany where serious beer has been enjoyed for over a thousand years. Doing so has strengthened Stone's already diverse international fan base, who happily drink STONE beer throughout the European Union and China, plus Canada, Australia, Singapore, Taiwan, Puerto Rico, Panama and Brazil, among other nations. It is fair to say that the STONE Mark has become inherently distinctive and Stone the internationally recognized standard-bearer for American craft beer.

C. Applicant and its “STONE COLD JONES” Brand

24. Upon information and belief, Applicant Stone Cold Jones, LLC, is a Florida limited liability company with a business address of 175 SW 7th Street, Suite 2410, Miami, Florida.

25. Applicant filed Application No. 88715937 on December 5, 2019, for the mark STONE COLD JONES, with a combined Section 1(a) use in commerce and Section 1(b) intent-to-use in commerce filing basis, describing the goods and services as follows:

“Athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, athletic uniforms; Hooded pullovers; Pants; Sport shirts; Sports jackets; Sports pants; Sports shirts; Sweat shorts; Sweatshirts; Tank-tops; Tank tops; Tee shirts; Tee-shirts; Hats; Hooded sweatshirts; Sweat pants” in Class 025 (intent-to-use);

“Fruit beverages; Fruit-based beverages; Non-alcoholic beverages, namely, carbonated beverages; Soft drinks, namely, sodas; Sports drinks” in Class 032 (claimed first use and first use in commerce date of January 1, 2019); and

“Entertainment services, namely, live appearances by a sports celebrity; Entertainment services, namely, personal appearances by a sports celebrity” in Class 041 (intent-to-use).

26. The application was published for opposition on March 17, 2020.

CLAIMS FOR RELIEF

First Basis for Opposition

LIKELIHOOD OF CONFUSION – Lanham Act § 2(d)

27. Opposer incorporates by reference the facts and allegations set forth in each of the preceding paragraphs as though fully set forth herein.

28. On information and belief, Opposer’s application for a federally registered trademark on April 4, 1996, predates Applicant’s filing for STONE COLD JONES and constitutes constructive use of the STONE Marks, thereby conferring a right of nationwide priority. *See* Section 7(c) of the U.S. Trademark (Lanham) Act, 15 U.S.C. § 1057(c). Applicant failed to provide Opposer any constructive notice of any claimed use of its mark.

29. Opposer, has senior use of the mark across the entire United States.

30. The STONE COLD JONES mark is likely to be confused with Opposer's STONE Marks because it is confusingly similar in appearance, sound, and meaning to the STONE Marks, and conveys a confusingly similar commercial impression.

31. The claimed Class 032 goods identified in the Application are closely related to, and travel through the same channels of trade as the goods and services offered under Opposer's STONE Marks and use of Applicant's STONE COLD JONES mark in connection with its Class 032 goods would so nearly resemble Opposer's use as to be likely to cause confusion, mistake, and/or deception.

32. If Applicant is permitted to register the mark in the Application in connection with the claimed Class 032 goods, Opposer will be damaged because, among other reasons, confusion in the trade and in the public is likely to result, injuring Opposer's reputation in the trade and with the public. That confusion will also injure the public, in that consumers, upon seeing Applicant's mark used on and in connection with Applicant's goods, are likely to believe that Applicant's goods are somehow associated with or approved by Opposer.

Second Basis for Opposition

LIKELIHOOD OF DILUTION – Lanham Act § 43(c)

33. Opposer incorporates by reference the facts and allegations set forth in each of the preceding paragraphs as though fully set forth herein.

34. On information and belief, Applicant filed for its trademark after Opposer filed for its trademark.

35. Opposer's application date for the STONE Marks predates Applicant's filing date.

36. The STONE Marks are distinctive and famous in that they are widely recognized by the general consuming public as a designation of the source of Opposer's goods and were famous well before Applicant's December 5, 2019 application date.

37. If Applicant is permitted to register the mark in the Application in connection with the claimed Class 032 goods, Opposer will be damaged because, among other reasons, such registration and use is likely to impair the distinctive quality of Opposer's famous mark and brand and otherwise cause injury to Opposer's business reputation and brand.

PRAYER FOR RELIEF

WHEREFORE, Opposer requests that Application Serial No. 88715937 be rejected, that no registrations be issued to Applicant, and that this opposition be sustained in favor of Opposer.
