International Class 037:

The Applicant requests that the goods and services wording in the Application be amended to read:

International Class 012:

Automotive body kits comprising external structural parts of automobiles;  
Pre-designed vinyl vehicle wraps specially adapted for vehicles

International Class 037:

Car washing; Automobile cleaning and car washing

This requested amendment permissibly narrows the scope of the identification, eliminates confusion caused by a non-sequitur exclusion, and is made with the consent of the Opposer, as granted through its counsel, Julie Bergkamp.
