NOTICE OF OPPOSITION

Opposer The Men’s Wearhouse, Inc. (“Opposer”) believes it will be damaged by registration of the purported mark MARK’S WORK WEARHOUSE in whole as identified in Applicant’s Application Serial No. 88648121 (the “Subject Application”) and hereby opposes the same.

As grounds for this Opposition, it is alleged that:

1. Opposer The Men’s Wearhouse, Inc. is a Texas corporation with a place of business at 6380 Rogerdale Road, Houston, Texas 77072.
2. For more than forty years, Opposer and its predecessors-in-interest have been engaged in the manufacture, advertisement, promotion, and/or retail sale of a wide variety of men’s tailored and casual clothing, sportswear, footwear, and accessories, as well as the accompanying retail store services (the “Opposer’s Services”). Opposer promotes its business to customers through an expansive omni-channel network that includes MEN’S WEARHOUSE branded brick and mortar stores located throughout the United States, as well as a branded e-commerce website and social media pages, such as www.menswearhouse.com.

3. In addition to rights in common law based on longstanding use, Opposer owns the following federal trademark registrations, among others, for marks including the unique term WEARHOUSE (collectively, the “MEN’S WEARHOUSE Marks”):

4. Several of these registrations have become incontestable under Section 15 of the Lanham Act.

5. As a result of Opposer's longstanding use, extensive advertising, promotion and sales in connection with the MEN'S WEARHOUSE Marks, Opposer's MEN'S WEARHOUSE Marks have acquired fame and distinctiveness and have achieved a respected reputation and goodwill that is associated with Opposer by the consuming public. As such, Opposer's MEN'S WEARHOUSE Marks and the goodwill symbolized by those marks are of inestimable value to Opposer.

6. Upon information and belief, Applicant, Mark's Work Wearhouse Ltd. is a corporation formed under the laws of Canada, with a principal office at 1035 64th Avenue SE Calgary, Alberta, Canada T2H2J7

7. The Subject Application opposed herein was filed on October 9, 2019 on an intent-to-use basis, as well as based on a foreign registration. Applicant seeks to register the mark MARK'S WORK WEARHOUSE for "retail department store services" (collectively, the "Applicant's Services").

8. Applicant's Services and Opposer's Services, on information and belief, are identical, if not highly related; are offered or may be offered through the same or substantially the same, and/or related channels of trade, to the same, substantially the same, and/or related classes of purchasers; and are advertised, marketed and promoted through the same, and/or related media channels.

9. As a result of the public's association of the MEN'S WEARHOUSE Marks with Opposer, as well as Opposer's prior rights in the MEN'S WEARHOUSE Marks, Applicant's intended use and registration of the confusingly similar MARK'S WORK WEARHOUSE mark in connection with the Applicant's Services is likely to cause confusion, mistake or deception as to the source, origin or affiliation of Applicant's services, in that consumers are likely to be confused that Applicant's MARK'S WORK WEARHOUSE services originate from—or are affiliated with or sponsored by—Opposer, in view of the highly similar nature of the marks, the similarities of the services, and other factors.

10. If Applicant is permitted to register U.S. Trademark Application Serial No. 88648121 for MARK'S WORK WEARHOUSE despite this likelihood of confusion, Opposer's exclusive right to use the MEN'S WEARHOUSE Marks will be impaired, and Opposer will be damaged.

11. Opposer's MEN'S WEARHOUSE Marks are famous under 15 U.S.C. §1125(c) for Opposer's Services.

12. Opposer's MEN'S WEARHOUSE Marks became famous before Applicant's filing date of U.S. Trademark Application Serial No. 88648121 for MARK'S WORK WEARHOUSE.

13. Applicant's registration and intended use of MARK'S WORK WEARHOUSE will cause dilution by blurring of Opposer's famous MEN'S WEARHOUSE Marks under 15 U.S.C. §1125(c), and, as a result, Opposer will be damaged.

14. The relevant consumers of the Applicant's Services are likely to recognize that MEN'S WEARHOUSE points uniquely and unmistakably to Opposer,

given the long, widespread, and extensive use of Opposer's MEN'S WEARHOUSE Marks in connection with Opposer's Services.

15. When encountering the mark MARK'S WORK WEARHOUSE, consumers would presume a connection between Applicant and Opposer due to the high degree of similarity to Opposer's MEN'S WEARHOUSE Marks.

16. Opposer is not connected or affiliated with Applicant or Applicant's Services.

17. Applicant's MARK'S WORK WEARHOUSE mark falsely suggests a connection or affiliation with Opposer.

18. If Applicant is permitted to register U.S. Trademark Application Serial No. 88648121 for MARK'S WORK WEARHOUSE despite this false suggestion of a connection or affiliation with Opposer, Opposer will be damaged.

WHEREFORE, Opposer respectfully requests that registration of the mark applied for in Trademark Application Serial No. 88648121 be refused, and that this opposition be sustained in Opposer's favor.

Opposer requests such other and further relief as the Board may deem just and proper.
