WITHDRAW OPPOSITION NO. 91264230 WITHOUT PREJUDICE**

Pursuant to 37 C.F.R. § 2.133(a) and with Opposer Genesco Brands, LLC's consent, Applicant Fast IP, LLC respectfully requests that the identification of goods and services in the above-identified application be amended as follows:

International Class 25: Footwear, namely, athleisure shoes, sneakers, sandals, casual shoes, dress shoes, **all the foregoing incorporating hands-free footwear technologies.**

International Class 35: Marketing, advertising and promoting public awareness of technology relating to **hands-free** footwear.

The identification of goods in International Class 25 should now read as follows:

Footwear, namely, athleisure shoes, sneakers, sandals, casual shoes, dress shoes, all the foregoing incorporating hands-free footwear technologies.

The identification of services in International Class 35 should now read as follows:

Marketing, advertising and promoting public awareness of technology relating to hands-free footwear.

It is respectfully submitted that this amendment does not require republication because the amendments to the description of goods and services narrow, rather than broaden, the scope of the registration.
