NOTICE OF OPPOSITION

Opposer Flickr, Inc. (“Flickr”) believes that it will be damaged by registration of the mark FLICKSCAPE, and hereby opposes Application Serial No. 88/739,483 (“Application”) filed by Family Heritage LLC (“Applicant”) on December 26, 2019. As grounds for this opposition, Flickr alleges as follows:

I. PARTIES

1. Flickr is a corporation organized under the laws of the state of Delaware with a place of business at 67 East Evelyn Avenue, Suite 200, Mountain View, California 94041.
2. Upon information and belief, Applicant is a limited liability company organized under the laws of the state of Virginia with a place of business at 905 Poquoson Crossing, Chesapeake, Virginia 23320.

II. FLICKR AND ITS FLICKR MARKS

3. Flickr provides an online image hosting service and video hosting service created in 2004. As of August 2011, Flickr was hosting more than 6 billion images. As of March 2013, Flickr had a total of 87 million registered members and more than 3.5 million new images uploaded daily. As of May 2020, Flickr now has over 133 million registered users, averages over 2 million photo uploads per day, and hosts more than 29 billion photos and videos.

4. Since 2004, Flickr and/or its predecessors in interest have used the FLICKR mark in connection with interactive photo and video sharing services and software, which are available via desktop and tablet computers, and mobile platforms and applications. Among other features, Flickr’s service and software allow users to upload, post, display, store, organize, search, transmit, comment on, send messages relating to, and share their photos and videos with friends, family, and designated groups within the Flickr community, and/or the general public.

5. Flickr and/or its predecessors in interest have also used the FLICKR mark in connection with online blogging and information services in the field of photography since 2004.

6. In addition, since at least November 2007, Flickr and/or its predecessors in interest have also used the FLICKR mark in connection with services that allow users to manipulate, edit, and digitally enhance photos and videos that users upload to and store on the Flickr platform.

7. Additional information regarding Flickr’s software and services is available on its website at Flickr.com.

8. Flickr uses the FLICKR mark, and holds multiple registrations for the FLICKR mark and various stylizations thereof, in the U.S. and around the world in connection with its software and services.

9. In the U.S., Flickr owns the following incontestable registrations for the FLICKR mark:

Flickr’s aforesaid incontestable registrations for the FLICKR mark are valid and subsisting, unrevoked and uncanceled, and Flickr is the owner of the registrations and all of the goodwill represented thereby. Printouts from the USPTO’s Trademark Status and Document Retrieval system showing the current statuses of the aforementioned registrations are attached hereto as **Exhibit A**.

10. As a result of Flickr and its predecessors’ extensive use of, promotion of, and successes in connection with the FLICKR mark, the FLICKR mark has achieved widespread and substantial recognition and goodwill in association with the goods and services listed in the aforementioned registrations (Flickr’s Goods and Services). Moreover, the public and consumers in the relevant market have come to know the FLICKR mark as an indication of goods and services that originate from or are affiliated with Flickr and Flickr’s Goods and Services.

11. At no time has Flickr granted permission, written or otherwise, to Applicant to use or register any version or variation of the FLICKR mark, or any similar marks, for any purpose.

III. APPLICANT'S MARK AND APPLICATION

12. Applicant is the owner of record of the Application, which covers: “Telecommunications services, namely, electronic transmission of data, messages, graphics, images and information; peer-to-peer photo sharing services, namely, electronic transmission of digital photo files among internet users; providing access to computer, electronic and online databases; providing online forums for communication, namely, transmission on topics of general interest; providing online chat rooms and electronic bulletin boards for transmission of messages among users in the field of general interest; broadcasting services over computer or other communication networks, namely, uploading, posting, displaying, tagging, and electronically transmitting data, information, messages, graphics, and images; telecommunications services, namely, electronic transmission of photos and videos” in International Class 38 (“Applicant’s Services”).

13. Applicant filed the Application on December 26, 2019 on an intent to use basis.

14. The Application was published for opposition on April 28, 2020. Flickr timely filed requests for, and was granted, extensions of time to oppose the Application, extending the opposition deadline until August 26, 2020. This Notice of Opposition is therefore being timely filed pursuant to TBMP § 209.02 and 37 CFR § 2.196.

IV. PRIORITY

15. There is no issue as to priority. Flickr and/or its predecessors have continuously used the FLICKR mark, and the FLICKR mark has been distinctive, since well before the date that Applicant filed the Application, and upon information and belief, any other priority date upon which Applicant may rely.

16. Moreover, Flickr and/or its predecessors filed the applications to register the FLICKR mark, and the resulting registrations were issued, well before the filing date of the Application, and upon information and belief, any other priority date upon which Applicant may rely.

V. FIRST CLAIM - LIKELIHOOD OF CONFUSION

17. Flickr realleges and incorporates by reference the preceding allegations in this Notice of Opposition.

18. Applicant's mark is confusingly similar to the FLICKR mark.

19. Both parties' marks create the same commercial impression due to their similar features, sounds, and appearances.

20. Applicant's Services are identical to, closely related to, and/or directly overlap with, Flickr's Goods and Services.

21. Applicant's Services are likely to be advertised and/or retained via the same trade channels as Flickr's Goods and Services, and to be used by and marketed to overlapping consumers.

22. Applicant's FLICKSCAPE mark so resembles the FLICKR mark as to be likely, when applied to Applicant's Services, to cause confusion, to cause mistake, and to deceive the public with consequent injury to Flickr, the trade, and the public.

23. Flickr will be damaged if the Application is allowed to proceed to registration because consumers and prospective consumers are likely to be confused, misled, or deceived into believing that Applicant, or Applicant's Services offered under the FLICKSCAPE mark, are connected with, sponsored by, or approved by Flickr.

24. Any defect, objection, or fault found with Applicant's Services marketed or sold under the FLICKSCAPE mark will reflect upon and seriously injure the valuable reputation and goodwill that Flickr has established for the FLICKR mark.

25. Registration of the FLICKSCAPE mark would also damage Flickr because such registration would grant statutory exclusive rights to Applicant in violation of the prior and superior rights of Flickr, and would unduly narrow the scope of protection afforded to the FLICKR mark, in contravention of Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d).

VI. SECOND CLAIM - DILUTION

26. Flickr realleges and incorporates by reference the preceding allegations in this Notice of Opposition.

27. As a result of Flickr and/or its predecessors' exclusive and extensive advertising of the FLICKR mark, the long duration and extent of its use of the FLICKR mark, and the commercial success Flickr and/or its predecessors have experienced in connection with their use of the FLICKR mark, the

FLICKR mark has become widely recognized by the general consuming public of the United States as a designation of source of Flickr's Goods and Services. Accordingly, the FLICKR mark is "famous" as defined under 15 U.S.C. § 1125(c).

28. The FLICKR mark became famous well prior to the filing date of the Application, and upon information and belief, any other priority date upon which Applicant may rely in this matter.

29. Accordingly, registration of the FLICKSCAPE mark would harm Flickr because such registration is likely to cause dilution of the distinctive quality of the FLICKR mark by eroding consumers' exclusive identification of the FLICKR mark with Flickr, and otherwise lessening the capacity of the FLICKR mark to distinguish Flickr's Goods and Services, in violation of the Lanham Act, 15 U.S.C. § 1125(c)(1).


VII. REQUEST FOR RELIEF

WHEREFORE, Flickr believes that it will be damaged by registration of the FLICKSCAPE mark shown in Application Serial No. 88/739,483 and respectfully requests that this Opposition be sustained and that registration for the FLICKSCAPE mark be refused. This Notice of Opposition is filed according to the rules governing electronic submissions to the Trademark Trial and Appeal Board, including payment of the requisite filing fee.
