ANSWER TO NOTICE OF OPPOSITION

Applicant, Aristocrat Technologies Australia Pty Ltd. (hereinafter “Applicant”), respectfully submits its Answer to Notice of Opposition (hereinafter “Opposition”) filed by Valve Corporation (hereinafter “Opposer”) in the above referenced matter.

Applicant admits upon information supplied by Opposer and belief, that Opposer is a Washington corporation having its principle place of business at 10400 NE 4th Street, Suite 1400, Bellevue, WA 98004. Applicant and Opposer agree, subject to the terms of the co-existing agreement executed between the parties on October 12, 2020, that Applicant’s Mark, the subject of U.S. Trademark Application Serial No. 88/620,619, can co-exist without causing a likelihood of confusion with Opposer’s Mark.

Applicant states as follows:

1. Within seven business days of the Effective Date of the Agreement, Applicant has agreed to take all steps necessary to file with the United States Patent and Trademark Office an amendment to the application for registration of PORTAL FORTUNES (Serial No. 88620619), as follows:
