**OPPOSER’S & APPLICANT’S JOINT STATUS  
REPORT AND MOTION TO CONSOLIDATE**

Opposer Honda Motor Co., Ltd. (“Honda” or “Opposer”) and Applicant Microsoft Corporation (“Microsoft” or “Applicant”), by and through their undersigned counsel, hereby provide the below status report and move to consolidate five pending proceedings, namely (i) Opposition No. 91/264,500, (ii) Opposition No. 91/264,501, (iii) Opposition No. 91/264,502, (iv) Opposition No. 91/264,504, and (v) Opposition No. 91,264,765 (collectively, the “Opposition Proceedings”).


In accordance with the Board’s Order dated February 11, 2021 in Opposition No. 91/264,500 (14 TTABVUE), the parties herein state that on February 15, 2021, in Opposition No. 91/264,765, the Board dismissed Applicant’s Motion to Dismiss for Failure to State a Claim (9 TTABVUE) as moot due to Opposer’s filing of an Amended Notice of Opposition on January 12, 2021 (10 TTABVUE). Thus, this proceeding may be called up for appropriate action.

The parties also respectfully move for a consolidation of the Opposition Proceedings. The Opposition Proceedings involve common questions of law and fact and involve identical parties and virtually identical pleadings. *See* TBMP § 511; *M.C.I. Foods Inc. v. Bunte*, 86 USPQ2d 1044, 1046 (TTAB 2008) (proceeding involved identical parties, identical registrations and related issues); *S. Industries Inc. v. Lamb-Weston Inc.*, 45 USPQ2d 1293, 1297 (TTAB 1997) (both proceedings involved the same mark and virtually identical pleadings). Consolidation will save the parties and the Board time, effort, and expense, and neither party will be prejudiced by the consolidation of the Opposition Proceedings.
