**OPPOSER’S MOTION FOR DEFAULT JUDGMENT**

Opposer hereby moves the Trademark Trial and Appeals Board (“**TTAB**”) to enter a default judgment in favor of Opposer.

1. Opposer filed an Opposition on September 5, 2020.
2. The TTAB issued a binding scheduling order, dated September 5, 2020 (the “**Scheduling Order**”), which expressly warned of an entry of default for failure to respond.
3. The Scheduling Order established a deadline for Applicant to file an Answer to the Opposition on or before October 15, 2020.
4. Applicant's Answer was due on or before October 15, 2020.
5. Applicant failed to file an Answer in accordance with the Scheduling Order. On the date hereof, Opposer has not been served with an Answer and it believes that Applicant has not filed the same based upon TTABVUE.
6. CFR §2.106 provides “(a) If no answer is filed within the time set, the opposition may be decided as in case of default.” Id.; TBMP 312; 508.

7. Accordingly, Opposer hereby moves the TTAB to enter a default judgment against Applicant and to deny registration of the mark at issue.

WHEREFORE, Opposer requests that Applicant's application, Serial No. 88/869,107, be refused registration, and that this opposition be sustained in favor of Opposer.
