Grow Financial Federal Credit Union, a federally chartered credit union, having a principal place of business of 9927 Delaney Lake Drive, Tampa, Florida, 33619 (“Opposer”), believes it will be damaged by the registration of the trademark shown in Application Serial No. 88/714,830 by Fund&Grow, Inc. (“Applicant”) for the recited services and hereby opposed that application under the provisions of 15 U.S.C. §1063 as follows:

1. Opposer is a leading federally chartered credit union, offering its customers a host of financial services including credit card services, checking and savings account services, mortgage and automobile loan services, refinancing loan services, and numerous related financial services.

2. Since at least as early as September 4, 2007, Opposer has been known as “Grow Financial,” (or “Grow” for short) and has offered its financial services under the “Grow” service mark.

3. Opposer is the owner of the following registered service marks:

a. U.S. Trademark Reg. No. 3376331 for GROW FINANCIAL FEDERAL CREDIT UNION & Design for banking and credit union services; financial services, namely, mortgage lending and credit card services; insurance agency services, registered on January 29, 2008 with a date of first use of September 7, 2007;

b. U.S. Trademark Reg. No. 5098135 for GROW & Design for banking and credit union services; financial services, namely, mortgage lending and credit card services; insurance agency services, registered on December 13, 2016 with a date of first use of September 7, 2007;

c. U.S. Trademark Reg. No. 5098138 for GROW FINANCIAL FEDERAL CREDIT UNION for banking and credit union services; financial services, namely, mortgage lending and credit card services; insurance agency services, registered on December 13, 2016 with a date of first use of September 7, 2007;

d. U.S. Trademark Reg. No. 5102805 for GROW FINANCIAL for banking and credit union services; financial services, namely, mortgage lending and credit card services; insurance agency services, registered on December 20, 2016 with a date of first use of September 7, 2007;

(collectively, “Opposer’s Asserted Mark”)

4. Upon information and belief, on or about December 4, 2019, Applicant filed U.S. Trademark Application Serial No. 88/714,830 for FUNDANDGROW & Design for use in

connection with “credit and loan services; credit counseling services; financial services rendered in connection with the issuance, receipt and transfer of lines of credit, namely, credit processing services” (the “Opposed Mark”). The Opposed Mark claimed a date of first use of November 20, 2019 – over a decade later than Opposer’s date of first use of Opposer’s Asserted Marks.

5. The Opposed Mark incorporates the dominant “Grow” portion of Opposer’s Asserted Marks, and is similar to them in sound, appearance, meaning, connotation, and commercial impression.

6. The services recited in the Opposed Mark are similar related, and/or competing with Opposer’s services.

7. The date of first use of Opposer’s Asserted Marks predates the Opposed Mark by well over ten years, and therefore, Opposer has prior and superior rights as compared to Applicant.

8. The Opposed Mark is barred from registration because it consists of or comprises a trademark which so resembles Opposer’s Asserted Mark as to be likely, when used in connection with the alleged services of Applicant, to cause confusion, mistake, or deception as to an affiliation, connection, or association between Opposer and Applicant, or as to the sponsorship or approval of Applicant’s services and other commercial activities by Opposer within the meaning of 15 U.S.C. § 1052(d). Potential customers are likely to believe that Applicant’s services originate from, or are sponsored or approved by, Opposer, when such is not the case. All of the foregoing will cause Opposer damage.

9. Applicant is not affiliated with or connected in any way to Opposer, and Opposer has not consented to Applicant’s use of the Opposed Mark represented in U.S. Trademark Application Serial No. 88/714,830.

10. Accordingly, pursuant to 15 USC § 1063, the Opposed Mark is not entitled to registration.

WHEREFORE, Opposer believes that it will be damaged by registration of the Opposed Mark as shown in U.S. Trademark Application Serial No. 88/714,830, and respectfully requests that this Opposition be sustained and that registration be refused. Authorization is given to charge the filing fee for this Opposition to Deposit Account No. 50-0951.
