MOTION FOR EXTENSION OF TIME

Opposer, School Specialty, Inc., seeks a 90-day extension of all deadlines in this proceeding. Good cause for the requested extension exists as follows.

This extension is requested by the Opposer to realign the schedule to allow time for further fact discovery and in view of ongoing settlement discussions. The parties served their initial disclosures on March 22, 2021. After Opposer served interrogatories and requests for production, Applicant’s counsel requested a 30-day extension of time to respond to those discovery requests, which Opposer consented to. Applicant has now served written responses to the interrogatories and requests for production, but has not yet produced documents.

In parallel, the parties, through counsel, have also been discussing the potential resolution of this matter. Opposer seeks this extension to realign the schedule to allow time for the parties to complete fact discovery and continue their settlement discussions.

Counsel for Opposer discussed this requested extension with Counsel for the Applicant on October 28, 2021 and sought Applicant’s consent. Applicant has not responded to the request

for consent to the requested extension.
