ANSWER TO COUNTERCLAIMS FOR CANCELLATION

Opposer and Cancellation Respondent, Little Busy Bodies, LLC ("**Little Busy Bodies**") answers the Counterclaims for Cancellation by Applicant and Cancellation Petitioner, Oogie Solutions LLC ("**Oogie Solutions**") as follows. Unless specifically admitted, all allegations in the Counterclaims for Cancellation are denied.

1. Little Busy Bodies lacks sufficient knowledge or information to admit or deny the allegations in paragraph 1 and therefore denies them.

2. Little Busy Bodies lacks sufficient knowledge or information to admit or deny the allegations in paragraph 2 and therefore denies them.

3. Little Busy Bodies admits that it sells a range of products, including wipes and other products that are used on children's noses. Little Busy Bodies states that its products are not limited to nasal wipes and nasal solution products for children, and Little Busy Bodies denies the remaining allegations in paragraph 3.

4. Little Busy Bodies admits the allegations in paragraph 4.

5. Little Busy Bodies admits the allegations in paragraph 5.

6. Little Busy Bodies admits the allegations in paragraph 6.

7. Little Busy Bodies admits the allegations in paragraph 7.

8. Little Busy Bodies denies the allegations in paragraph 8.

9. Little Busy Bodies admits that the term "booger" may be used to mean "a piece of dried nasal mucus." Little Busy Bodies denies that said definition is the only meaning of the term "booger."

10. Little Busy Bodies admits that it is the owner of Reg. No. 5045572 for the BOOGIE mark and that it uses the BOOGIE mark in connection with, among other things, goods that can be described as "nasal products." Little Busy Bodies further states that the records of the United States Patent and Trademark Office are public records and can speak for themselves.

11. Little Busy Bodies admits that the term "mist" may be used to mean "small droplets of water." Little Busy Bodies denies that said definition is the only meaning of the term "mist."

12. Little Busy Bodies admits that the registered BOOGIE MIST mark comprises the words BOOGIE and MIST. Little Busy Bodies admits that the word MIST is disclaimed in Reg. No. 5848507. To the extent Oogie Solutions alleges a disclaimer outside of such registration, Little Busy Bodies denies such allegation. Little Busy Bodies further states that the records of the United States Patent and Trademark Office are public records and can speak for themselves.

13. Little Busy Bodies admits that it is the owner of Reg. No. 5848507 for the BOOGIE MIST mark and that it uses the BOOGIE MIST mark in connection with goods that

can be described as “nasal products.” Little Busy Bodies further states that the records of the United States Patent and Trademark Office are public records and can speak for themselves.

14. Little Busy Bodies admits that the term “drop” may be used to mean “quantity of fluid that falls in one spherical mass.” Little Busy Bodies denies that said definition is the only meaning of the term “drop.”

15. Little Busy Bodies admits that the registered BOOGIE DROPS mark comprises the words BOOGIE and DROPS. Little Busy Bodies admits that the word DROPS is disclaimed in Reg. No. 5848509. To the extent Oogie Solutions alleges a disclaimer outside of such registration, Little Busy Bodies denies such allegation. Little Busy Bodies further states that the records of the United States Patent and Trademark Office are public records and can speak for themselves.

16. Little Busy Bodies admits that it is the owner of Reg. No. 5848509 for the BOOGIE DROPS mark and that it uses the BOOGIE DROPS mark in connection with goods that can be described as “nasal products.” Little Busy Bodies further states that the records of the United States Patent and Trademark Office are public records and can speak for themselves.

17. Little Busy Bodies admits the allegations in paragraph 17.

18. Little Busy Bodies admits that the Website includes a tab titled “Booger Facts” and that information relating to mucus and boogers can be found under that tab. Little Busy Bodies denies that the tab is “featured” over other tabs. Little Busy Bodies further states that its website is publicly viewable and can speak for itself.

19. Little Busy Bodies admits that a page on its website, <https://www.boogiewipes.com/boogie-products/boogie-wipes/>, states, "Boogies (mucus) and germs are a big part of kid life. Make cleanup easier on everyone with soft and soothing **Boogie Wipes®** saline nose wipes. **Boogie Wipes®** natural saline formula breaks down dried, stuck-on boogers without irritation and wipes away dirt and germs," with "**Boogie Wipes®**" depicted in bold typeface. Little Busy Bodies denies that said web page depicts "Boogies (mucus)" in bold typeface. Little Busy Bodies denies that "**Boogie Wipes®**" is not depicted in bold typeface on said web page. Little Busy Bodies admits that the screenshot depicted in paragraph 19 of the Counterclaims appears to be a depiction of the above referenced web page. Little Busy Bodies further states that its website is publicly viewable and can speak for itself.

20. Little Busy Bodies admits that a page on its website, <https://www.boogiewipes.com/boogie-products/boogie-mist/>, states, "**Boogie Mist®** saline mist is a non-medicated sterile saline mist that works quickly inside the nasal cavity to ease congestion caused by boogers that won't budge," with "**Boogie Wipes®**" depicted in bold typeface. Little Busy Bodies denies that "**Boogie Wipes®**" is not depicted in bold typeface on said web page. Little Busy Bodies further states that its website is publicly viewable and can speak for itself.

21. Little Busy Bodies admits that a page on its website, <https://www.boogiewipes.com/boogie-products/boogie-drops/>, states, "**Boogie Drops®** saline nose drops are made with natural saline and are easy-to-use on small, stuffy noses," with "**Boogie Drops®**" depicted in bold typeface. Little Busy Bodies denies

that "**Boogie Drops®**" is not depicted in bold typeface on said web page. Little Busy Bodies further states that its website is publicly viewable and can speak for itself.

22. Little Busy Bodies admits that a page on its website, <https://www.boogiewipes.com/boogie-products/boogie-baby-bundle/>, states, "Babies come with boogies and messes." Little Busy Bodies admits that the screenshot depicted in paragraph 22 of the Counterclaims appears to be a depiction of the above referenced web page. Little Busy Bodies further states that its website is publicly viewable and can speak for itself.

23. Little Busy Bodies admits that a post on its Facebook page, <https://www.facebook.com/boogiefans/>, states, "Have you tried our new Lavender scent wipes? Made with 100% natural fragrance, they are free from all the ickies and your #1 partner in crime to wipe away dirt, germs and boogies." Little Busy Bodies admits that the screenshot depicted in paragraph 23 of the Counterclaims appears to be a depiction of the above referenced post. Little Busy Bodies further states that its Facebook page is publicly viewable and can speak for itself.

24. Little Busy Bodies admits that a post on its Facebook page, <https://www.facebook.com/boogiefans/>, states, "Made with natural saline, our line-up of boogie busting products help gently clean and dissolve boogers and snot." Little Busy Bodies admits that the screenshot depicted in paragraph 24 of the Counterclaims appears to be a depiction of the above referenced post. Little Busy Bodies further states that its Facebook page is publicly viewable and can speak for itself.

25. Little Busy Bodies states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 25 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 25 to the extent an answer is required.

26. Little Busy Bodies states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 26 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 26 to the extent an answer is required.

27. Little Busy Bodies states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 27 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 27 to the extent an answer is required.

Little Busy Bodies further states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 29 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 29 to the extent an answer is required.

30. Little Busy Bodies denies the allegations in paragraph 30.

31. Little Busy Bodies states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 31 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 31 to the extent an answer is required.

Little Busy Bodies further states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 33 call for a legal conclusion. Little Busy Bodies denies the remaining allegations in paragraph 33 to the extent an answer is required.

34. Little Busy Bodies states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 34 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 34 to the extent an answer is required.

Little Busy Bodies further states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 42 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 42 to the extent an answer is required.

43. Little Busy Bodies denies that it has not used and does not use the BOOGIE mark in commerce for any of its goods. The phrase "standalone BOOGIE mark" is

undefined and ambiguous. Little Busy Bodies lacks sufficient knowledge or information to admit or deny the allegations in paragraph 43 as to the "standalone BOOGIE mark" and therefore denies them.

44. Little Busy Bodies admits that it submitted specimens in support of U.S. Reg. No. 4162748 for the BOOGIE mark and that the images depicted in paragraph 44 of the Counterclaims appear to be portions of the specimens submitted in connection with Little Busy Bodies' U.S. App. Serial No. 77704750 and in connection with the renewal of U.S. Reg. No. 4162748. The records attached as Exhibit A appear to be records from the United States Patent and Trademark Office. Little Busy Bodies further states that the records of the United States Patent and Trademark Office are public records and can speak for themselves. The phrase "use of BOOGIE WIPES" is undefined and ambiguous. The phrase "standalone BOOGIE Mark" is undefined and ambiguous. Little Busy Bodies lacks sufficient knowledge or information to admit or deny the remaining allegations in paragraph 44 and therefore denies them.

45. Opposer denies that it does not use, and has not used, the BOOGIE mark in commerce. The phrases "standalone BOOGIE Mark" and "composite mark BOOGIE WIPES" are undefined and ambiguous. Little Busy Bodies further states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 45 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 45 to the extent an answer is required.

46. Little Busy Bodies admits that it submitted a specimen in support of U.S. Reg. No. 5045572 for the BOOGIE mark and that the image depicted in paragraph 46 of the Counterclaims appears to be a portion of the specimen submitted in connection with

Little Busy Bodies' U.S. App. Serial No. 86927515. The records attached as Exhibit B appear to be records from the United States Patent and Trademark Office. Little Busy Bodies further states that the records of the United States Patent and Trademark Office are public records and can speak for themselves. The phrase "use of BOOGIE MIST" is undefined and ambiguous. The phrase "standalone BOOGIE Mark" is undefined and ambiguous. Little Busy Bodies lacks sufficient knowledge or information to admit or deny the remaining allegations in paragraph 46 and therefore denies them.

47. Opposer denies that it does not use, and has not used, the BOOGIE mark in commerce. The phrases "standalone BOOGIE Mark" and "composite mark BOOGIE WIPES" are undefined and ambiguous. Little Busy Bodies further states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 47 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 47 to the extent an answer is required.

48. Little Busy Bodies denies that it does not, and has not, used the BOOGIE mark on its Website or in connection with any of its products for more than three years. The phrase "standalone BOOGIE Mark" is undefined and ambiguous. Little Busy Bodies lacks sufficient knowledge or information to admit or deny the allegations in paragraph 48 as to the "standalone BOOGIE mark" and therefore denies them.

49. Little Busy Bodies states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 49 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 49 to the extent an answer is required.

50. Little Busy Bodies states that Little Busy Bodies is not required to respond to the extent that the allegations in paragraph 50 call for a legal conclusion. Little Busy Bodies denies the allegations in paragraph 50 to the extent an answer is required.

AFFIRMATIVE DEFENSES

Little Busy Bodies asserts the following affirmative defenses that bar Oogie Solutions' requested relief in its Counterclaims for Cancellation.

FIRST AFFIRMATIVE DEFENSE

The Counterclaims for Cancellation fail to state any claim upon which relief can be granted.

SECOND AFFIRMATIVE DEFENSE

Oogie Solutions is estopped from bringing its Counterclaims for Cancellation through the equitable doctrine of unclean hands.

THIRD AFFIRMATIVE DEFENSE

Oogie Solutions' claims are barred, in whole or in part, by the equitable doctrine of laches, acquiescence, waiver and/or estoppel.

FOURTH AFFIRMATIVE DEFENSE

Little Busy Bodies' U.S. Reg. No. 4162748 for BOOGIE and U.S. Reg. No. 3541165 for BOOGIE WIPES are incontestable.

FIFTH AFFIRMATIVE DEFENSE

Little Busy Bodies has priority over Oogie Solutions.

SIXTH AFFIRMATIVE DEFENSE

Oogie Solutions cannot demonstrate that it will suffer any harm for which there is an available legal remedy because Oogie Solutions does not have priority over Little Busy Bodies.

SEVENTH AFFIRMATIVE DEFENSE

Little Busy Bodies reserves the right to amend this Answer and to assert and pursue additional defenses and claims based upon facts uncovered in discovery.

Respondent respectfully requests dismissal of Oogie Solutions' Counterclaims for Cancellation of U.S. Reg. No. 5045572 for BOOGIE, U.S. Reg. No. 4162748 for BOOGIE, U.S. Reg. No. 5848507 for BOOGIE MIST, and U.S. Reg. No. 5848509 for BOOGIE DROPS in their entirety with prejudice and that the prayer for relief contained therein be denied.
