NOTICE OF OPPOSITION

Jurlique International Pty Ltd., a company organized under the laws of Australia, having a principal place of business at 44-50 Oborn Road, Mount Barker, South Australia, Australia 5251 (hereinafter “*Opposer*”), believes that it will be damaged by the registration of the trademark “JUNIQUE & Design” shown in Application Serial No. 88/869,179. Opposer timely files this Notice of Opposition. As grounds for the opposition, Opposer alleges as follows:

1. On information and belief, J Paul Cook, an individual, has a principal address of 16423 Mason St., Omaha, Nebraska 68130 (hereinafter, “*Applicant*”).
2. Opposer is an Australian-based manufacturer of cosmetics whose products are sold and services offered around the world, including the United States.
3. Opposer is the owner and registrant of the mark “JURLIQUE” covered by several United States registrations, all of which are valid registrations in full force and effect (the “*Registrations*”). The details of the Registrations are shown in the chart below:

Attached hereto as Exhibit A are true and correct copies of the TSDR records for the Registrations as of today's date.

4. Opposer first used the JURLIQUE mark in any form in the United States at least as early as 1986.
5. Opposer has made, and continues to make, a substantial investment in advertising and promoting its goods and services under the JURLIQUE mark.
6. Applicant's Mark JUNIQUE and Opposer's Mark JURLIQUE are similar in sight, sound, meaning and overall commercial impression.

7. Applicant's goods in class 44, *Health spa services, namely, cosmetic body care services; Medical services; Primary care medical services*, are similar to the goods and services offered by Opposer under the JURLIQUE mark and are related.

8. The classes of purchasers are the same with respect to Opposer's goods/services and Applicant's services.

9. When used in connection with the services listed in the Application, Applicant's JUNIQUE mark is likely to cause confusion, or to cause mistake, or to deceive, within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

10. The relevant consuming public is likely to mistakenly believe that Applicant's services originate from, are sponsored or authorized by, or are otherwise connected to Opposer's goods/services.

11. Applicant filed the Application on November 17, 2016, on an intent-to-use basis.

12. Applicant's filing date is well after – 30 years after – Opposer's earliest first use date of the JURLIQUE mark.

13. Opposer's JURLIQUE mark is senior to Applicant's mark.

14. Based upon the foregoing, registration of Applicant's mark JUNIQUE is likely to cause injury and damage to the Opposer.

WHEREFORE, Opposer respectfully requests that registration of the mark JUNIQUE as shown by Application Serial No. 88/869,179 be denied under Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d), and that this Opposition be sustained.
