NOTICE OF OPPOSITION

IW Apparel, LLC, a Delaware limited liability company, with offices at 251 Little Falls Drive, Wilmington, Delaware 19808 (“Opposer”), believes it will be damaged by the issuance of a trademark registration to Ruben Ramos Flores, an individual, with a mailing address at 15700 Garfield Avenue, Paramount, California 90723 (“Applicant”), for the mark TERRAFLEX BY BONANZA BOOTS (Serial No. 88/695665) in International Class 25, and hereby opposes the application.

As grounds for the opposition, Opposer alleges that:

1. Applicant is seeking to obtain, under the provisions of the Trademark Act of 1946, as amended, registration on the Principal Register of the mark TERRAFLEX BY

BONANZA BOOTS (Serial No. 88/695665) for “footwear” in International Class 25 (“Applicant’s Mark”).

2. Applicant is not now, and never was, entitled to registration on the Principal Register of Applicant’s Mark either on November 18, 2019, the date of Applicant’s filing of the application, or on November 10, 2020, the date of publication in the *Official Gazette*.

3. Opposer is the owner of federal trademark registrations, including:

a. TERRA (Stylized)[®] (Registration No. 2115071) (1997) for “footwear” in International Class 25;

b. TERRA-LITES[®] (Registration No. 1533248) (1989) for “work boots and boots” in International Class 25;

c. TERRA[®] (Registration No. 2449316) (2001) for “footwear” in International Class 25;

d. TERRA & Design[®] (Registration No. 5533347) (2018) for “safety equipment, namely, safety helmets; hard hats, visors and shields; safety harnesses other than for vehicles or sports purposes; lanyards for safety purposes for fall protection; protective glasses; safety goggles; knee pads for workers; reflective safety vests; respiratory masks for non-medical purposes; sunglasses; men’s and women’s industrial work related garments for safety or reflective purposes, namely, industrial grade coveralls and overalls, industrial grade work smocks and aprons, industrial grade work pants and work jeans, industrial grade work outerwear jackets and parkas, industrial grade work vests, industrial grade work shirts, industrial grade quilted flannel shirts and industrial grade flannels shirts” in International Class 9; and “footwear, namely, boots and shoes; clothing, namely, gloves, socks, hosiery, caps, hats, rainwear; men’s

and women's industrial work related garments not for safety or reflective purposes, namely, industrial grade coveralls and overalls, industrial grade work smocks and aprons, industrial grade work pants and work jeans, industrial grade work outerwear jackets and parkas, industrial grade work vests, industrial grade work shirts, industrial grade quilted flannel shirts and industrial grade flannels shirts" in International Class 25; and

e. TERRA and Design[®] (Registration No. 5727981) (2019) for "providing consumer product information via the internet in the field of footwear and protective footwear and protective accessories" in International Class 35, (collectively, "Opposer's Marks"). True and correct copies of the TSDR reports are attached hereto as Exhibit "A."

4. Opposer has, since long prior to the filing date of Applicant's application, sold in commerce its goods under Opposer's Marks. Through usage by Opposer, the Opposer's Marks have become well-known to consumers and potential customers as trademarks of Opposer and as an origin and source indicator of the goods sold and provided by Opposer.

5. Opposer has also used Opposer's Marks at common law, before it obtained registrations, and long before the filing date of Applicant's application.

6. A primary feature, focus and emphasis of Applicant's Mark is the word "TERRA", which Applicant employs as a prominent feature of its mark, which is the exact mark of Opposer's Marks ("TERRA").

7. The Applicant's Mark is also for the same or related goods as Opposer's Marks. Therefore, Applicant's Mark is or may be viewed by the same consumers as those of the Opposer, which is likely to cause confusion, mistake, or deception amongst the general and

consuming public as to whether Applicant's goods are being offered by, or in affiliation with, Opposer, hence causing damage to Opposer.

Accordingly, Opposer requests that registration of the mark TERRAFLEX BY BONANZA BOOTS (Serial No. 88/695665) be denied to Applicant and this opposition be sustained.
