NOTICE OF OPPOSITION

Opposer 2323 N. Milwaukee LLC, an Illinois limited liability company with a principal place of business in Chicago, Illinois ("Opposer"), believes it will be damaged by registration of the mark shown in Application Serial No. 88811905 in the name of Applicant Destiladora Mexicana, S.A. de C.V. ("Applicant"), and hereby opposes the same. As grounds for opposition, Opposer alleges:

1. Opposer is engaged in the business of producing and selling craft beer through its related companies under the marks and trade names REVOLUTION and REVOLUTION BREWING, and the trade name REVOLUTION BEER, and is owner of the trademarks REVOLUTION and REVOLUTION BREWING for beer (all of the foregoing collectively, the "REVOLUTION Marks").

2. Opposer's and its related companies' beer under the REVOLUTION Marks has won awards and considerable public recognition at such prestigious national and international festivals and beer competitions as the World Beer Cup, the Great American Beer Festival, and the Festival of Wood and Barrel Aged Beer, and Opposer has acquired substantial goodwill and value in the REVOLUTION Marks.

3. In addition to its common law rights, Opposer is also the owner of U.S. Reg. No. 3,822,436 on the Principal Register of the U.S. Patent and Trademark Office for the REVOLUTION BREWING mark for beer with a constructive first use date of May 7, 2008. The registration is valid, subsisting and incontestable. A printout of the registration from the electronic database of the U.S. Patent and Trademark Office showing the current title and status of the registration is attached hereto as Exhibit A.

4. On February 26, 2020, Applicant filed Application Serial No. 88811905 seeking to register the mark BEER REVOLUTION ("Applicant's Mark") for beer.

5. By virtue of the registration of REVOLUTION BREWING mark and long prior use of the REVOLUTION Marks, Opposer has rights prior and superior to any alleged rights of Applicant in Applicant's Mark and has priority.

6. The goods identified in the Application opposed are identical to the goods to the sold under Opposer's REVOLUTION Marks: beer.

7. Applicant's Mark is confusingly similar to Opposer's REVOLUTION Marks in sight, sound, meaning and commercial impression.

8. Applicant is in no way authorized, sponsored, or licensed by, or in any other way legitimately connected with, Opposer.

9. Applicant's use and registration of Applicant's Mark is without Opposer's permission or authorization.

10. Applicant's Mark, when used for the goods in the Application opposed, so resembles the REVOLUTION Marks as to be likely to cause confusion, mistake, and/or deception under Section 2(d) of the Trademark Act, to the damage of Opposer.

11. Because Opposer possesses prior and superior rights in the REVOLUTION Marks, the registration sought by Applicant for Applicant's Mark and the presumptions that would flow to Applicant from any such registration are inconsistent with Opposer's rights.

12. By reason of the foregoing, Opposer would be damaged by Applicant's registration of Applicant's Mark.

WHEREFORE, Opposer 2323 N. Milwaukee LLC respectfully requests that this opposition be sustained and the registration sought by Applicant in Application Serial No. 88811905 be denied.


